INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Safe Harbor 401(K) Profit Sharing Plan For Employees of Arizona Autism United, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with the auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Employee Benefits Plan of Arizona Autism United, Inc. and to meet our other ethical responsibilities in accordance with the relevant

ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Employee Benefits Plan of Arizona Autism United, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE A – DESCRIPTION OF PLAN

The following description of Safe Harbor 401(k) Profit Sharing Plan For Employees of Arizona Autism United, Inc., the “Plan,” provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering all employees of Arizona Autism United, Inc. the “Organization”, who have at least two months of service and are 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On January 1, 2021, the Plan adopted a Safe-Harbor 401(k) profit sharing plan. The Plan changed 1) the employer match to 100% of the first 3% of compensation deferred by the participant and 50% of the next 2% of compensation deferred by the participant, and 2) the vesting of the employer match to 100% immediate vesting.

As of December 2023, the plan switched their service providers from Mutual of America to Norton James Retirement Services (“Norton James”) to serve as the Plan’s Third Party Administrator, and Nationwide Life Insurance Company (“Nationwide” or “Custodian”) to serve as the custodian and recordkeeper for the Plan. The Custodian holds all assets of the Plan in accordance with provisions of the service provider contract with the Plan Sponsor. All assets of the Plan are in investment accounts of the Custodian.

Contributions and Eligibility

Participants may contribute up to \$23,000 of pretax annual compensation, as defined in the Plan, for the year 2024. Participants who have attained age 50 before the end of the Plan year have the option to make additional “catch-up” contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan offers various mutual funds investment options for participants. Eligible employees may opt to join the first day of the month after meeting the eligibility requirements.

After meeting the eligibility requirements for the Organization of turning age 21 and completing one year of service, the Organization matches 100% of the first 3% of compensation deferred by the participant and 50% of the next 2% of compensation deferred by the participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's Safe Harbor matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their accounts attributable to elective deferrals. Effective January 1, 2021, the Organization's Safe Harbor contributions became 100% vested upon receipt of contributions.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum distribution, an ad-hoc distribution or installments for a specific period equal to the value of the participant's vested interest in his or her account.

The Plan allows active employees to receive lump-sum distributions under one of three criteria, obtaining the age 59 ½, hardship or disability.

Death Benefits and Disability

Upon the death or disability of the participant before retirement or termination of employment, the current balance of such participant's individual account becomes fully vested and will be paid to his designated beneficiary either in a lump sum or in installment payments, as chosen by the beneficiary.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited non-vested account balance was \$0.

Participant Loans

The Plan does not allow for participant loans.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through June 25, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value, except as noted. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions Receivable

The Plan records receivables for any contributions remitted to the Plan after year end. As of December 31, 2024, and 2023, contributions receivable totaled \$627 and \$0, respectively.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

NOTE C – CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and the supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In December 2023, the investments were transferred to money market account and collective investment trusts. Starting in January 2024, the money market account and 2024 contributions were distributed into collective investment trusts and mutual funds. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Fixed income mutual funds that invest in debt securities characterized by short maturities and minimal credit risk. These securities are issued by government entities or companies who borrow money and repay principal and interest to investors within a short period of time. The funds are invested in cash, US government securities and repurchase agreements that are fully collateralized by cash or government securities. A money market fund aims to maintain a net asset value (NAV) of \$1 per share. Any excess earnings that get generated through interest on the portfolio holdings are distributed to the Plan in the form of dividend payments.

Collective investment trusts: The Great Gray Collective Investment Trust and the Great Gray Collective Investment Trust II (collectively, the "Great Gray Trusts") are common collective trusts maintained by Great Gray Trust Company LLC ("Great Gray"). Great Gray generally determines the fair value of the Great Gray Trusts' units each day the New York Stock Exchange is open for trading. The NAV per unit is computed based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding at the time of such computation. The Trusts have (1) no unfunded commitments, (2) a daily redemption frequency, and (3) no redemption notice period as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported on the active market by the Custodian. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

During 2024, the Plan's investments (including dividends, interest, gains and losses on investments bought and sold, as well as held during the year) appreciated by \$400,213.

NOTE E – PLAN TERMINATION

Although management has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions (i.e., any non-Safe Harbor contributions).

The Plan has not obtained a determination letter, but the volume-submitter plan documents have received a letter dated June 30, 2020, for the Safe Harbor Plan, from the IRS that its form is acceptable under section 401 of the Internal Revenue Code. The Plan has since been amended, but the Plan Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE F – TAX STATUS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because plan management believes that the Plan had no taxable income, no income tax returns have been filed for December 31, 2024 or prior years.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan may invest in funds which invest in securities of foreign countries, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

NOTE H – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Nationwide performed the recordkeeping for the Plan for a fee. Fees paid by the Plan for recordkeeping amounted to \$4,751 for the year ended December 31, 2024.

Fees paid by the Organization to Nationwide for plan administration were minimal for the year ended December 31, 2024.

The Plan held \$1,033 in Nationwide funds managed by the custodian as of December 31, 2024. Certain fees charged by the custodian to manage the investments were netted against net appreciation (depreciation) in fair value of investments.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE I – PROHIBITED TRANSACTIONS

During 2024, the plan sponsor failed to remit to the plan's trustee certain contributions totaling \$22,424 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the trustee were due to ACH being rejected because there was a change in bank accounts used.
