Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hilltop National Bank 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of Hilltop National Bank 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering substantially all employees of Hilltop National Bank, N.A. (HNB) who have completed 1,000 hours of service and are 21 years of age or older. Participants may enter the Plan at the beginning of the month following their compliance with eligibility requirements. The Board of Trustees is responsible for oversight of the Plan. The Administrative Committee of Hilltop National Bank 401(k) Savings Plan determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code provisions.

Contributions and investment options: Each year, participants may contribute up to 100% of pretax annual compensation, not to exceed the maximum allowed under the Internal Revenue Code. HNB may make discretionary matching and nonelective contributions to the Plan each year at the discretion of the Board of Directors. During the year ended December 31, 2024, HNB made discretionary matching contributions to the Plan totaling approximately \$405,000. No employer discretionary nonelective contributions were made during the year ended December 31, 2024. Contributions are subject to certain limitations. Participants direct the investment of all contributions into various mutual funds and certificates of deposit. Participants may change their investment options daily and their deferral amount quarterly or at the time of a salary adjustment.

Participant accounts: Each participant's account is credited with the participant's contribution, HNB's discretionary matching contribution and an allocation of (a) Plan earnings and (b) employer discretionary nonelective contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: Upon enrollment in the Plan, a participant may direct contributions to their account in any of the funds offered by the Plan. Participants may change their investment options at any time.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to HNB discretionary contributions plus earnings thereon becomes 20% vested after one year of service, as defined, and continues to vest at the rate of 20% for each successive year of service until 100% vested after five years of service.

Payment of benefits: Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or disability. Participants who have reached the age of 59½ may elect to receive in-service distributions. Terminated participants who elect to leave their funds in the Plan are permitted a single withdrawal per plan year. Benefits shall be distributed through a lump-sum amount.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to an amount equal to one half of the participant's vested account balance, not to exceed \$50,000 reduced by the participant's highest outstanding note receivable balance in the previous year. The notes receivable from participants are secured by the value of the vested balance in the participant's vested account. The notes receivable have terms of up to five years, or longer if the note qualifies as a home loan. For a note to be considered a home loan, the funds must be used to acquire a dwelling unit, which, within a reasonable time, the participant will use as a principal residence. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants outstanding at December 31, 2024, mature through March 2040, and bear interest at rates ranging from 5.25% to 10.50%. Notes receivable from participants outstanding at December 31, 2023 and bore interest at rates ranging from 5.25% to 10.50%.

Forfeited accounts: At December 31, 2024 and 2023, there were no forfeited nonvested accounts in the Plan. Forfeitures from nonvested accounts are used to reduce future employer contributions. During the year ended December 31, 2024, forfeitures from nonvested account balances reduced employer contributions by approximately \$14,000.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and disclosure through August 12, 2025, the date the financial statements were available to be issued.

Note 3. Administrative Expenses and Party-in-Interest Transactions

Effective March 16, 2023, Matrix Trust Company is the custodian of the mutual funds and, therefore, a party-in-interest of the Plan. Certain other administrative expenses are paid directly by the Plan. HNB is trustee of the Plan assets, custodian of the time deposit and notes receivable and the plan sponsor and, therefore, a related party of the respective Plan. Certain administrative functions were performed by officers or employees of HNB. No such officer or employee received compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. Investment related expenses are included in net appreciation of the fair value of investments.

The Plan had purchases of \$460,575, sales of \$100,744 and interest income of \$175,110 from the HNB time deposit account during the year ended December 31, 2024.

Note 4. Information Certified and Provided by Matrix Trust Company, a Custodian and Hilltop National Bank, N.A., the Trustee

Management has obtained certifications from Hilltop National Bank, N.A., a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information for the bank certificates of deposit and notes receivable from participants is complete and accurate to the best of their knowledge. Effective March 16, 2023, Matrix Trust Company is the custodian of the mutual funds. Management obtained certifications from Matrix Trust Company, a qualified institution, as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information for mutual funds is complete and accurate.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Hilltop National Bank, N.A. and Matrix Trust Company, qualified institutions:

Note 5. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Descriptions of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, are set forth below. The level to which an asset is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at December 31, 2024 compared to December 31, 2023.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

Bank certificates of deposit: Certificates of deposits are valued at amortized cost, which approximates fair value due to the short-term nature of the agreements and are classified within Level 2 of the valuation hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, HNB has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
