## **INDEPENDENT AUDITOR'S REPORT**

To the Investment Committee of  
**Citation Oil & Gas Corp. Retirement Savings Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Citation Oil & Gas Corp. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Citation Oil & Gas Corp. Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions. The Plan was amended and restated effective January 1, 2024. Any changes to Plan provisions are detailed below.

**General**

The Plan is a defined contribution plan originally established April 1, 1989, for all eligible employees of Citation Oil & Gas Corp. and its subsidiaries (the “Company”) excluding employees who are union, leased, non-resident aliens, residents of Puerto Rico, hourly paid, or under Section 414(o) of the Internal Revenue Code (IRC). Employees may enter the Plan immediately upon reaching age 21. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The trustee and custodian for the Plan is Lincoln Financial Group Trust Company (Lincoln Financial) and the recordkeeper is Lincoln Retirement Services Company, LLC.

**Contributions**

Participants may contribute up to 80% of their annual eligible compensation on a pre-tax, Roth or after-tax basis, as defined in the Plan, subject to certain limitations prescribed by law. Each eligible employee who has not affirmatively elected not to participate or designated a deferral percentage shall be deemed to have made an election to defer 6% of the employee’s pre-tax eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may transfer amounts from their vested pre-tax accounts to an in-plan Roth transfer account. The Plan allows rollover contributions from other qualified plans.

The Company may make discretionary matching contributions calculated each pay period. During 2024, the Company contributed 100% of each participant’s contributions that were up to a maximum of 6% of each participant’s eligible compensation. Effective January 1, 2024, the Company may make an employer discretionary contribution on a plan year basis equal to a uniform percentage of participants’ eligible compensation. Eligible participants must have at least 182 consecutive days of employment with the Company during the plan year and be employed by the Company as of the last day of the plan year. The Company did not make a discretionary contribution for 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan and may change their contribution rates each payroll period and investment options at any time.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's contribution, as well as allocations of Plan earnings and any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Effective January 1, 2024, participants hired on or after January 1, 2024 vest 100% in all Company contributions after two years of service. Employees hired prior to January 1, 2024, vest 20% after one year of service and are 100% vested after two years of service.

**Benefit Payments**

A participant is immediately vested upon death, retirement, or termination of employment due to total and permanent disability. Normal retirement age under the Plan is 65. Upon termination or retirement, a participant may receive the value of the vested funds in the participant's account in a lump sum or other type of payment as defined in the Plan. The Plan also allows in-service withdrawals at age 59 ½ and hardship withdrawals from a participant's deferral account, including earnings.

Effective October 1, 2024, the Plan was amended to allow the plan administrator to rollover involuntary cash-out distributions, subject to certain limitations as defined in the Plan, to an individual retirement plan designated by the plan administrator.

**Forfeited Accounts**

Forfeitures of nonvested employer contributions are used to pay administrative expenses or reduce employer contributions. The forfeitures balance at December 31, 2024 and 2023 was \$3,579 and \$8, respectively. Forfeitures of \$79,051 were used to reduce employer contributions during 2024. There were no forfeitures used during 2024 to pay administrative expenses.

**Notes Receivable from Participants**

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Loans are repaid in level installments through payroll deductions for periods ranging up to five years. The loans bear interest at the quarterly prime rate plus 1% established at the inception of the loan and are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Participants are allowed to have one loan outstanding at a time.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and third party administrator. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants and certain other transaction fees are charged directly to the participant's accounts and are included in administrative expenses. Investment advisory and recordkeeping fees are also included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The collective trust fund is valued at NAV of units of a collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to determine fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fund invests in high-quality guaranteed investment contracts or similar contracts issued by insurance companies, banks, and similar financial institutions. The fund also invests in security-backed investment contracts including insurance separate accounts. Redemptions are allowed daily for participants. There are no unfunded commitments and no obligation to further invest in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from participants qualify as party-in-interest transactions and are covered by an exemption from the prohibited transaction provisions.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - TAX STATUS**

The Plan has adopted a non-standardized pre-approved plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document was in compliance with applicable requirements of the IRC. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued.
