- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following brief description of the Modern Woodmen of America Employees' Savings Plan (the Plan) provides only general information about the Plan's provisions. Modern Woodmen of America (the Society) is the plan sponsor. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all employees of the Society. Effective January 1, 2022, the Plan was amended and restated for the execution of Vanguard's Non-standardized Profit Sharing/401(k) Adoption Agreement complying with the IRS Cycle 3 requirements. Also, the list of excluded earnings was updated and other miscellaneous changes were made. Effective January 1, 2021, the Plan was amended to remove the one-year service and minimum age requirements for participation. Employees hired after the amendment's effective date are automatically enrolled at 2% with automatic escalation of 1% per year up to 6%. Before January 1, 2021, employees were required to have both completed one year of service and attained age 21 or older. The plan administrator is the Society and is responsible for the general administration of the Plan. Vanguard Fiduciary Trust Company (Vanguard) is the trustee and the record keeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may defer up to 50% of their annual compensation to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). All contributions are subject to certain limitations of the Internal Revenue Code (the Code). The Society will also contribute to the Plan an amount equal to the lesser of 3% of the participant's compensation or 50% of the participant's salary deferral.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Society's applicable contribution for the participant, and an allocation of the Plan's earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Society matching contributions is based on years of active service. The plan currently has three different vesting schedules, they are: 1) for participants hired on and after January 1, 2021, they are fully vested after three years of service; 2) for participants hired prior to January 1, 2021 and are still employed on January 1, 2021, they are fully vested based on a tiered three-year vesting schedule and are fully vested after completing three years of service; 3) for participants terminated prior to January 1, 2021, participants continued with a tiered six-year vesting schedule, they are fully vested after six years of service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period and repays any distributed amounts, the participant's forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Society contributions. Unallocated forfeited balances as of December 31, 2024 and 2023 were approximately \$13 and \$12, respectively.

Payment of Benefits

Active participants may elect a hardship withdrawal provided they submit proper documentation of the heavy financial burden.

Active participants may withdraw all or a portion of their after-tax account at any time. Upon attaining age 59½, participants may elect an in-service withdrawal up to 100% of their full account balance. Age 59½ in-service withdrawals are limited to one per calendar year.

On termination of service, a participant may elect an immediate distribution or postpone distribution as late as his or her required minimum distribution date. The participant may elect to receive a lump-sum amount equal to the vested value of his or her account or periodic installments. A participant may also choose an annuity contract or elect a direct rollover to an eligible retirement plan.

If the value of a participant's account is more than \$1 but less than or equal to \$5 and, after receiving all required notices, a participant does not affirmatively elect a distribution, the balance of the participant's account will be automatically rolled over by the Plan to an individual retirement account (IRA) with Vanguard as soon as practicable after the participant terminates employment.

If the value of a participant's account is \$1 or less and, after receiving all required notices, the participant does not affirmatively elect a distribution, the participant will receive a lump-sum distribution as soon as practicable after the participant terminates employment.

Participant Loans

Plan participants are eligible to receive a loan from the Plan after they have completed two years of active service while a plan participant. The initial loan amount may not be less than \$1 or exceed the lesser of 50% of the participant's vested account balance, the balance of the participant's pretax account, or \$50. Loan terms cannot exceed five years unless the purpose of the loan is to acquire a principal residence for which the term can be up to ten years. Loans are secured by the participant's vested account balance and bear interest at the prevailing prime lending rate plus one at the time the loan is issued. Principal and interest are repaid through payroll deductions. A participant may not have more than one outstanding loan at any given time.

Administrative and Operating Expenses

The administrative and operating expenses of the Plan are shared between the Society and participants. The Society pays the quarterly recordkeeping fee and participants pay expenses incurred from investing in certain plan funds. Expenses paid by the Society are excluded from these financial statements.

Investment Options

Participants can allocate contributions to their account among the investment options offered. Participants can make changes in the allocation of their account at any time by contacting Vanguard. Participants must designate their investment options amongst the funds offered.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 6 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

Payments of Benefits

Benefits are recorded when paid. There are no participant withdrawals from the Plan that have been approved but not paid as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Income Tax Status

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

3. Income Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

4. Plan Termination

Although it has not expressed any interest to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

5. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard (the trustee of the Plan).

6. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Mutual Funds

Mutual funds are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan. These investments are reflected in Level 1.

Collective Trust Fund

Collective trust funds are valued at the NAV of units of a bank collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For the year ended December 31, 2024 and 2023, there were no adjustments made to the reported NAV. Participant transactions (purchases and sales) may occur daily.

7. Related Party and Party in Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Society. No such officer or employee receives compensation from the Plan. The Plan invests in shares of mutual funds and a collective trust managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. In addition to the transactions with parties-in-interest discussed herein, Vanguard provides recordkeeping services to the Plan and receives fees, which are paid by Plan investments. These transactions are exempt from the prohibited transactions rules of ERISA. The Society may pay other Plan expenses from time to time. Notes receivable from participants also reflect party-in-interest transactions.

8. Subsequent Events

Management evaluated subsequent events for the Plan through July 31, 2025, the date the financial statements were available to be issued.
