**INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Southeastern Community Action Partnership, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## **NOTE 1 – PLAN DESCRIPTION**

The following brief description of the 403(b) Thrift Plan of Southeastern Community Action Partnership, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

Southeastern Community Action Partnership, Inc. (the "Organization") established the Plan to provide employees with a systematic means of saving and investing for the future. All employees of the Organization (except for employees who normally work less than twenty hours per week) are eligible for the Plan. Participants are automatically enrolled in the Plan with a 1% contribution rate unless the participant informs the Plan otherwise.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Organization matches 100% of employee deferrals up to 4% of compensation. Matching contributions for 2024 and 2023 were \$211,321 and \$195,938, respectively. In addition, the Organization made a discretionary contribution of 4% of annual compensation during 2024 and 2023. Discretionary contributions for 2024 and 2023 were \$318,407 and \$288,850, respectively.

### Participant Accounts

Each participant's account is credited with the participant's contribution and Organization contributions, if any, as well as allocated Plan earnings (and losses) and administrative expenses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their voluntary contributions and the Organization's matching and discretionary contributions plus actual earnings thereon.

### Benefit Payments

Upon retirement, disability, or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum, or at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participant's vested account in lump sum. Hardship distributions are allowed in accordance with the Plan document.

### Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan transactions are treated as a transfer between the investment fund and the loan fund. Terms range from one year to five years or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% - 7.0%. The interest rate is felt to be commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably on a monthly or quarterly basis.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Administrative Expenses

Administrative expenses are paid by either the Plan or the Organization, as provided in the Plan agreement. Investment related expenses are included in net appreciation in fair value of investments.

### Investment Valuation and Income Recognition

The Plan's investments in variable annuities are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts. The contract value is the relevant measurement since it represents the amount that the participant would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the investment contract with an insurance company is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as of the ex-dividend date.

Contributions

Contributions from employees and the Organization are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

Benefit Payments

Benefit payments are recorded when paid.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events

The plan has evaluated subsequent events through July 24, 2025 (the issuance date of the financial statements) and has determined that there were no subsequent events to recognize or disclose in these financial statements.

**NOTE 3 – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company ("LNLIC"). LNLIC maintains the contributions in a general account. The Plan has also entered into a traditional fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company (MALIC). MALIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts meet the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by LNLIC and MALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The complete or partial termination of the Plan may limit the ability of the Plan to transact at contract value. The plan administrator does not believe that this event is probable of occurring. The investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, was \$3,930,969 and \$3,798,074, respectively.

#### **NOTE 4 – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. All of the Plan's investments are in variable annuities and investment contracts with insurance companies. In accordance with *Financial Accounting Standards Board Accounting Standards Codification 820-10*, Variable annuities are measured at fair value using the net asset value per share practical expedient. As such, they are not required to be classified in the fair value hierarchy. In addition, because the investment contracts are fully benefit-responsive, contract value is the relevant measurement for the investment contracts. Accordingly, the investment contracts have not been classified in the fair value hierarchy.

The Plan had \$2,325,763 and \$1,819,955 of investments in participation units held in variable annuities through subaccounts of insurance companies at December 31, 2024 and 2023, respectively. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The underlying securities in the variable annuities are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted net asset value under agreements with the insurance company. Participant transactions (purchases and sales) may occur daily. Redemption is permitted daily with no other restrictions or notice periods and there are no unfunded commitments.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are valued at the amortized cost which is felt to approximate fair value. Interest income is recorded when received. The Plan currently does not have an allowance for doubtful accounts as all amounts are considered collectible.

**NOTE 7 - PLAN TERMINATION**

While it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue its participation at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested in their accounts, and the assets of the Plan shall be administered and distributed to the participants and beneficiaries at such time and in such nondiscriminatory manner as prescribed by ERISA and its related regulations.

**NOTE 8 - TAX STATUS**

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain its tax exemption. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December 31, 2024. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022 and 2023. There are currently no audits for any periods in progress.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments held by the Plan are managed by The Lincoln National Life Insurance Company and Mutual of America Life Insurance Company, the trustees. Accordingly, the transactions in such investments qualify as party-in-interest transactions as defined by ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
