Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sambrailo Packaging Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended October 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Sambrailo Packaging Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan covering all eligible employees of Sambrailo Packaging, Inc. (the "Company"). Employees who are age 21 or older, not covered under a union collective bargaining agreement, and not a leased employee, are eligible to participate in the Plan following the completion of one year of service and 1,000 hours. Participants may participate in the Plan on the first day of the Plan year or first day of the seventh month of the Plan year after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants in the Plan may elect to reduce their compensation by a specific percentage or dollar amount, up to 100% of their pre-tax annual compensation, and have that amount contributed to the Plan on a pre-tax basis as a salary deferral, subject to Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to contribute up to the maximum amount allowable, not to exceed \$23,000 (\$30,500 if over 50 years of age) and \$22,500 (\$30,000 if over 50 years of age) for 2024 and 2023, respectively. In addition, participants may make rollover contributions from individual retirement accounts (IRAs) and other qualified plans.

The Company is required to make a non-elective safe harbor matching contribution equal to 100% of salary deferrals up to the first 3% of compensation deferred by each participant, plus 50% of salary deferrals up to the next 2% of compensation deferred by each participant.

The Company can make annual discretionary contributions to the Plan in an amount determined by the Board of Directors. For the years ended October 31, 2024 and 2023, the Company made discretionary contributions of 4.5% and 1.5% of total compensation of all participants in the Plan to the Board of Directors and all other participants, respectively.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contributions, (b) Plan earnings, and (c) fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants: Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance, whichever is less. All loans are secured by the balance in the participant's account and bear an interest rate at the prime rate plus 2%. The loan terms are limited to a maximum of five years. However, the maximum loan term may be longer than five years where the purpose of the loan is to finance the purchase of a principal residence. Periodic principal and interest payments are paid through payroll deductions.

Vesting: Participants are immediately vested in their voluntary contributions and actual earnings (losses) thereon. Vesting in the Company's discretionary and matching contributions is based on years of continuous service in the Plan. A participant is vested after years of credited service per the following schedule:

Forfeited Accounts: At October 31, 2024 and 2023, unallocated non-vested accounts totaled \$10,104 and \$4,336, respectively. Amounts forfeited by terminated participants will be used to reduce future employer contributions. During the years ended October 31, 2024 and 2023, forfeitures of \$5,417 and \$2,621 were used to reduce employer contributions, respectively.

Payment of Benefits: Upon retirement, death, or other termination of service, a participant's vested account shall be made in a lump sum as soon as administratively feasible following severance of employment. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions. Participant consent is required for distributions over \$5,000.

Hardship Withdrawals: Participants may withdraw a percentage of their pre-tax account balance attributable to their own employee contributions or rollovers upon approval of the Plan Administrator and subject to IRS hardship withdrawal rules. After making a withdrawal, a participant is suspended from making additional contributions for a period of six months from the effective date of the withdrawal.

In-Service Withdrawals: Participants who have reached age 59 1/2 may make a cash withdrawal at any time from any of their vested contributions.

Administrative Expenses: Investment management fees and other fees related to investments of the Plan are paid either from the earnings of the Plan's investments or from forfeitures. All other expenses relating to the operation of the Plan are paid by the Company.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants: Participant loans are valued at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchase and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefit payments are recorded when paid.

Risks and Uncertainties: The Plan provides for various investment options in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value:

- Money market: Valued at the closing price reported by the fund sponsor from an actively traded exchange.
- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. CERTIFIED INFORMATION

Voya Retirement Insurance and Annuity Company, the custodian of the Plan, is a qualified institution as defined by Department of Labor regulations, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected in the accompanying statements of net assets available for benefits as of October 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of October 31, 2024. All investments and notes receivable from participants are covered by these certifications.

NOTE 5. PARTY-IN-INTEREST

Voya Retirement Insurance and Annuity Company, as custodian of the Plan assets, is also a party in interest. The purchase by the Plan of certain proprietary funds sponsored by the units and subsidiaries of Voya Retirement Insurance and Annuity Company constitutes party-in-interest transactions which are allowable under the ERISA regulations.

NOTE 5. PARTY-IN-INTEREST (Continued)

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation and financial reporting of the Plan. The Company pays these individuals' salaries and also pays other administrative expense on behalf of the Plan. Certain fees, to the extent not paid by the Company, are paid by the Plan.

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory and administrative exemptions from the Internal Revenue Code (IRC) and ERISA's rules on prohibited transactions.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7. TAX STATUS

The Plan adopted a Prototype Standardized Profit Sharing Plan with a cash or deferral arrangement that received a favorable opinion letter from the IRS on November 30, 2020. This letter stated the form of the Plan was acceptable under the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standards Board issued guidance that clarifies the accounting for uncertainty in income taxes recognized in the Plan's financial statements. In addition, the guidance prescribes a comprehensive model for recognizing, measuring, presenting, and disclosing in the financial statements tax positions taken or expected to be taken on a tax return, including positions that the Plan is not subject to income taxes. In addition, it provides guidance on de-recognition, classification, interest and penalties, accounting for interim periods, disclosure, and transition. Only tax positions that meet the more likely than not recognition threshold at the effective date may be recognized upon adoption of guidance.

As of October 31, 2024, the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements.

NOTE 8. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Voya is contractually obligated to repay the principal and interest credited to participants holding the investment. There is no minimum interest crediting rate; however, in no event is the credited rate less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The investment contract does not permit the insurance company to terminate the agreement prior to all assets being distributed.

NOTE 9. SUBSEQUENT EVENTS

The Plan's management has evaluated its October 31, 2024 and 2023 financial statements for subsequent events through August 12, 2025, the date of issuance of the financial statements. The Plan's management is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
