NOTE 1 - DESCRIPTION OF PLAN

The following is a brief description of Meier Supply Co., Inc. 401(k) Profit Sharing Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. A complete description of the Plan may be obtained from the Plan Administrator.

General

The Plan is a defined contribution profit sharing plan under Section 401(k) of the Internal Revenue Code that was established on January 1, 2002 for the purpose of providing retirement benefits for eligible employees of Meier Supply Co., Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan's salary deferral option when they reach the age of 21. Eligibility for employer matching and profit sharing contributions requires that an employee complete twelve months of service and be employed on the last day of the Plan Year. These requirements are waived for employees who die, become disabled, or retire during the Plan Year.

Contributions

The plan allows participants to defer up to 100% of their eligible compensation, but participants are limited to the annual threshold set by the Internal Revenue Service. Participants over the age of 50 are eligible to make catch-up contributions up to certain dollar thresholds, as defined in the Plan. Participants have the option of making Roth elective deferrals.

All employees meeting the eligibility requirements to make salary deferrals to the Plan are automatically enrolled in the Plan and 3% of the employee's eligible compensation will be automatically withheld and deposited into the Plan as a salary deferral. Participants will then have the ability to terminate or modify the automatic deferral election within 90 days of the date the automatic deferral election is first effective.

Participants may also contribute funds representing distributions from other qualified plans or individual retirement accounts in the form of direct rollover contributions.

The Company may make matching contributions on behalf of eligible participants in an amount equal to either a percentage of compensation or a dollar amount as it directly relates to elective deferrals made during the Plan Year by eligible participants. The Company may also make discretionary profit sharing contributions, which will be allocated to participant accounts based on the amount of eligible compensation. For the years ended October 31, 2024 and 2023, the company made matching and discretionary contributions of \$282,330 and \$275,034, respectively.

The Plan provides that all employee contributions to the Plan will be invested in certain individual funds as directed by each participant.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan is participant-directed Plan.

Vesting

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. There is a six year graded vesting schedule with regard to the Company's non-elective contributions of 20% vesting after two years of services, and an additional 20% vesting for each additional year of service. In addition, a participant's account balance will become fully vested upon reaching retirement age, becoming disabled or dying while employed by the Company. Normal retirement age is 65.

Payment of Benefits

Upon termination of employment, participants may receive all or part of their vested account balance paid at any time. If the value of the participant's vested interest is greater than \$1,000 but less than or equal to \$5,000, a direct rollover will be made of the participant's vested account balance into an IRA as selected by the plan administrator. Active participants may receive a portion of their vested accounts once they reach age 59½. Required minimum distributions are made once a participant reaches age 70½. Additionally, active participants may make hardship withdrawals to satisfy financial hardships as specified in the Plan document.

Forfeited Accounts

Forfeited, non-vested accounts are retained in the Plan and used to reduce the contribution of the employer. During the years ended October 31, 2024 and 2023, employer contributions were reduced by \$2,530 and \$1,972, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on an accrual basis in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The Plan uses estimates and assumptions in preparing financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. Quoted market prices are used to value mutual funds. Shares of common/collective trusts are reported at contract value. Within the self-directed brokerage accounts, mutual funds, common stocks, and unit investment trusts are valued at quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when earned. The net realized and unrealized appreciation (depreciation) in fair value of investments reflects the change in market value from beginning of year to end of year, realized gains and losses on sale of underlying investments, and investment earnings.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest at year end. The Plan administrator annually evaluates notes receivable for collectability based on their current financial condition. Provisions for losses on notes receivable are determined on the losses of known risks in the loan portfolio, the estimated value of underlying collateral and current economic conditions. Losses on notes receivable are treated as distributions to plan participants upon default. At October 31, 2024 and 2023, there was no allowance for losses on notes receivable, as all are considered collectable because they are secured by participant accounts.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan sponsor in addition to those paid by the Plan.

Subsequent Events

The Company has evaluated events and transactions that have occurred between October 31, 2024 and August 11, 2025 which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. No significant subsequent events have been noted to have occurred within this time period.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

NOTE 5 - INVESTMENT IN COLLECTIVE TRUST

One of the current investment options in the Plan is the Federated Capital Preservation Fund (the Fund), which invests in traditional guaranteed investment contracts (GICs), separate account guaranteed investment contracts (SGICs), synthetic guaranteed investment contracts (SICs), money market mutual funds and other stable value products.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Contract value, as reported to the Plan by the trustee and custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value of the guaranteed investment contract was \$904,139 and \$939,001 as of October 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with the fund. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 6 - RELATED PARTY TRANSACTIONS

NBT Bank, the trustee, and Charles Schwab Bank, a custodian, as defined by the Plan, have physical and administrative control of certain assets of the Plan and execute transactions therein. For such responsibilities, NBT Bank and Charles Schwab Bank receive fees at customary and reasonable rates as provided for in the Plan. Administrative fees paid by the Plan to the trustee and custodian amounted to \$38,065 and \$29,152 for the years ended October 31, 2024 and 2023, respectively.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - INCOME TAX STATUS

The Plan is a non-standardized prototype plan. The Internal Revenue Service has determined and informed the trustee by a letter dated March 31, 2014 that the Plan and the related trust established under the Plan are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - TERMINATED PARTICIPANTS

The value of terminated participants' accounts for years ended October 31, 2024 and 2023 was \$4,675,728 and \$2,931,782, respectively.
