Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Edison Welding Institute, Inc. Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Edison Welding Institute, Inc. Salary Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1986 as a defined contribution retirement plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan provides retirement benefits to all eligible employees of Edison Welding Institute, Inc. (the "Company").

All employees of Edison Welding Institute, Inc. who have attained the age of 20½ are eligible to participate in the Plan on their first day of employment. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers several registered investment companies (mutual funds) and common/collective trust funds as investment options.

Contributions

Plan participants may voluntarily contribute between 1 percent and 75 percent of their annual eligible compensation to the Plan as a pretax contribution and an after-tax Roth IRA contribution. The amount of a participant's contribution for any plan year may not exceed certain limits set by the plan document and the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans and after-tax contributions, not to exceed certain limits set by the plan document and the IRC.

The Company makes a nonelective safe harbor contribution to each participant's account equal to 3 percent of eligible compensation. The Plan also allows for the Company to make a discretionary matching contribution for all participants making employee deferrals. For the year ended December 31, 2024, the Company made matching contributions equal to 50 percent of the first 8 percent of deferred compensation. The Company may also make additional discretionary contributions at the option of the Company's board of directors. There were no other discretionary contributions made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contributions and an allocation of (a) the Company's contributions and (b) plan earnings and expenses. Allocations are based on participants' earnings or account balances in accordance with the method described in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and other discretionary contributions is based on years of continuous service.

The Company's discretionary contributions, if any, vest according to the following schedule:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Payment of Benefits

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a plan participant is entitled is that amount of contributions and income allocated to that participant's account. Upon disability, service or disability retirement, death, or termination, the participant or beneficiary will be paid in a lump sum or in a form agreeable to the plan administrator. In addition, the Plan includes a provision for participants to make withdrawals from their accounts under certain hardship circumstances.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the IRC. Notes receivable bear interest at a market rate.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The interest-bearing cash is valued at fair value based on its outstanding balance. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Party-in-interest Transactions

During 2024, the Plan paid administrative fees for investment management services. The Company pays certain other fees related to the Plan's operations.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 4, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Ascensus Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus, LLC, as agent for Ascensus Trust Company (Ascensus).

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 5 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
