## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Plumbers and Steamfitters  
Local No. 131 Annuity Fund

### Opinion

We have audited the financial statements of the Plumbers and Steamfitters Local No. 131 Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of October 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**NOTES TO FINANCIAL STATEMENTS**

OCTOBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF PLAN**

**General** - Plumbers and Steamfitters Local No. 131 Annuity Fund (the Plan) was established on November 1, 1994 and is maintained pursuant to collective bargaining agreements. The purpose of the Plan is to supplement the benefits of the Plumbers and Steamfitters Local No. 131 Pension Fund by the establishment of an individual account plan to which contributions are made for each employee working as a plumber and steamfitter in the jurisdiction of Local 131.

The Plan is jointly administered by a Board of Trustees consisting of representatives of the employers and the union. The Plan is a non-contributory defined contribution profit sharing plan under the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Employers' Contributions** - Contributions to the Plan are made by contributing employers at rates established by the collective bargaining agreement. The collective bargaining agreement provides for employers to contribute \$2.21 for each hour worked by covered journeymen and foremen effective June 6, 2022. The agreement also provides for employers to contribute \$1.71 for each hour worked by apprentices after 6 months of employment effective June 6, 2022. Contributing employers primarily conduct business in the State of New Hampshire. Contributions from 3 employers comprise 67% of the total contributions for 2024.

**Participant Accounts** - An individual becomes a participant in the Plan on the day he/she works at least one hour in covered employment. Covered employment means employment with a contributing employer in a category of work covered by a collective bargaining or participation agreement requiring contributions to the Plan. Participants may direct the investment of employer contributions made on their behalf to any investment option offered under the Plan. Each participant's account is credited with employer contributions and adjusted by investment results and expenses. Administrative expenses are allocated quarterly, on a per capita basis, among those accounts which are in existence. Net earnings or losses are allocated on a daily basis based upon the investment results of the investment options in a participant's account.

**Vesting** - Participants are 100% vested in the value of the employer contributions made on their behalf plus the allocation of net earnings or losses and administrative expenses.

## **NOTE 1. DESCRIPTION OF PLAN (continued)**

**Plan Benefits** - Participants are entitled to their vested benefits upon retirement, disability, death, termination of covered employment or satisfying the requirements of financial hardship. An election for distribution must be filed indicating the method of distribution and approved by the Board of Trustees. The participant may receive benefits in one lump-sum payment or partial distributions.

On August 9, 2022, the Board of Trustees voted to adopt the 3<sup>rd</sup> Amendment to the Plan regarding disqualified beneficiaries.

On May 9, 2023 the Trustees approved to change the Required Minimum Distribution age to 73, effective January 1, 2023, in accordance with the Secure Act 2.0.

On February 13, 2024, the Trustees voted to adopt Plan Amendments regarding the Secure Act, Secure Act 2.0, Jurisdiction and Venue Clause, and Slayer Clause.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** - The Plan's investments in registered investment companies are stated at fair value as determined by quoted market prices or the net asset value of the fund. The Plan's investments in the insurance contract is stated at contract value. See Note 11 for discussion of fair value measurements and Note 12 for discussion of investment contract with insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

## **NOTE 3. PLAN TERMINATION**

The Trustees expect and intend to continue the Plan indefinitely but reserve the right to amend or terminate it. Upon termination of the Plan or complete discontinuance of contributions, each participant or beneficiary will have nonforfeitable rights to their account, after providing for all of the expenses of the Plan at termination.

**NOTE 4. TAX STATUS**

The Plan is qualified under Section 401(a) of the Internal Revenue Code and the related trust is exempt from federal income tax under Section 501(a).

The Plan obtained its latest determination letter on February 23, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5. EMPLOYER CONTRIBUTIONS RECEIVABLE**

Employer contributions receivable represents uncollected contributions for covered employment prior to the Plan's fiscal year end.

The allowance account was established based on an assessment of the collectability of contributions receivable. There were no amounts written off as uncollectible during the years ended October 31, 2024 and 2023, respectively.

**NOTE 6. RELATED PARTIES**

The Plumbers and Steamfitters Local No. 131 Pension and Health and Welfare Funds are related to the Plan through common trustees. The Funds share the cost of meeting expenses, insurance coverage, conference expenses, and certain legal fees. The Plan's portion of shared expenses totaled \$15,476.

**NOTE 7. PARTY IN INTEREST TRANSACTIONS**

The Plan paid certain expenses related to Plan operations and investment activities to various service providers. These transactions are party in interest transactions under ERISA.

#### **NOTE 8. CONTRACT ADMINISTRATION**

The Plan has a contract with Zenith American Solutions (Zenith), a third party administrator, to administer the Plan. The contract provided for a monthly fee of \$2,044 through December 31, 2023. Effective January 1, 2024, the monthly fee increased to \$2,105. The agreement shall be extended automatically, in one year increments, without further action on either party unless terminated.

#### **NOTE 9. RECIPROCAL AGREEMENTS**

The collective bargaining agreement requires employers to contribute for all employees regardless of whether the employee is a member of Local No. 131 or another affiliated local. The Plan's trustees have signed reciprocity agreements with plan trustees for a number of affiliated local unions. According to these agreements, contributions received on behalf of employees working outside the jurisdiction of their home local union are forwarded to the appropriate plan of the employee's home local union at an agreed upon rate.

#### **NOTE 10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 11. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

##### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

## NOTE 11. FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

For the years ended October 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at October 31, 2024 and 2023.

*Registered Investment Companies:* Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year end and are classified within level 1 of the valuation.

## **NOTE 12. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a Guaranteed Interest Account with Mass Mutual Life Insurance Company (“Mass Mutual”). The investment is an unallocated insurance contract called Fixed Interest Fund. The Fixed Interest Fund is a market value separate investment option with a general investment account guarantee that provides a stated rate of return and insulates participants’ accounts from daily fluctuations in the market. Under the terms of the Fixed Interest Fund group annuity contract, participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balance in the Fixed Interest Fund investment option at contract value.

Contract value represents contributions and credited interest less participant withdrawals and fees. Contract value is also often referred to as “Book Value”. The fair value represents the liquidation value as documented within the Fixed Interest Fund contract and assumes that the intrinsic value of the general investment account guarantee is immaterial. Liquidation value is the market value of the assets in the separate account. Mass Mutual considers the Fixed Interest Fund to be fully benefit responsive notwithstanding the liquidation value events under the contract that limit the ability of the plan to transact at contract value.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: 1) temporary absence; 2) change in position or other occurrence qualifying as a temporary break in service under the Plan; 3) transfer or other change of position resulting in employment by an entity controlling, controlled by or under other common control with the employer; 4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan’s sponsor’s business. The Plan administrator believes the occurrence of such events, that would also limit the Plan’s ability to transact at contract value with Plan participants, is not probable.

The Guaranteed Interest Account is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the Great West general accounts that is used to determine the Guaranteed Interest Account’s crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for plan year 2024 is 3.55%. The actual average yield earned by the plan for the benefit responsive fund can be derived averaging the plan’s quarterly interest rates. That average for plan year 2024 is 3.55%.

## **NOTE 13. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through August 4, 2025 which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
