Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Noble Biomaterials, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits at December 31, 2024, the related statement of changes in net assets available for benefits for the period May 30, 2024 to December 31, 2024, and the related notes to the financial statements.

NOTE 1 Description of plan

The following description of Noble Biomaterials, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of Noble Biomaterials, Inc. (the "Company") who had six months of service and were age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees was responsible for oversight of the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an Eligible Automatic Contribution Arrangement ("EACA") whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The default deferral rate shall increase by 1% annually up to a maximum of 10%. Contributions are automatically invested according to the investment documents related to the Plan. The Company contributes 100% of the first 4% of compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's board of directors. The Company did not make any discretionary contributions in 2024. Participants direct the investment of all contributions into various options offered by the Plan. Contributions are subject to certain IRS limitations.

Transfer of assets

On May 30, 2024, the Board of Trustees of Noble Biomaterials, Inc. approved the creation of this Plan. All investments were transferred from a multi-employer Plan into the Plan accordingly on May 30, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, Company EACA contributions and allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. Participants self-directed the investments in their own accounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's

account and bear an interest rate of 1% over the prime rate (prime rate was 7.50% on December 31, 2024). Principal and interest is paid ratably through payroll deductions.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump sum distribution equal to the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met.

Vesting

Participants were vested immediately in their contributions, including EACA contributions, rollovers, plus actual earnings thereon. Vesting in the Company's matching contribution portion, if any, of their accounts plus actual earnings thereon is based on years of continuous service on a scale as follows:

Forfeited accounts

Forfeited accounts are used in the future to reduce Plan administrative expenses. At December 31, 2024, forfeitures aggregated \$7,041.

SECURE Act 2.0

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for the provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

NOTE 2 Summary of significant accounting policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines that Plan's valuation policies utilizing

information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Note receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable is recorded as benefit payments on the basis of the terms of the Plan.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs used in determining valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for

substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds

The collective trust funds are composed primarily of commingled investment vehicles that are valued at net asset value of units of the collective trust. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Therefore, the investment has a "Readily Determinable Fair Value." Participant transactions (purchases and sales) may occur daily. Advance written notice is required for any redemption directed by a plan sponsor; redemptions of \$1,000,000 or more of a plan's assets invested in the fund require 5 business days advance notice for most funds. Redemptions will be made on a pro rata basis from the plan's interest in the fund. Certain funds may have additional prior notice requirements. If total fund withdrawals from all plans requesting withdrawals exceed the amount of uncommitted cash and the liquid investments available on the redemption date payments will be made based upon the following priorities: (1) requests for redemptions in order to pay benefits from plans; (2) requests for redemptions to effect transfers to other investments directed by plan participants; and (3) all other redemption requests. There are no unfunded commitments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 Related-party transactions and party in interest transactions

Certain of the Plan's investments are managed by the trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants will become 100% vested in the employer contributions.

NOTE 7 Tax status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designated in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 Information certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period May 30, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal (the trustee of the Plan).

NOTE 9 Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 Subsequent events

The Plan had evaluated subsequent events through July 22, 2025, which is the date these financial statements were available to be issued.
