Independent Auditor's Report

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Albertus Magnus College DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Independent Auditor's Report

To the Plan Administrator  
Albertus Magnus College DC Retirement Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Albertus Magnus College DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### *Other Matters - Supplemental Schedules Required by ERISA*

The supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a) for the year ended December 31, 2024 and Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements December 31, 2024

### Note 1 - Description of Plan

The following description of Albertus Magnus College DC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

#### General

The Plan is an Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Albertus Magnus College (the "College"). All eligible employees may begin to make salary deferral contributions to the Plan as soon as administratively feasible following their date of hire. Students, as defined, are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

#### Contributions

Each year, participants may make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has also elected to allow participants to make additional Qualified Organization Catch-up Contributions provided they have completed at least 15 years of service. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of College Retirement Equities Fund ("CREF") variable annuity contracts; a Teachers Insurance and Annuity Association of America ("TIAA") pooled separate account, referred to as the TIAA Real Estate Account; TIAA fixed annuity contracts, referred to as the TIAA Traditional Annuity Account; and a variety of mutual funds as investment options for participants.

The College may, at its discretion, make matching contributions to the Plan on behalf of each eligible participant. Employees age 21 or older who have completed one year of service (minimum of 1,000 hours) are eligible to receive College discretionary matching contributions. The College will make discretionary matching contributions to the Plan on behalf of faculty members who make a minimum salary deferral contribution to the Plan of 5% and nonfaculty members who make a minimum salary deferral contribution to the Plan of 3%. For the year ended December 31, 2024, the College made discretionary matching contributions to the Plan based on each participant's eligible years of service in accordance with the following table below:

<u>Years of service</u>	<u>College discretionary matching contribution</u>
1 - 5	3.5% of eligible compensation
6 - 10	4.0% of eligible compensation
11 - 15	4.5% of eligible compensation
16 - 21	5.0% of eligible compensation
22 or more	5.5% of eligible compensation

Effective January 1, 2022, the Plan was amended to credit participants with prior years of service from other qualifying organizations, as defined. This prior service credit is available for purposes of eligibility, the College's discretionary matching contributions and vesting.

Participants also direct the investment of the College's discretionary matching contributions. All contributions are subject to certain IRC limits.

#### Participant accounts

Each participant's account is credited with the participant's contributions and the College's discretionary matching contributions, as well as an allocation of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. In the event of termination due to death, disability or normal retirement, participants shall become 100% vested in the College's discretionary matching contribution portion of their account. For all other participants, vesting in the College's discretionary matching contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

3	40%
4	60%
5	80%
6 or more	100%

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of certain portions of their account balance. The loans are secured by the balance in the participant's account. The loan interest rates are determined by the source of the participant's investments. The loan interest rate is based on the prime rate on the first business day of the month in which the loan is approved, plus 1%. Principal and interest payments are made directly by participants to TIAA-CREF.

#### Payment of benefits

Upon termination of service for any reason, participants will receive benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Terminated participants with a vested account balance less than \$7,000 will receive a mandatory distribution in a lump-sum payment. The Plan administrator will make a direct rollover of the participant's account to an individual retirement account, designated by the Plan administrator, with a vested account balance greater than \$1 but less than \$7,000 if the participant does not elect a direct rollover. Participants with a vested account balance greater than \$7,000 may elect to receive their vested balance as a single lump-sum amount, in installment payments over a specified term, in the form of an annuity contract, or defer payment of benefits until a later date.

Withdrawals from the salary deferral contribution portion of a participant's account (exclusive of earnings) may be made in the event of a financial hardship in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed from all portions of a participant's vested account, in accordance with the provisions specified in the Plan, for participants who have become disabled or who have attained normal retirement age.

#### **Forfeited accounts**

When a participant is terminated, nonvested contributions are forfeited by the participant. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$75,973 and \$64,755, respectively. Forfeitures may be used to reduce future employer contributions or to pay Plan expenses. There were no amounts utilized from forfeitures during the year ended December 31, 2024.

#### **Note 2 - Summary of accounting policies**

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in two types of fixed annuity contracts, of which one is considered fully benefit-responsive.

##### **Investment valuation and income recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The College, in conjunction with the investment advisor, determines the Plan's valuation policies utilizing information provided by TIAA and CREF. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### **Payment of benefits**

Benefit payments are recorded upon distribution.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the College. Expenses that are paid by the College are excluded from these financial statements. Participant loan issuance fees, certain investment advisory fees and other administrative costs are paid directly by the Plan and are included in administrative expenses. Indirect investment related expenses are included in the net appreciation in fair value of investments.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Subsequent events

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

#### Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA and CREF.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Variable annuity contracts:* Valued at the unit value as reported by the accounts. The unit values are listed on the National Association of Securities Dealers Automated Quotations ("NASDAQ") website and updated overnight for each day that the NASDAQ is open. The accounts held by the Plan are deemed to be actively traded.

*Nonfully benefit-responsive fixed annuity contracts:* Valued based on the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. These annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the retirement annuity contracts may be made in the form of a life annuity or in 10 annual installments. The fully benefit-responsive fixed annuity contracts are valued as described in Note 5.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the unit value reported by the account. The unit value is listed on the NASDAQ website and updated overnight for each day the NASDAQ is open. The pooled separate account held by the Plan is deemed to be actively traded.

### Notes to Financial Statements December 31, 2024

#### Note 5 - Investment contracts with insurance company

The Plan has entered into fully benefit-responsive fixed annuity contracts with TIAA, an insurance company, referred to as the TIAA Traditional Annuity Account. Participants who choose to invest in these contracts make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and ranges between 1% and 3% and has the potential for additional interest if declared by TIAA.

The Plan's ability to receive amounts due in accordance with fully-benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the College's discretionary matching contributions.

#### **Note 7 - Plan loans**

Participants were able to borrow from TIAA and CREF using certain portions of the assets in the participant's account as collateral. Under this arrangement, TIAA and CREF have the right to collect the collateral in the event of a default. Principal and interest payments are made directly by participants to TIAA and CREF. At December 31, 2024 and 2023, Plan loans totaling \$19,135 and \$25,815, respectively, were outstanding under this arrangement, of which \$19,135 and \$18,097, respectively, have been defaulted. TIAA will no longer offer Plan loans to the Plan's participants.

#### **Note 8 - Tax status**

The Plan has been designed using a volume submitter 403(b) plan document sponsored by TIAA. TIAA received an advisory letter dated August 7, 2017, in which the Internal Revenue Service ("IRS") stated that the volume submitter 403(b) plan document satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is deemed to be qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 - Related party and party-in-interest transactions**

Certain Plan investments are proprietary investments managed by TIAA and CREF. TIAA and CREF are the insurance entities who hold certain investments of the Plan and also the recordkeeper as agent for TIAA Trust, N.A., the custodian holding the other investments of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for TIAA and CREF investment management services are included in the net appreciation in fair value of investments. Direct fees of \$9,553 pertaining to TIAA and CREF administrative services were charged directly to participant accounts for the year ended December 31, 2024. The College pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against certain portions of their account balance, which are also considered party-in-interest transactions.

Effective May 1, 2024, all TIAA-CREF proprietary mutual funds and TIAA-CREF Lifecycle funds were renamed Nuveen funds. TIAA is the parent company of Nuveen, therefore, the Nuveen funds are considered proprietary assets and also qualify as party-in-interest transactions.

At December 31, 2024 and 2023, the Plan's revenue sharing account totaled \$40,365 and \$23,219, respectively. This account is used to pay Plan expenses and any excess amounts may be re-allocated to participant accounts. The Plan received revenue sharing credits from TIAA in the amount of \$26,838 for the year ended December 31, 2024, which is shown as other income in the accompanying financial statements. The Plan made direct payments that were covered by revenue sharing credits of \$11,359 to TIAA and other consultants for certain investment advisory and third-party administration fees for the year ended December 31, 2024.

#### **Note 10 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 11 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the College for the year ended December 31, 2024. The College is currently working with its third-party administrator to calculate a corrective contribution of lost earnings that will be deposited into the Plan and allocated to the affected participants as soon as administratively feasible.

#### **Note 12 - Subsequent events**

Subsequent to year-end, the College made the decision to merge the Plan into a 403(b) Multiple Employer Plan established by New England Independent Colleges and Universities. Effective June 2025, the College merged its Plan assets and became a participating employer in the New England Independent Colleges and Universities Multiple Employer Plan.
