Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lindblad Expeditions, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lindblad Expeditions, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lindblad Expeditions, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 – Description of Plan

The following description of the Lindblad Expeditions, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was amended in July 2022.

General

The plan is a defined contribution plan, established November 1, 1991. It is available to employees of Lindblad Expeditions, LLC. formerly known as Lindblad Expeditions, Inc. (the “Company” or the “Sponsor”). Effective December 1, 2024, the employees of Wineland-Thomson Adventures, LLC were able to join into the Lindblad Expeditions, Inc. 401(k) Plan. Employees become eligible for the Plan upon culmination of six months of service from the employee's date of hire and upon attainment of age 21. The Plan provides for contributions pursuant to Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

Under the provisions of the Plan, participants may defer up to 100% of qualified compensation to the Plan, subject to Internal Revenue Code regulations and limitations. Participants may also make a Roth deferral contribution to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic deferral feature for eligible new employees whereby 2 percent of their compensation will be withheld and contributed to the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

The Company made matching contributions in an amount not to exceed 30% of compensation contributed as elective deferrals for the plan year. Matching 401(k) contributions are subject to a maximum amount of \$2,400 for the year ended December 31, 2024. The Company may also make a profit-sharing contribution. The employer matching contributions for the year ended December 31, 2024, were \$686,451.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company's discretionary contributions and plan earnings. Earnings are allocated by fund to individual accounts monthly based on the proportion each account bears to the total of all account balances within the fund, which earned the income. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting

Participants are immediately 100% vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in the remainder of their accounts is based on the following years of service:

<u>Years of Service</u>	<u>Percentage</u>
1	25%
2	50%
3	100%

In the event of death, permanent disability, or normal retirement at the age of 65, participants become fully vested in all of their accounts, regardless of the vesting percentage attained at that date.

Notes Receivable from Participants

Plan participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested balance or the greater of \$50,000 less the highest outstanding loan balance over the last twelve months or \$10,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates from 7.50% to 8.50% per annum, which are commensurate with local prevailing rates. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant will receive a lump-sum distribution equal to the vested balance of their account if the balance is under \$1,000. Participants with a balance between \$1,000 and \$5,000 have 90 days from date of termination to rollover their account or the balance will automatically be rolled over to a Merrill Lynch IRA outside of the plan. Participants with a balance over \$5,000 have the option to keep their balance in the Plan or receive a distribution in accordance with the Plan document.

Investment Options

Participants may select one or more predetermined investment vehicles for the investing of contributions and allocated earnings. Contributions are deposited directly into the participant elected investment vehicles.

Forfeited Accounts

Forfeited non-vested accounts are used to reduce plan expenses or future employer contributions. For the year ended December 31, 2024, \$11,068 were used to reduce plan expenses. The remaining balance in the forfeited non-vested accounts at December 31, 2024 and 2023, totaled \$4,982 and \$4,519, respectively.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. No liability has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings. Employer contributions are recorded in the period in which the Company makes its contributions to the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of loans to participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses for the year ended December 31, 2024 were \$160,316. Investment-related expenses are included in net appreciation of the fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments brought and sold as well as held during the year.

The Plan's fair value investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated for the year ended December 31, 2024 by \$6,268,742.

Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a plan termination, participants would become 100 percent vested in their accounts. The complete provisions covering the Plan termination are included in the Plan document, which is available to all participants.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund ("Fund"): Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily, even if the Plan were to be discontinued. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The investment strategy of the Fund is the Fund's returns are based on returns generated by an actively managed, highly diversified portfolio of investment grade, fixed and floating rate securities. The Fund may invest in such securities directly or indirectly through comingled investment vehicles (the "building block strategy"). This building block strategy may provide greater diversification than could be achieved by investing in individual bonds. This building block strategy also may reduce the unintended impact on portfolio characteristics created by participant cash flow.

The trustee and investment manager for the Fund is Invesco Trust Company, a Texas trust company.

Note 4 - Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds and a commingled fund managed by Merrill Lynch Investment Managers, an affiliate of Merrill Lynch. Merrill Lynch, as defined by the Plan is the investment manager; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services was \$160,316 for the year ended December 31, 2024.

Note 5 - Tax Status of Plan

The Plan is a prototype Plan of Ascensus, Inc. that obtained its last determination letter on March 31, 2014, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and other taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. There was no material impact to the Plan's 2024 financial statements.

Note 8 – Investment Certified by the Plan's Trustee (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Ascensus on behalf of Ascensus Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 is complete and accurate.
