INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of
Proskauer Rose LLP Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Proskauer Rose LLP Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The Proskauer Rose LLP Profit Sharing Plan (the "Plan") is a defined contribution plan under Section 401(a) of the Internal Revenue Code (the "Code") and was established by Proskauer Rose LLP (the "Partnership") in order to provide a systematic method by which its eligible employees could receive retirement benefits. The Plan was amended and restated effective November 1, 2013 and has been subsequently amended. The Plan's benefits are funded entirely by the Partnership. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Partnership's Retirement Plan Committee as designated by the Partnership's Executive Committee.

[1] Contributions:

Effective with the Plan year beginning November 1, 2010, the Partnership will make a fixed profit-sharing contribution ("fixed contribution") on behalf of each eligible participant equal to 7.5% of a participant's first \$255,000 of compensation, as well as an enhanced contribution, as defined by the Plan, for certain named participants. The Partnership may make a discretionary contribution at its sole and absolute discretion subject to certain limitations. There were no discretionary contributions in 2024.

[2] Benefits:

Benefit payments are determined by the value of the participant's account balance and recorded when paid.

On termination of employment, death, retirement at normal retirement age or by reason of disability, or upon attainment of age 59½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

[3] Participation and vesting:

Each eligible staff employee, senior counsel or income partner becomes a participant in the Plan upon completion of one hour of service for the Partnership. Eligible employees exclude nonresident aliens, leased employees, employees subject to a collective bargaining agreement and the executive director of the employer (all as defined in the Plan). Each staff employee, senior counsel or income partner becomes eligible for the fixed contribution upon completion of one year of service for the Partnership, as defined. Participants must be employed on the last day of the Plan year to receive a contribution.

Each participant's account is credited with allocations of (a) the Partnership's employer contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Effective January 1, 2007, each participant was subject to graded vesting of two to six years and will be 100% vested upon completion of their sixth year of service. In the event a participant terminates employment, any portion of the participant's profit-sharing account to which the participant is not vested will be forfeited. Benefits are fully vested if a participant reaches normal retirement age, incurs a disability or dies while an employee of the Partnership.

[4] Termination of the Plan:

Although it has not expressed an intent to do so, the Partnership may terminate the Plan for any reason at any time. Upon termination of the Plan, the rights of participants to the benefits accrued under the Plan to the date of termination, as defined in the Plan, shall be nonforfeitable and fully vested.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

[5] Administrative expenses:

Except for recordkeeping charges, fees relating to the administration of personal choice retirement self-directed brokerage accounts ("PCRA's") and Plan investment management fees, all administrative costs of the Plan are paid by the Partnership and are excluded from the financial statements. Certain Plan expenses are paid through revenue-sharing agreements with investment funds (Note F).

[6] Forfeited accounts:

Under the Plan, amounts forfeited as a result of vesting rules can be utilized against Plan administrative expenses and the excess as a reduction of future contributions. At October 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,886 and \$226,180, respectively. The Employer contribution receivable at October 31, 2024 and 2023 was reduced by forfeited nonvested accounts, available subsequent to year-end, of approximately \$629,000 and \$524,000, respectively.

[7] Investment options:

Plan participants have the option of investing from a choice of various investment options, which include a money market fund, mutual funds offered by registered investment companies including target retirement funds, and a common/collective trust. In addition, participants have the option to invest in a PCRA, which is a self-directed brokerage account. Investment options included in the PCRA are limited to mutual funds, government securities, money market funds and interest-bearing cash and cash equivalents.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and when applicable, the disclosure of contingent assets and liabilities and accompanying notes. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The following is a description of the valuation methodologies used for investment assets measured at fair value:

All mutual funds and the money market fund are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission ("SEC"). The money market is a mutual fund that is registered with the SEC. As of December 31, 2024, the money market fund invested primarily in U.S. Treasury securities whereas as of December 31, 2023, the money market fund invested in U.S. Treasury and government agency securities, commercial paper and certificate of deposits. The mutual funds and money market fund are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[3] Investment valuation and income recognition: (continued)

PCRA accounts, self-directed brokerage accounts, are invested in mutual funds and interest-bearing cash that are valued on the basis of readily determinable market prices.

The Plan invests in the Pioneer Large Cap Growth Portfolio ("Pioneer"), a common/collective investment trust. Pioneer is valued at its NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pioneer seeks long-term growth of capital through investment principally in publicly traded equity securities. Participant transactions (purchases and sales) may occur daily. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the common/collective trust fund and participant withdrawal requests will be honored when received. The common/collective investment trust is redeemable upon written notification. Plan sponsor directed withdrawals in excess of \$1 million require five days written notice and may be limited and prioritized if total withdrawals are in excess of available liquid funds. As of October 31, 2024 and 2023, there were no unfunded commitments; the redemption frequency for participant transactions in the common/collective funds is daily upon receipt of an authorized request on or prior to the valuation date.

Net realized/unrealized appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Charles Schwab Trust Bank, (the "Trustee") of the Plan, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of October 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended October 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of October 31, 2024.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation techniques used to measure fair value of investment are included in Note B[3]. There have been no changes in the methodologies used at October 31, 2024 and 2023.

The methods described in Note B[3] may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS (CONTINUED)

(A) Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - TAX STATUS

The Internal Revenue Service has determined and informed the Partnership by a letter dated March 18, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Code. The Plan has been amended since applying for the tax determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During 2024, certain investments are shares of registered investment companies managed by Charles Schwab Trust Bank, the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan, inclusive of PCRA advisory fees, were \$14,403 for the year ended October 31, 2024. The Plan also pays investment advisory fees. As a service provider to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to this service provider was \$3,688 for the year ended October 31, 2024.

The Trustee receives revenue from mutual fund providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for their administrative services to the Plan. If the revenue received by the Trustee from such mutual fund service providers exceeds the amounts owed, the Trustee remits the excess to the Plan pursuant to the service agreement. During the year ended October 31, 2024, \$21,532 was received from the trustee and is reflected in net realized/unrealized appreciation in the fair value of investments in the statement of changes in net assets available for benefits. Such amounts may be applied to pay Plan expenses. During the year ended October 31, 2024, \$18,091 was used to pay Plan expenses. The account balance as of October 31, 2024 and 2023 was \$177,391 and \$173,950, respectively.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - RISKS AND UNCERTAINTIES (CONTINUED)

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at October 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus are not separately identifiable as an expense.

NOTE I - SUBSEQUENT EVENTS

The Plan's management evaluated subsequent events through August 11, 2025, the date on which the financial statements were available to be issued, and no additional disclosures were required.
