In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

McCoy-Rockford, Inc. 401(k) Retirement Plan (the Plan) is a qualified retirement plan adopted by McCoy-Rockford, Inc. (the Company) to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on January 1, 1994 and was amended and restated effective July 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All eligible employees of the Company who have attained the age of 21 and completed three months of service may participate in the Plan. Participants may enter the Plan on the date they satisfy the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage (up to 90% of compensation) or dollar amount and have that amount contributed to the Plan as a salary deferral, not to exceed an annual dollar limit which is set by law. There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Participants who attain age 50 before the end of a calendar year may also elect to defer additional catch-up contributions to the Plan. Participants are permitted to modify or revoke their salary deferral election at any time during the Plan year and may make any other modification at least once a year.

The Plan includes an automatic salary deferral feature. If a participant does not submit an elective deferral agreement or does not specifically decline to make elective deferrals, the Company will automatically withhold 3% of a participant's compensation and contribute it to the Plan on the participant's behalf in the form of an automatic elective deferral. Participants can opt out of the automatic deferral program at any time.

The Company may make a discretionary matching contribution on behalf of eligible Plan participants, as a percentage of salary deferrals participants' make during each payroll period or as a uniform dollar amount. The Company will decide each year how much, if any, they wish to make as a matching contribution. Company matching contributions in any Plan year will not exceed \$500 per participant.

The Company may also match a discretionary profit sharing contribution to the Plan, which will be allocated annually. During 2024, the Company did not make any profit sharing contributions.

Rollover contributions from other qualified retirement plans and certain IRAs may be permitted by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their salary deferrals and rollover contributions. Participants' vested percentage in Company profit sharing contributions is determined under a six-year graded vesting schedule, in which participants earn 20% vesting each year of service after two years of service. Participants' vested percentage in Company matching contributions is determined under a two-year graded vesting schedule, in which participants become fully vested after two years of service.

Payment of Benefits: Upon termination of employment due to death, disability or normal retirement, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in their account or installments over a period of assumed life expectancy. Upon termination of employment for reasons other than death, disability or normal retirement, lump-sum distributions may be made at the participant's election. If a participant's vested account balance exceeds \$5,000, no distribution will be made from the Plan without their consent. If a participant's vested account balance does not exceed \$5,000 when they terminate employment, then their vested account balance may only be distributed to them in a single lump-sum payment, even if the participant does not consent to a distribution. If a mandatory distribution is being made to a participant because their vested interest in the Plan exceeds \$1,000 but does not exceed \$5,000, then the Plan will rollover their distribution to an IRA if they do not make an affirmative election to either receive or roll over the distribution.

Participants may be entitled to receive an in-service distribution. A participant may request a hardship withdrawal to satisfy certain immediate and heavy financial needs. Hardship distributions are permitted from all account sources allowed under the Plan, including pre-tax elective deferral, Roth elective deferral, rollover, and matching contribution accounts, in accordance with IRS regulations and the terms of the Plan document. Participants who have attained age 59½ may receive an in-service distribution from the Plan from all eligible account types prior to termination of employment. The minimum amount a participant can receive as an in-service distribution is \$500.

Notes Receivable From Participants: Participants may borrow from the Plan up to a maximum aggregate amount equal to the lesser of 50% of the participant's nonforfeitable account balance or \$50,000, reduced by the excess of the participant's highest outstanding note balance during the 12-month period ending on the date of the note over the participant's current outstanding note balance on the date of the note. The minimum note amount is \$1,000. The notes are made for terms not to exceed five years, unless the note is obtained to purchase a principal residence, for which the Company may permit a longer repayment term. The notes are adequately secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. Forfeitures may be used to pay Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$743 and \$410, respectively. During 2024, approximately \$4,317 of forfeitures were used to reduce employer contributions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination no further contributions will be made to the Plan and all amounts credited to participant accounts will become 100% vested. The Company will direct the distribution of participant accounts as soon as administratively feasible.

Administrative Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, the expenses will generally be allocated among the accounts of all participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, the participant.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 30, 2025, which is the date the financial statements were available to be issued. No subsequent events were identified that require adjustment to or disclosure in the financial statements.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows.

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. During 2024, the Plan paid investment management fees to an investment advisor and an affiliate of Reliance Trust Company for recordkeeping services, which qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
