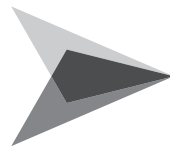

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Manufacturers Bank Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Manufacturers Bank Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Sections 103(a)(3)(C).

Basis for Opinion

December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of the Manufacturers Bank Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General and eligibility – The Plan is a defined contribution plan covering substantially all employees of Manufacturers Bank & Trust (the Company), who are 19 years of age or older, as defined by the Plan. Eligible employees are allowed to enroll immediately following the date the requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute up to 100% of pretax annual compensation subject to an annual limit by federal regulations, as defined by the Plan, and are auto-enrolled into the plan at 8%, unless opted out. Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company makes matching contributions of up to 4% of eligible compensation. The company also makes an additional discretionary matching contribution as determined by the company.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, matching and discretionary contributions, plan administrative expenses, and plan earnings. Allocations are based on participant earnings or on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. The Plan allows each participant to choose their own investment mix for salary deferrals and employer contributions. Participants can change their investment mix daily. If a participant does not make a timely selection for investment allocation, contributions are automatically invested in the target retirement date fund most closely matching the estimated retirement date of the participant based on birthdate. The funds remain in that fund until changed by the participant.

Participant loans – Participants may borrow from their accounts a minimum of \$500 and a maximum amount of 50% and \$50,000 with a max term of 5 years unless the loan is taken for the purpose of purchasing a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate of 5.50% - 10.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably by the participant to the plan administrator through payroll deductions.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,852 and \$23,196, respectively. These accounts are used to reduce the employer contribution that is received by the Plan subsequent to its year end.

Payment of Benefits – Upon termination of service, retirement, death or disability, a participant may elect to receive an amount equal to the value of their vested account balance in a lump-sum payment. In-service withdrawals after age 59 ½ are also allowed under the terms of the plan. Hardship withdrawals are not allowed.

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Note 2 - Summary of Accounting Policies

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition – The investments of the Plan, with the exception of fully benefit responsive (“FBR”) investment contracts, are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date (the exit price). The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisers. See Note 6 for a discussion of fair value measurements. The Plan’s fully benefit responsive investment contract with Principal Trust Company (Note 7) is valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan’s contracts, less withdrawals.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administration fees paid directly by the Plan are reflected on the statements as administrative expenses.

Date of Management Review – Management has evaluated subsequent events through July 23, 2025, the date which the financial statements were available to be issued.

Note 3 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

Note 4 - Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan’s administrator and the Plan’s tax counsel believe that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Information Certified by the Trustee

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedule, related to the following assets:

Note 6 - Investments and Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are held as individual plan assets. Both proprietary and non-proprietary mutual funds have publicly available prices that are quoted daily. In addition, underlying asset information is publicly available for each fund and therefore is classified as Level I in the fair value hierarchy.

Note 6 - Investments and Fair Value Measurements (Continued)

Pooled Separate Accounts: Pooled separate accounts invest in a single mutual fund. The fair value of the mutual fund is a publicly quoted pricing input used in determining the net asset value of the pooled separate account, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The net asset value is the basis for current transactions and the pooled separate accounts can be redeemed at net asset value as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Valuation approaches are reviewed on an ongoing basis by the trustee and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price and that the valuation techniques used have not changed so as to cause a change in the level used for the basis of fair value measurement.

Note 7 - Fixed Investment Contract

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. If a contract is terminating and a surrender charge applies, the Plan may no longer be deemed benefit responsive. This could require the fixed account to be reported at fair value and thus included in the fair value disclosures. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring. For the year ended December 31, 2024, the Plan does not have a fixed investment contract.

Note 8 - Related-Party and Party-In-Interest Transactions

The Plan invests in fixed accounts and pooled separate accounts managed by Principal. Principal is the trustee as defined by the Plan, and therefore, transactions with Principal qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$47,480 and \$41,079 for the years ended December 31, 2024, and 2023, respectively.

Note 9 - Subsequent Events

Subsequent to year end, an amendment was added to the Plan to add automatic contribution escalation of 1% every year with a cap of 15% for any participant that has not made a proactive deferral election, effective January 1, 2025.

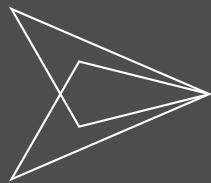
