1. DESCRIPTION OF PLAN:

The following description of the Bethesda 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all employees of Bethesda Associates and Subsidiaries (the Company). The Plan was established on January 1, 1999, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The retirement committee is responsible for plan oversight.

CONTRIBUTIONS

Each year, participants may contribute from 1% up to a maximum of 100% of annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Unless directing otherwise, participants are automatically enrolled at 4% of eligible compensation upon date of hire. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed investment contract as investment options for participants.

All employees are eligible to participate in the Plan. However, only employees 21 years of age or older with one year of service (as defined by the Plan) are eligible to receive employer contributions to the Plan. In order for a participant to qualify for a year of service, they must complete 1,000 hours of service. The Company may make discretionary contributions in an amount to be determined annually. The Company makes a discretionary contribution of 1% of eligible compensation along with a dollar for dollar matching contribution of up to 2% of eligible compensation. Contributions to the Plan are subject to certain limitations in accordance with federal income tax regulations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of credited service, with a 20% increase every year thereafter until reaching 100% after the fifth year.

1. DESCRIPTION OF PLAN, continued:

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over an agreed upon-period as defined. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. On termination of service for any reason, if the value of the vested benefits does not exceed \$5,000, not counting any rollover contributions, the Company will automatically distribute the balance within one year of termination. Upon proof to the satisfaction of the plan administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rate of 4.25%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

FORFEITED ACCOUNTS

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts are used to reduce future employer contributions and administrative expenses. During the year ended December 31, 2024, employer contributions were reduced by \$83,405 from forfeited nonvested accounts. In addition, the Plan Sponsor used \$915 of forfeitures to pay Plan expenses during the year ended December 31, 2024.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual basis of accounting.

ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from the estimates that were assumed in preparing the financial statements.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments, except for fully-benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements and Note 4 for a discussion on fully-benefit responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants include participant loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

PAYMENTS OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

The Plan paid direct administration fees of \$32,896 during the year ended December 31, 2024. Indirect fees, such as investment management fees, are included in net appreciation on the statement of changes in net assets available for benefits. All other administrative expenses, such as consulting and accounting fees, were paid by the Company.

3. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, all fair value measurements were pooled separate accounts and were reported using Level 2 inputs. The Plan's shares of the pooled separate accounts are determined on an accumulation-unit basis. The fair value of the Plan's pooled separate accounts are based on the underlying assets held within the accounts. Quoted market prices are used to value the underlying investments in the pooled separate accounts. Gains and losses (realized and unrealized) included in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

4. INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan's general insurance account investments are benefit-responsive contracts with American United Life Insurance Company (AUL). AUL maintains the contributions in a general insurance account. The accounts are credited with employer contributions and with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rate is based on the return AUL expects on new investments made by it and held in the AUL general insurance account. When establishing interest crediting rates for these contracts, AUL considers past general account investments adjusted for portfolio turnover and withdrawals for benefit payments. The crediting rate will always equal or exceed the contractually guaranteed rate of 3 percent for the fixed fund. The stable value fund was added as an investment option during 2021, and the contractually guaranteed rate is established on an annual basis based on current market conditions. For 2024, the contractually guaranteed rate for the stable value fund was 1.0 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the Plan sponsor to settle an amount different than contract value paid either within 90 days or over time. As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

6. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by OneAmerica. The prototype plan document has received an opinion letter from the Internal Revenue Service dated November 22, 2017, stating that the written form of the underlying prototype plan document is qualified under Section 403(b) of the Internal Revenue Code (Code) and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 403(b) of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the opinion letter. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTY-IN-INTEREST:

As of December 31, 2024 and 2023, certain investments for the Plan are pooled separate accounts and investment contracts managed by AUL. AUL performs recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the Plan for these services amounted to \$32,896 for the year ended December 31, 2024.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through August 6, 2025, which represents the date the financial statements were available to be issued.

Subsequent to December 31, 2024, the Plan adopted a prototype plan document sponsored by FIS Capital Markets and the Plan was officially restated as of July 28, 2025. The provisions of the Plan disclosed in Note 1 have remained substantially the same.
