## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Lawley Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Lawley Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Lawley Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF PLAN

The following description of the Lawley Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** – The Plan is a defined contribution plan covering most employees of Lawley, LLC and Subsidiaries (the “Company” or “Plan Sponsor”). Employees are eligible to participate in the Plan who are age twenty-one (21) or older and have completed one year of service. Effective January 1, 2024, one year of service was defined as at least 500 hours of service. The Plan contains an automatic enrollment feature upon an employee meeting the eligibility requirements, which begins at 5% and increases by 1% annually, up to 10%. Employees have the option to opt out of automatic enrollment, if desired. The Plan is sponsored and administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Participants may make contributions to the Plan in the form of salary deductions of up to 100% of their compensation. Participant contributions are limited by the maximum allowable contribution under the Internal Revenue Code (the “Code”). Participants may also contribute rollover amounts representing distributions from other defined contribution plans and certain IRAs. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers multiple mutual fund investment options, common collective trust options that invest primarily in guaranteed and other similar investment contracts, and a participant directed brokerage account.

The Company makes contributions for eligible participants in an amount equal to 3% of employee compensation up to a maximum contribution per participant of \$10,350. The Company may also make a discretionary profit sharing contribution and the amount may vary year to year. This contribution is determined at year-end by the Company’s Board of Directors. The Company approved discretionary profit sharing contributions of \$346,670 and \$400,589 for the years ended December 31, 2024 and 2023, respectively. The discretionary contributions are included in employer contributions receivable in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023.

**Participants’ Accounts** – Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, any discretionary Company profit sharing contributions, and all earnings thereon.

**Vesting** – Participant, employer matching contributions and discretionary profit sharing contributions immediately vest 100% to the participant.

**Payment of Benefits** – Distribution of a participant’s vested account balance is permitted without penalty in the event of death, retirement, disability, termination of employment, attaining age 59 ½ or immediate financial hardship, as defined by the Code.

On termination of service due to disability or retirement, a participant may elect to receive a partial or lump-sum amount equal to the value of the participant’s vested account balance. On termination of service due to death, the beneficiary will receive a lump-sum payment. If a participant’s employment terminates, the participant may elect to receive a partial or lump-sum payment, rollover his or her vested account balance to other benefit plans or individual retirement accounts, or maintain the balance in the Plan until reaching retirement age, at which time a payment option may be selected.

## 1. DESCRIPTION OF PLAN (continued)

If a participant's vested account is \$7,000 or less, a participant will automatically receive a lump-sum payment at termination of service provided they do not elect to rollover their account balance.

**Notes Receivable from Participants** – Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, with a minimum of \$1,000. Notes must be repaid within five years unless the note is for the purchase of a primary residence. Interest is charged at the prime rate plus 1% on the date of issuance. Note repayments and interest are directed to the investment funds elected by the participant. All notes are subject to a one-time administrative charge and a quarterly administrative charge that is paid by the participant. Notes bear interest at rates ranging from 4.25% to 9.50% and mature through April 2039.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan has established standards for determining the fair value of assets and liabilities which are subject to reporting at fair value in accordance with accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value:

**Mutual funds:** Valued based on the quoted market price available on an active market, which represents the net asset value ("NAV") of the shares held by the Plan at year end.

**Common collective trusts:** Valued based on the NAV practical expedient of units held by the Plan at year end, and generally have no redemption restrictions or unfunded capital commitments.

**Participant directed brokerage account:** Valued at the closing price reported in the active market in which the underlying securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Costs of administering the Plan are shared by the Company and participants, except for fees related to administering notes receivable from participants, as disclosed in Note 1.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

*Subsequent Events* – Management of the Plan has evaluated the effects of all subsequent events through July 21, 2025, the date which the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

## 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, with the exception of the common collective trusts, which are measured at fair value using the NAV practical expedient. The fair value for the common collective trusts is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

#### 5. PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are in common collective trusts managed by Principal Financial Group and Subsidiaries. As Principal Life Insurance Company, the Plan's custodian, is a member of the Principal Financial Group, these transactions qualify as party in interest transactions.

#### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 7. FEDERAL INCOME TAXES

The Internal Revenue Service has issued a determination letter stating that the Plan is qualified under the provisions of Sections 401(a) and 401(k) of the Code and is therefore exempt from Federal income taxes under Section 501(a) of the Code. The Plan has been amended since receipt of the determination letter.

**7. FEDERAL INCOME TAXES (continued)**

However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Accordingly, there is no provision for income taxes in these financial statements.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has a right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
