We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of the CorEvitas, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General and Plan Termination

The Plan was a defined contribution profit sharing plan covering all employees of CorEvitas, LLC (the “Employer”) upon hire, except residents of Puerto Rico, union employees and non-resident aliens. There were also limitations for entities acquired during the “transition period” as defined (“Participants”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments were participant directed.

On August 13, 2023, the Plan Sponsor was acquired by Thermo Fisher Scientific, an unrelated third party. On March 31, 2024 the CorEvitas LLC 401(k) Plan was amended to freeze future contributions effective March 31, 2024. Per the Division Acquisition Strategy Document prepared by Thermo Fisher Scientific, Inc. confirmed the merger of the Plan into the Thermo Fisher Scientific, Inc. 401(K) Retirement Plan effective May 31, 2024. Accordingly, all plan assets were either transferred or re-registered to the Thermo Fisher Scientific, Inc. 401(k) Retirement Plan at Fidelity Investments on May 31, 2024. As of result of the Plan merger, this Plan was terminated on that date.

Participant Contributions

Participants could defer up to 100% of their annual eligible compensation, as defined by the Plan, subject to dollar limits set by Federal law. Participants who had reached the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Subject to the approval of the Plan administrator, participants could also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

Employer Discretionary Matching Contributions

The Employer could make a discretionary matching contribution of 140% of the amount contributed by a participant, up to a maximum of 7% of the participant’s compensation for each payroll period that the participant contributes a minimum of 5% of their compensation. In order to receive an Employer contribution, a participant must have completed 1,000 hours of service during the Plan year and be employed by the Employer on the last day of the Plan year, unless the employee terminated employment due to death or becoming disabled, or terminated employment after attaining normal retirement age. For the period January 1, 2024 through May 31, 2024, the Employer-elected discretionary contribution amounted to \$644,281, net of forfeitures applied of \$55,000.

The Employer also reserved the right to make a true-up matching contribution based upon the participant’s compensation for the Plan year. There was no true-up matching contribution made in 2024.

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account was credited with the Participant's contributions, allocations of Employer's contributions, as applicable, and Plan earnings/losses, and reduced by direct loan and distribution or administrative expenses associated with certain investment options. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the Participant's vested account.

Vesting

Participants were immediately vested in their rollover and deferral contributions. Unless due to death or becoming totally disabled, a participant became 100% vested in discretionary Employer matching contributions after three years of credited service in accordance with the following schedule:

After 1 Year of Service	33%
After 2 Years of Service	66%
After 3 Years of Service	100%

Forfeitures

The non-vested portion of a participant's account was forfeited as of the earlier of the date on which the participant received a complete distribution of his or her account or the last day of the Plan year in which the participant incurred five consecutive one-year breaks in service. Forfeitures of any non-vested portion of withdrawing participants' accounts were used to offset a portion of the Employer discretionary matching contribution or to pay Plan expenses. During the period January 1, 2024 through May 31, 2024, \$55,000 of forfeitures were used to offset a portion of the 2024 Employer contributions. At May 31, 2024 and December 31, 2023, there were no forfeited non-vested amounts available.

Payments of Benefits

Generally, all distributions were made in a single lump-sum payment. The Plan allowed for in-service withdrawals from the elective deferral accounts of participants who had attained the age of 59½ and all accounts upon retirement age, as defined. The Plan also allowed for hardship distributions to cover immediate and heavy financial needs from a participant's vested account balance (without respect to safe harbor matching account). If a participant's account balance was less than \$5,000, the distribution was in the form of a lump sum, as defined.

Notes Receivable from Participants

Subject to approval by the Plan administrator, a participant could borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms ranged from one to five years (up to ten years for the purchase of a primary residence). The loans were secured by the balance in a participant's vested account and bore interest at a reasonable rate established by the Plan administrator, commensurate with the interest rate charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest were paid ratably through payroll deductions.

Plan Expenses

General operational expenses were charged to the Plan and all other expenses incurred in the administration of the Plan were paid by the Employer.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan were prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments were reported at fair value (except for the fully benefit-responsive investment contract, which was reported at contract value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value was the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period ended in 2024.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Benefits Paid

Benefits were recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan administrator has evaluated subsequent events through June 5, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Custodians

Plan investments were held under a group annuity contract, by the Plan's trustee and custodian, Empower Trust Company, LLC ("Empower Trust") and Empower Annuity Insurance Company of America ("Empower Insurance"). The fair and contract values of all investments as of December 31, 2023, and all investment transactions for the period January 1, 2024 through May 31, 2024, including interest and dividend income and net appreciation, were reported to the Plan and certified as complete and accurate by Empower Trust and Empower Insurance. Information related to notes receivable from participants was also certified by the custodians.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

- Level I* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level II* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Note 4 - Fair Value Measurements (Continued)

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Fully Benefit-Responsive Investment Contract

The Plan invested in Empower Annuity Insurance Company's ("Empower Insurance") Guaranteed Income Fund which is a fully benefit-responsive investment. Empower Insurance maintained the contributions in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The Guaranteed Income Fund was reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less benefits paid and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Note 5 - Fully Benefit-Responsive Investment Contract (Continued)

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The contract value of the funds allocated to the general account with the insurance carrier December 31, 2023 \$396,801. Empower was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate at May 31, 2024 was 0.57%. The average yield for the period January 1, 2024 through May 31, 2024 was 1.41%.

Note 6 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities at December 31, 2023 and through date of merger, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Tax Status

The Plan had adopted the Kenneth D. Anderson Company, Inc. Volume Submitter Profit Sharing Plan with CODA ("Cash or Deferral Arrangement") which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan had been amended since receiving the opinion letter, the Plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan continued to qualify under Section 401(a) and the related trust continued to be tax exempt. Therefore, no provision for income taxes had been included in the Plan's financial statements.

Note 7 - Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

Note 8 - Related-Party Transactions and Party-in-Interest Transactions

Three executives of the Employer served as the Plan's trustees. Certain Plan investments were managed by Empower Trust and Empower Insurance. During the Plan period ended May 31, 2024, \$81,303 of administrative expenses were incurred by the Plan to Empower and other service providers. Notes receivable from participants also qualified as exempt party-in-interest transactions, as defined by ERISA. During the Plan period ended May 31, 2024, the Plan received revenue credits of \$18,339 from Empower and used the entire amount to pay Plan expenses. The revenue credits are reported as other income on the Statement of Changes in Net Assets Available for Benefits.
