Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of The John Gore Organization, Inc. 401K and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a qualified retirement plan sponsored by The John Gore Organization, Inc. (the Company, Employer, or Plan Sponsor) to enable eligible employees to save for retirement. The Plan was effective January 1, 2008. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees become eligible to participate in the Plan upon date of hire and attainment of age 21. Upon becoming eligible, participants are automatically enrolled to contribute 3% of pre-tax annual eligible compensation but may choose to either not participate or change their elective deferral percentage. An employee will enter the Plan on the first day of the month after meeting the service and age requirements.

The following employees are not eligible to participate in the Plan:

- Employees covered by a collective-bargaining agreement, unless the agreement requires the employees to be included under the Plan.
- Leased, temporary, or seasonal employees.
- Part time employees who work less than 1,000 hours for the year ended December 31, 2023. Beginning January 1, 2024, part time employees who worked less than 500 hours per year for the past three consecutive years.
- Nonresident aliens who do not receive any earned income from the Company, which constitutes United States source income.

Reliance Trust Company is the Trustee of the Plan; Automatic Data Processing, Inc. (ADP) is the recordkeeper for the Plan.

Participant Contributions

Participants may elect to defer up to 90% of eligible compensation into the Plan. The total participant contribution in any year is subject to certain limitations of the Internal Revenue Code (IRC). The limit for 2024 and 2023 was \$23,000 and \$22,500, respectively. Contributions may be made to the Plan on a pre-tax and/or after-tax Roth 401(k) basis. Participants may increase, decrease, suspend, or resume their deferral contributions on the first day of each month. In addition, participants who will have attained age 50 or older by the end of the calendar year may make additional catch-up contributions of \$7,500 for both 2024 and 2023.

Employer Contributions

The Company may make discretionary matching contributions equal to a percentage of the participants' contributions, to be determined annually by the Company. Employees are eligible for the discretionary matching contributions upon completion of six months of service. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of \$702,427 and \$668,140, respectively. The Company may also make a discretionary nonelective contribution. The Company made nonelective discretionary contributions of \$27,849 and \$18,120, included in the Employer contributions on the statements of changes in net assets available for benefits, for the years ended December 31, 2024 and 2023, respectively.

Participants can roll over part or all of an eligible rollover distribution they have received from an eligible retirement plan into this Plan as a rollover contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, Employer contributions, an allocation of Plan earnings or losses, and charges for benefits paid. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on the participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, rollovers, and the actual earnings or losses thereon. Vesting in the Employer contribution portion of their accounts is based upon the elapsed time method. Employees are on a three-year vesting schedule (one year - 20%, two years - 50%, and three years - 100%).

Forfeited Accounts

If a participant leaves the Company before becoming fully vested, non-vested Employer contributions, if any, and investment earnings thereon are forfeited. These forfeitures are used to either reduce future Employer contributions or pay reasonable administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,658 and \$54, respectively. In 2024 and 2023, Employer contributions were reduced by \$36,982 and \$6,606 from forfeited non-vested accounts, respectively. Included in the ending 2024 balance is \$11,508 of stale checks, which were not deposited by the intended participants in a timely manner. The Plan is working with the third-party administrator to locate these participants and return the funds, plus earnings, to them.

Notes Receivable from Participants

Participants may borrow from their investment account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 1%. The loans are made for terms not to exceed five years unless the loan is used to acquire a principal residence, in which case the loan may not exceed ten years. At December 31, 2024 and 2023, notes bear interest at a rate of 4.25% to 9.50%. Principal and interest are repaid ratably

through after-tax payroll deductions. A participant may have only one loan outstanding at any given time.

Contributions Receivable

Participant contributions and any related discretionary matching contributions and discretionary nonelective contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

The Plan allows the following types of benefit payments: withdrawals after normal retirement age, hardship withdrawals, withdrawals after age 59½, withdrawals after age 73, and withdrawals of rollover contributions. Withdrawals will be made in lump sums, substantially equal installments or partial withdrawals.

Participants, or in certain cases their designated beneficiary or beneficiaries, may request a distribution of their vested account balances based on any of the following events: death, disability, retirement, minimum required distributions, or termination of employment. Participants' vested account balances will be paid as a non-rollover distribution, a direct-rollover distribution, or a combination non-rollover distribution and direct-rollover distribution. If the value of the participant's account is less than \$7,000 and \$5,000 for 2024 and 2023, respectively, the payment will be made in cash in a single lump sum.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Transaction-based fees are associated with optional services offered under the Plan and are charged directly to the participant's account based on use of a particular Plan feature, such as a Plan loan. Investment-related expenses are included in net appreciation in fair value of investments. Direct compensation paid by the Plan as administrative expenses totaled \$29,153 and \$27,638 for the years ended December 31, 2024 and 2023, respectively, which consisted of third-party administrative fees.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Company deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no amounts allocated to participants who have elected to withdraw from the Plan but have not been paid.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

5. Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - These assets are valued at the daily closing price, as reported by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no assets that were measured at fair value on a non-recurring basis during the years ended December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Company will facilitate the distribution of account balances in single lump-sum payments to each participant until all assets have been distributed in accordance with the Plan documents.

7. Party-in-Interest Transactions

Participant loan and distribution processing fees are paid to Reliance by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Tax Status

Effective June 1, 2019, the Plan adopted the ADP, LLC Prototype Non-Standardized Profit-Sharing Plan with a Cash or Deferred Arrangement (ADP, LLC). The Internal Revenue Service (IRS) has determined and informed ADP, LLC by a letter dated October 6, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Accordingly, the Plan is permitted to rely on the opinion letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

Subsequent events were evaluated by the Plan's management through August 1, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements or disclosures.
