Basis for Opinion

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the DESE Research, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, as defined in the Plan, of DESE Research, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Participation in the Plan is available to employees of DESE Research, Inc. Nonresident aliens and employees under collective bargaining agreements are specifically excluded from eligibility, unless otherwise noted in the Plan documents.

Contributions

Participant Salary Deferral - Participants become eligible on the first day of the month following employment. Each year, participants can contribute up to 100% of their pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants 50 years old or older during the Plan year are eligible to make catch-up contributions, up to maximum amounts established by the IRS. Participants can also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Profit-Sharing - The Company may contribute a profit-sharing contribution in an amount equal to a percentage of eligible compensation declared for the year by the Board of Directors. Contributions are subject to certain limitations and eligibility requirements as defined by the Plan.

Investment Options

Participants direct the investment of their contributions, as well as contributions by the Company, into investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offers registered investment companies as investment options for participants that invest in various combinations of stocks, bonds, and other investment securities. In addition, participants have the option of self-directing their accounts into individual brokerage accounts. The Plan also has a common collective trust fund as an investment option.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the profit-sharing portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants can borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at fixed rates from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator at time of issuance, as defined by the Plan. A loan is considered in default if the missed loan payment is not remitted by the end of the calendar quarter following the calendar quarter in which the required payment is due but not made. Principal and interest are paid ratably through payroll deductions. Loan terms cannot be greater than five years unless the loan is used for purchase of primary residence. The maximum number of loans a participant can have outstanding at any time is two.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants whose vested account balance is less than \$5,000 upon termination will have a period of time as determined by the plan administrator following termination of service to direct the funds in their account to another qualified plan or IRA account, or they may elect to receive a lump-sum cash distribution. If no action to remove the funds from the Plan has been taken by the participant by the end of the period of time set by the plan administrator, then the participants whose vested account balance is less than \$1,000 will receive a mandatory lump-sum cash distribution, and the participants whose vested account balance is between \$1,000 and \$5,000 will have their funds automatically transferred to an IRA account separate from the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$486,187 and \$88,278, respectively. These accounts will be applied first to restore participant forfeitures, and second to reduce future employer contributions. Any excess forfeitures shall be held in a money market fund pending such application. There were forfeitures used to reduce employer contributions of the Plan in the amount of \$76,512 and \$89,463 for years ended December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual method of accounting in accordance with the accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) is included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recognized when paid, usually each pay period. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses were recorded as of December 31, 2024 and 2023. If a DESE participant ceased to make loan repayments, breached any of the borrower's obligation or duties under the loan agreement, or separated from service without repayment of the loan the participant loan would be deemed to be in default with certain allowances for cure. Upon default the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were \$2,708 of excess contributions payable as of December 31, 2024.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan are allocated to the participant's account, in accordance with the Plan document, and are included in administrative expenses. Fees related to the administration of notes receivable from participants and payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Date of Management's Review

Management evaluated subsequent events through August 8, 2025, the date which the financial statements were available to be issued.

Note 3 - Information Prepared and Certified by Custodian

Certain information related to investment disclosures in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the period ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust, the Custodian of the Plan.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the Custodian and furnished to the Plan Administrator.

Reliance Trust certified the completeness and accuracy of \$8,647,751 of net appreciation in fair value of investments, \$2,928,691 of dividend and interest income related to the aforementioned Plan assets, and \$15,466 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued based on the NAV of units held by the Plan at year-end. Although the common/collective trusts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market. The NAV is used as a practical expedient to estimate fair value and would not be used if it is determined to be probable that the Plan would sell these investments for an amount different from the reported NAV. These investments are not included in the fair value hierarchy.

Self-directed Brokerage Accounts: Accounts primary consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Note 5 - Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of registered investment companies managed by Reliance Trust Company. Reliance Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator of \$88,544 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax Status

The IRS has determined and informed the document sponsor by a letter dated October 6, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization took a significant uncertain position that more likely than not would not be sustained upon examination. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
