Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of the Yale Appliance 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Yale Appliance 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1 – Description of the Plan

The following brief description of the Yale Appliance 401(k) Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Yale Appliance, Inc. (the “Sponsor”), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Sponsor is the Plan Administrator. In general, the Plan Administrator manages the operation of the Plan, subject to the terms and provisions of the Plan. Reliance Trust Company is the trustee of the Plan's assets.

Eligibility

Employees of the Plan Sponsor generally become eligible to participate in the Plan after completing two months of service and having reached the age of 21.

Contributions

Participants may contribute up to 90% of their compensation on a pre-tax or after-tax Roth basis, subject to Internal Revenue Code (“IRC”) limitations. Participants who are at least age 50 may make additional catch-up contributions subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan (“rollover contributions”), subject to certain requirements.

The Plan Sponsor contributes a safe harbor matching contribution equal to 100 percent of the first three percent of the participant's salary deferral and 50 percent of the next two percent of the participant's salary deferral.

The Plan Sponsor may make discretionary profit-sharing contributions in an amount to be determined annually by the Plan Sponsor. Participants must complete one year of service and earn at least 500 hours of service during the Plan year or be employed on the last day of the Plan year to be eligible. There were no discretionary profit-sharing contributions in 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Plan Sponsor safe harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service in their discretionary contributions.

Notes to Financial Statements

Notes receivable from participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. A participant may only have one loan outstanding at any time. The loans are secured by the participants' vested interest in the Plan and, as of December 31, 2024, bear interest at rates ranging from 4.25% to 9.50% and maturities through September 2029. Participants may have only one loan outstanding at any one time. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of employment for any reason, including retirement, a participant's vested account is generally distributed either in a single lump-sum payment or in installments over a period of time. Participants who are still employed may withdraw their vested accounts upon attaining age 59-1/2. If the termination is before the normal or early retirement dates and is for a reason other than death or disability and the vested balance is \$1,000 or less, the entire balance will be distributed. For retired participants, the latest commencement date for distributions is April 1 of the calendar year following the year in which the participant attains age 72. A participant may request withdrawal from their account in the case of hardship as defined in the Plan document.

On December 29, 2022, the Internal Revenue Code 401(a)(9) was amended to increase the age at which minimum distributions would be required to age 73 starting on January 1, 2023 and later to age 75 starting January 1, 2033.

Forfeited accounts

Non-vested forfeited participant accounts are used first to pay administrative expenses. Any remaining forfeitures are used to reduce Plan Sponsor contributions to the Plan.

Note 2 – Summary of significant accounting policies

Method of accounting

The Plan maintains its accounting records and prepares its financial statements and supplemental schedule on the accrual basis.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results may differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See discussion under Fair Value Measurements for a description of valuation methodologies used for assets measured at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Gain or loss on sales of investments is based on average cost. Interest income is recorded, as earned, on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits which consist of the realized gains or losses and the unrealized appreciation and depreciation on those investments.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Allocations to participants' accounts

Individual accounts are maintained for each participant, which are separated into the various investment fund components and a participant loan component, if the participant has an outstanding loan. Separate accounts are also maintained for rollover, matching and discretionary profit-sharing contributions.

Income for each fund is allocated to each participant's account monthly in proportion to each participant's account balance. The income allocation is based on the actual monthly yield for the Plan.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Note 4 – Fair value of investments

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Note 5 – Plan termination

Although the Sponsor has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of ERISA. If the Plan is terminated, all participants would become 100% vested in the discretionary contributions.

Note 6 – Income tax status

The IRS has determined and informed the Sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by the Federal and State tax authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 – Related parties

Affiliates of the trustee manage investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with the recordkeeping services qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

Note 8 – Subsequent events

The Plan has evaluated subsequent events and transactions through August 5, 2025, the date the financial statements were available to be issued. There were no subsequent events or transactions requiring recognition or disclosure in the financial statements.
