Independent Auditor's Report

To the Plan Trustees
Gaylor Electric, Inc. Employee Benefit Plan

Opinion

We have audited the accompanying financial statements of Gaylor Electric, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Gaylor Electric, Inc. Employee Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with the modified cash basis of accounting.

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of Gaylor Electric, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was organized effective January 1, 1989, to provide certain health and other benefits covering substantially all employees of Gaylor Electric, Inc. (the Employer), who have at least satisfied an initial eligibility period of 60 days, and their covered dependents. The effective start date is the 1st of the month following satisfaction of all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees (appointed by the Board of Directors) are responsible for oversight of the Plan, serve as the Plan Administrator and report to the Board of Directors.

Contributions: Participants make contributions to the Plan based on monthly premiums for benefits they have elected. Participant contributions are primarily made through payroll deductions. The Employer is required to make contributions to provide the Plan with sufficient funds to pay all health and other benefits eligible under the Plan, and the expenses of administering the Plan.

Certain participants are employed under the terms of certain government contracts and are eligible for supplemental contributions pursuant to the Davis-Bacon Act (and related laws). This legislation mandates minimum wage and benefit levels for affected employees. The Employer contributes the difference between minimum fringe benefits and actual fringe benefits received to Gaylor Electric, Inc. 401(k) Profit Sharing Plan sponsored by the Employer.

Benefits: The Plan provides health and welfare benefits which include medical, prescription drug, vision, dental, individual short-term disability, group long-term disability, group critical illness, group accident, whole life insurance, term life insurance, and AD&D insurance to employees of the Employer and their covered dependents.

Medical, prescription drug, and dental benefits are self-insured. Effective January 1, 2024, short-term disability benefits are fully insured after previously being self-insured. All other benefits are also fully insured.

The Plan also provides continuation of certain benefits upon termination of employment or loss of coverage in certain circumstances through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan's participants and their dependents are protected from catastrophic medical claims through the Plan's purchase of a stop-loss insurance policy, which covers claims in excess of specified amounts on an annual individual basis and on an annual aggregate basis.

Cash Accounts: The Plan's cash is maintained in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses related to these accounts.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan Trustees are required to compute the value of the trust and will retain, distribute or transfer the assets. No part of the corpus or income can be used for the benefit of the Employer.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and interest income are recognized when received, rather than when earned, and benefits and expenses are recognized when paid, rather than when the obligation is incurred. Although the modified cash basis represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the requirements of ERISA.

Estimates: The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Claims submitted for participants and their dependents and beneficiaries involving medical, prescription drug, and dental benefits are processed by the Plan's various third-party administrators. However, the responsibility for payments to participants and providers is retained by the Plan.

Benefits are recorded when paid.

Refunds and Rebates: Refunds and adjustments related to claims paid and rebates related to prescription drug usage are recorded as reductions in health and welfare claims paid (net) in the statement of changes in net assets available for benefits.

Benefit Obligations: Claims incurred but not reported at December 31, 2024, are computed at the present value of estimates based on the Plan's experience. Generally, claims are reported to and paid by the Plan within one year after incurred dates. See Note 3.

Plan Expenses: Administrative expenses for maintaining the Plan are paid by the Employer or by the Plan, at the Employer's discretion.

Tax Status: The Trust established under the Plan to hold the Plan's assets is intended to qualify as a tax-exempt trust, pursuant to Internal Revenue Code (IRC) Section 501(c)(9). Accordingly, the trust's investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated February 9, 1990. The trust has been amended since receiving the tax determination letter. The Plan Administrator believes that the trust, as amended, continues to qualify in accordance with the applicable provisions of the IRC.

The Plan is subject to routine audits by taxing authorities. The Plan is currently under examination by the U.S. Department of Labor's Employee Benefits Security Administration.

Subsequent Events: The Plan Administrator has evaluated the financial statements for subsequent events occurring through August 4, 2025, the date the financial statements were available to be issued. See Note 5.

NOTE 3 - BENEFIT OBLIGATIONS

Plan obligations for claims payable and claims incurred but not reported for self-insured benefits are estimated to be \$444,000 and \$498,000 at December 31, 2024 and 2023, respectively.

Amounts contributed by the Employer and participants to Health Savings Accounts (HSAs) for certain participants who elect coverage with high deductibles are made to accounts owned by each participant. Those account balances are not Plan assets. The Plan has established individual participant accounts at Optum Bank, Inc., the custodian for the HSAs. During 2024, total Employer and participant HSA contributions were \$208,003 and \$928,957, respectively.

NOTE 4 - PLAN AMENDMENTS

The Plan's Summary Plan Descriptions and insurance contracts are updated annually to reflect changes in the tax laws and changes in the schedule of benefits, including co-pays, deductibles, out-of-pocket expenses and covered services. See Note 1.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

UMR Insurance Companies (UMR), a subsidiary of UnitedHealth Group Inc., is the Plan's third-party administrator for the processing of self-funded medical claims. Prior to January 1, 2025, True Rx Management Services, Inc., d/b/a True Rx Health Strategists (True Rx) was the Plan's third-party administrator for the processing of self-funded prescription drug claims. Delta Dental Plan of Indiana, Inc. (Delta Dental) is the Plan's third-party administrator for the processing of dental claims. During 2024, administrative expenses paid by the Plan to UMR, True Rx, and Delta Dental totaled \$662,510, \$119,573, and \$53,662, respectively.

Effective January 1, 2025, MedImpact Healthcare Systems, Inc. (MedImpact) is the Plan's third-party administrator for the processing of self-funded prescription drug claims.

Quantum Health, Inc. (Quantum) administers a care coordination plan by incorporating care management, advocacy, communication, and other services to Plan participants. During 2024, administrative expenses paid by the Plan to Quantum totaled \$346,817.

Benefit Technology Resources, LLC (BTR) administers and monitors information within the Plan's benefits management software. During 2024, administrative expenses paid by the Plan to BTR totaled \$115,015.

Prior to June 1, 2024, BASIC administered the Plan's COBRA benefits. Effective June 1, 2024, Employee Benefits Corporation (EBC) administers the Plan's COBRA benefits. During 2024, administrative expenses paid by the Plan to BASIC and EBC were \$3,484 and \$3,617, respectively.

Effective January 1, 2024, The Standard provides insurance policies for short-term and long-term disability and life insurance benefits and receives insurance premiums from the Plan. The Employer administers the Plan's short-term and long-term disability and life insurance benefits at no cost to participants.

Effective January 1, 2024, The Standard also provides insurance policies for supplemental and dependent life and accidental death and dismemberment benefits, as well as supplemental critical illness, short-term disability, accident, and hospital indemnity benefits. Participants pay premiums for coverage under these voluntary benefits.

Anthem Insurance Companies, Inc. (Anthem) provides insurance policies for vision coverage. Participants pay premiums for coverage under these voluntary benefits.

Effective January 1, 2024, Unum Life Insurance Company of America and Provident Life and Accident Insurance Company provided insurance policies for supplemental whole life benefits. Participants paid premiums for coverage under these voluntary benefits. Effective January 1, 2025, supplemental whole life benefits are no longer offered by the Plan.

The Employer provides certain accounting and administrative services to the Plan for which it receives no compensation.

NOTE 6 - STOP-LOSS INSURANCE CONTRACT

Under a contract with an insurer, self-funded health claims for participants and their dependents for the 2024 Plan year in excess of \$250,000 per participant on an annual basis, plus a split funded liability (i.e. an aggregating specific deductible) of \$465,000 on an annual basis, are reimbursed to the Plan by the insurer. Aggregate annual claims in excess of \$10,636,098, as defined, are reimbursed to the Plan by the insurer.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan Trustees may change the benefits and provisions of the Plan to increase, reduce or eliminate benefits as the Plan's participants are not vested in the Plan's benefits.
