### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of The Harvard Management Company 403(b) Tax-Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of The Harvard Management Company 403(b) Tax-Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### General

The Plan is a defined contribution plan covering all employees of Harvard Management Company, Inc. (the Company) with retirement benefits in accordance with Section 403(b) of the Internal Revenue Code (the Code). All employees are eligible for participation in the Plan on their first day of employment.

#### Contributions and Vesting

Participants may defer pre-tax contributions to be made to the Plan through reduction of their compensation in amounts up to 100% of their eligible compensation, subject to certain limits under the Code. Participants who are projected to be age 50 or older by the end of the calendar year and who are making pre-tax contributions to the Plan may also make additional "catch up" pre-tax contributions, subject to limits under the Code. Rollovers from qualified plans are permitted as well as Roth deferral contributions. The Plan does not offer an employer match contribution.

Participants are vested immediately in their contributions plus actual earnings on the contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Any active employee may apply for a loan in an amount limited to the lesser of \$50,000 or one-half of the participant's vested interest in their account, with a minimum of \$1,000. Only one loan may be outstanding at a time.

All loans made are considered a directed investment from the account(s) of the participant maintained under the Plan. As such, all payments of principal and interest made by the participant are credited only to the account(s) of such participant. The repayment of existing loans outstanding is received monthly through direct after-tax payroll deductions. Upon termination of employment or withdrawal from the Plan, outstanding notes receivable from participant's balances are treated as benefit distributions. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **Administrative Expenses**

Certain administrative expenses are paid by the Plan.

### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or monthly, quarterly or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at the closing price reported by the fund sponsor from an actively traded exchange.

#### 4. Party-in-Interest Transactions

The administrative expenses paid by the Plan for 2024 were \$17,799 and qualify as party-in-interest transactions as they are related to recordkeeper fees and investment advisor fees incurred by the Plan. In addition, notes receivable from participants also qualify as party-in-interest transactions.

#### 5. Income Tax Status

The Plan sponsor adopted a volume submitter 403(b) plan which received a favorable advisory letter dated January 2, 2018. The plan administrator believes the Plan is currently being operated in compliance with the terms of the Plan and the Code and remains qualified under the Code and applicable regulations and, as such, is exempt from taxes as of the financial statement date.

#### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
