As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

OCTOBER 31, 2024 AND 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of LaBella Associates, P.C. Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of LaBella Associates, D.P.C. (the “Company”). The minimum age requirement is 18 years for entrance into the Plan. Employees are eligible to participate in the Plan on the first day of the month coinciding with, or the next month following, the date the service requirements are met. The service requirement is met when the employee has three consecutive months of service. Effective November 1, 2024, the service requirement is no longer required for entrance into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are entitled to defer up to the maximum amount or percentage allowed of their annual compensation, as defined in the Plan, as a qualified pre-tax contribution subject to maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a matching contribution of a discretionary percentage of the participant’s salary provided that the participant is actively employed on the last day of the plan year and has completed at least 1,000 hours of service during the plan year. Effective November 1, 2024, the hours of service requirement was reduced to 520 hours. The Company also has the option of making annual discretionary profit sharing contributions to the Plan.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s match, (b) the Company’s discretionary profit sharing contribution, (c) plan earnings and (d) administrative expenses. Allocations of the Company’s discretionary contributions are based on individual participants’ deferrals for the year in relation to total deferrals of all participants for the year. Allocations of plan earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant loans

Participants are permitted to borrow up to 50% of the vested balance in their plan accounts to a maximum of \$50,000. Participant notes receivable are measured and valued at their unpaid principal balance. The loans are payable over terms up to five years (longer if for the purchase of a principal residence) and bear interest at a fixed rate. The fixed interest rate is derived from the prime rate of interest plus 1% at origination. Principal and interest payments on the loans are redeposited into the participants’ accounts based on their current investment allocation elections. Interest rates on participant loans range from 3.25-9.50% and expire at various dates through January 2050.

Payment of benefits

A participant's entire interest in the plan is payable upon death, disability, or attainment of normal retirement age, at age 65. A participant may elect to receive a lump-sum amount, equal installments, or partial withdrawals equal to the vested portion of the participant's account. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Vested account balances that are less than \$5,000 upon separation of service will be paid in one lump-sum distribution paid directly to the participant in accordance with the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully vested in Company contributions plus actual earnings thereon after three years of service. A participant receives credit for a year of service if they complete at least 1,000 hours of service during the plan year.

Forfeited accounts

Any forfeitures arising under the Plan are applied against the Company's matching and profit sharing contributions. There were unallocated forfeiture balances of \$61,690 and \$1,362 at October 31, 2024 and 2023, respectively. There were \$41,928 and \$38,583 of forfeitures applied during the years ended October 31, 2024 and 2023, respectively.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements and supplemental schedule have been prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Generally, contributions, investment earnings and participant note interest are recorded as received and benefits and administrative fees are recorded as paid.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Mutual funds are valued at the net asset value multiplied by the number of shares held by the Plan at year end. The net asset value is determined using quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the modified cash basis. Capital gain distributions are included in net appreciation or depreciation in fair value of investments.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through August 12, 2025, which is the date the financial statements are available to be issued. See Note A.

NOTE C: CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and participants notes receivable held at October 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and participant notes receivable interest for the year ended October 31, 2024, including the adjustment to notes receivable from participants, as disclosed in Note J was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE D: FAIR VALUE MEASUREMENTS

The modified cash basis of accounting requires enhanced disclosures about investments that are measured and reported at fair value. The modified cash basis of accounting establishes a hierarchal disclosure framework which prioritizes and ranks the level of market price observance used in measuring investments at fair value. Market price observability is affected by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Money market fund: Valued at cost plus accrued interest, which approximates fair value.

Mutual funds: Valued at the quoted prices in active markets on which the individual securities are traded.

Common/collective trust: Valued at the net asset value ("NAV") of units of common collective trust held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The common collective trust generally permits redemptions daily. There are no unfunded commitments at October 31, 2024 and 2023. If the funds experience periods of insufficient liquidity then the common collective trust may defer honoring any payment request until liquidity is sufficient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: TAX STATUS

The Plan obtained a determination letter on October 6, 2020, in which the Internal Revenue Service stated that the non-standardized pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE E: TAX STATUS, Cont'd

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would immediately become 100% vested in their accounts and their accounts will be paid to them as provided for in the Plan document.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H: PARTY-IN-INTEREST TRANSACTIONS

The Plan considers "prohibited transactions" as reportable party-in-interest transactions. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Except as noted in Note B, the Plan had no other reportable party-in-interest transactions.

NOTE I: PLAN TRANSFER

On October 1, 2020, the Company acquired 100% of the common stock of Highland Technical Services, Inc. ("HTSI"). Effective January 1, 2022, the employees of HTSI became employees of the Plan Sponsor and were eligible to participate in the Plan on that date. The HTSI Retirement Plan was terminated effective July 31, 2024. Plan assets totaling \$1,289,708 were transferred to the LaBella Associates, P.C. Profit Sharing and 401(k) Plan on July 17, 2024. The transfer is reflected as an addition to net assets in the accompanying statement of changes in net assets available for benefits - modified cash basis.
