Note 1. Description of Plan

The following description of the Mid-Atlantic Permanente Medical Group, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that is open to all employees who are shareholders or shareholder track physicians and administrative staff of the Mid-Atlantic Permanente Medical Group, P.C. (“Group”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participant Contributions

Each year, participants may contribute up to 50% of compensation on a pre-tax and/or Roth basis and 25% of compensation for after-tax contributions, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans and certain individual retirement accounts. Contributions are subject to certain limitations.

Employer Contributions

As in prior years, the employer contributions were made as a percentage based on physician category and salary. Employer contribution of 5% of base and incentive pay was made per pay period to all physicians, up to plan maximums and subject to a 5-year vesting schedule. All employer contributions are allocated to participant’s investment accounts in the same manner as their participant contributions.

Administrative staff employees who have completed two years of service are eligible for a 5% employer contribution. Such contributions are made each pay period and represent 5% of the employee’s gross wages. Amounts are automatically allocated to participant’s investment accounts in the same manner as their participant contributions.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, common collective trust funds including a stable value common collective trust fund and a self-directed brokerage account. Participants may utilize an individual self-directed brokerage option, through which participants are able to invest in a variety of securities including stocks, bonds, mutual funds and government securities in accordance with the Plan document.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Group’s contributions, plan earnings (losses) and rebates of investment management revenue sharing, and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and, when applicable, unrelated business income taxes. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants, with exception of physicians hired after December 31, 2009, are 100% vested immediately in their contributions and the Group’s contributions, plus actual earnings thereon. Physicians hired after December 31, 2009 will vest in the Group’s contribution over a five-year period.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$100,000 or 50% of their vested account balance. The loans are secured by the balance of the participant's accounts and bear interest at rates which are commensurate with local prevailing rates for similar loans. At December 31, 2024, outstanding loans bore interest rates of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, retirement, death, disability, or attainment of age 59½, a participant or their beneficiary, in the event of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or installment payments. Amounts contributed on a before-tax basis may be withdrawn upon demonstration disability or after the participant reaches the age of 59½ years. Amounts contributed may be withdrawn upon the demonstration of financial hardship. Hardship distributions are available from vested balances with limitations specified in the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts were \$62,326 and \$25,009, respectively. During 2024, \$721,418 was used to reduce Group contributions and \$142,442 was used to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date-basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by the Group, as provided by the Plan document. Certain administrative functions are performed by employees of the Group. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Revenue Credit Account

The plan has a revenue credit account which provides rebates to participants. These rebates are allocated to individual participants quarterly to reduce plan expenses charged. During 2024, the total rebate allocated to individual participant accounts totaled \$451,390.

Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists; therefore, requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common Collective Trust Fund and Stable Value Common Collective Trust Fund

The Plan invests in common collective trust funds and stable value collective trust funds for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (“NAV”) provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12-months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

Self-Directed Brokerage Accounts

Accounts primarily consist of mutual funds, and common stocks and bonds. Mutual funds and common stocks are valued on the basis of readily determinable market prices. Bonds are generally valued using pricing models maximizing the use of observable inputs for similar securities.

Note 4. Certification of the Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Exempt Party-in-Interest Transactions

Certain plan assets are invested in funds managed by Fidelity Management Trust Company ("Fidelity") or its affiliate. Fidelity is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity or its affiliates by the Plan for participant-initiated transaction fees and investment management were \$478,715 for 2024. Other fees for investment management services were paid and included as a reduction of return earned on each fund.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Group has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

Note 7. Tax Status

The Internal Revenue Service (the “IRS”) has determined and informed the Group by letter dated December 4, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of the risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
