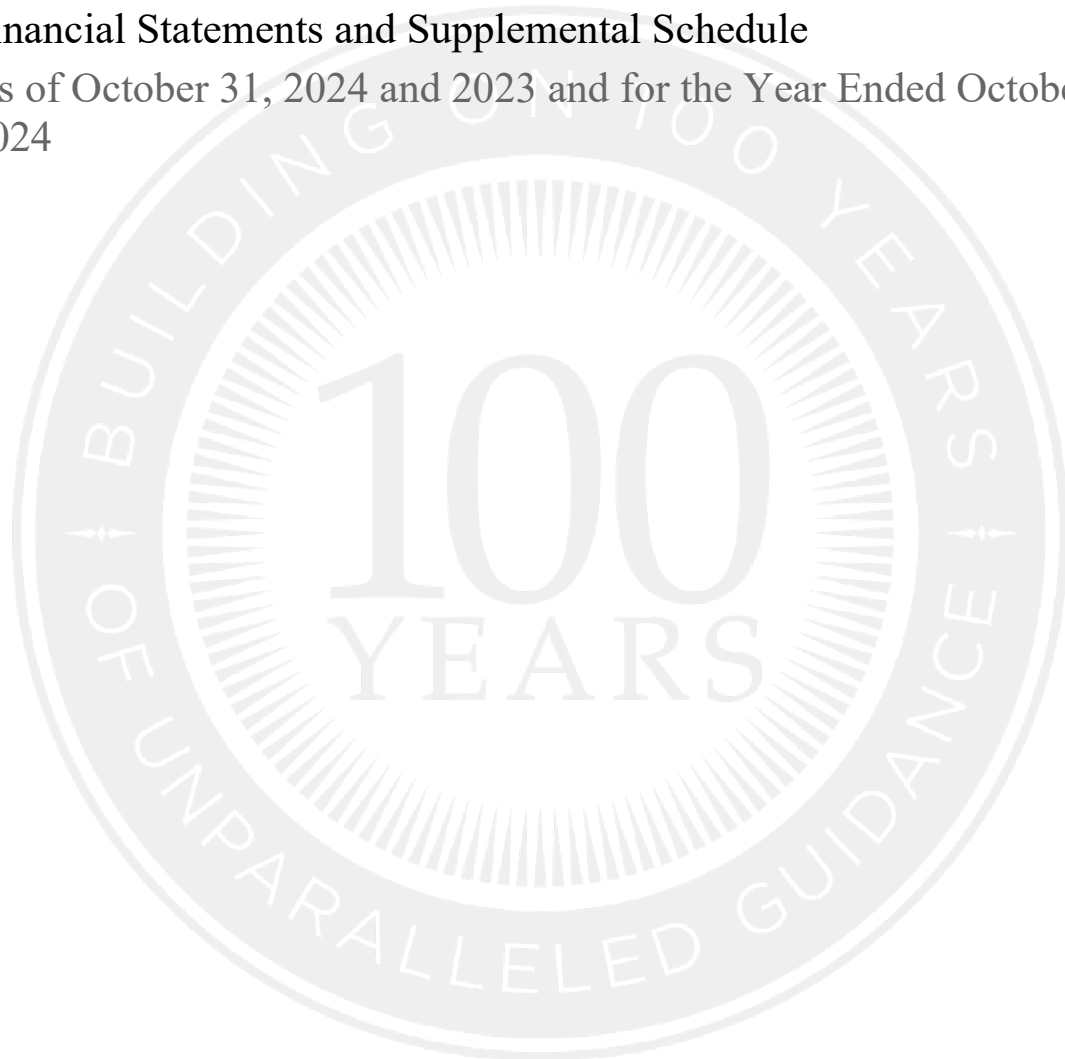

Independent Auditor's Report

To the Investment Committee of Kayem Foods Employees 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kayem Foods Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of October 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of

management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

As of October 31, 2024 and 2023 and for the Year Ended October 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Kayem Foods Employees 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all non-union eligible employees of Kayem Foods, Inc. (the “Company,” “Plan Administrator,” or “Plan Sponsor”). The Plan was established effective August 22, 1962 and amended on March 6, 2024 to adopt the current adoption agreement. The Plan is subject to the Internal Revenue Code of 1986 (“IRC”), as amended, and the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective March 6, 2024, the name of the Plan was changed from Kayem Foods, Inc. Employees Retirement Plan to Kayem Foods Employees 401(k) Plan.

The Plan changed its trustee from Newport Trust Company, LLC to Fidelity Management Trust Company and its recordkeeper from Newport Group, Inc. to Fidelity Workplace Services, LLC, effective March 6, 2024.

Eligibility

Employees become eligible to participate in the Plan on the first day of the month following attainment of age 18 and completion of sixty days of service. At such time that employees are eligible to participate, they are also eligible for employer matching contributions.

Participant Contributions

Participants may elect to defer and contribute to the Plan eligible compensation up to the maximum amount allowed by the IRC.

The Plan provides for auto-enrollment and deferral rate auto-increase features for any participants that do not make an affirmative election to opt out of these features. The auto-enrollment provision applies only to newly eligible employees and provides that unless an employee makes an affirmative election, the individual will be enrolled at a 3% deferral rate. The deferral rate auto increase is at a rate of 0.50% annually up to a maximum of 10% of compensation and applies to all eligible individuals.

Employer Contributions

For the year ending October 31, 2024, the safe harbor matching contributions made by the Plan Sponsor are calculated as 100% of the first 3% of the eligible participant's compensation contributed to the Plan and 50% of the next 2% of the eligible participant's compensation contributed to the Plan. All safe harbor matching contributions are 100% vested at the date of the contribution. The employer contributions are presented net of forfeitures in the statement of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, Company matching contributions, participant's rollover contributions, and allocations of the Plan's earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollovers

With the approval of the Plan Administrator, the Plan may receive any amounts received by an employee as a distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

Vesting

Participants are immediately vested in any safe harbor employer contributions and their voluntary contributions plus actual earnings thereon. The employer may make discretionary matching contributions in which participants vest ratably at 25% per year over a four-year period starting with the participant's second year of employment. There were no discretionary matching contributions made during 2024.

Forfeitures

Forfeitures represent the non-vested portion of terminated participants' account balances. These amounts are applied to reduce employer matching contributions to the Plan. During the year ended October 31, 2024, there were no forfeitures used to fund employer matching contributions. The amount of unallocated forfeitures at October 31, 2024 and 2023 was \$311 and \$0, respectively.

Investments Elections

Participants direct the investment of their accounts and may select from a selection of mutual funds and a common/collective trust. Each participant has the ability to change their investment allocations at any time.

Notes Receivable from Participants

The Plan permits its participants to obtain loans against their respective account balances. Plan participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans bear an interest rate of 1% plus the effective prime rate at the time the loan is requested. Loans are repaid through salary deferrals in equal installments, and the term of a loan may not exceed five years, unless the loan is for the purchase of a principal residence. A participant may have only two outstanding loans at a time. Certain restrictions apply to loans, as defined in the plan document.

Administrative Expenses

Administrative expenses related to Plan's investments and recordkeeping are paid by the Plan and all other administrative expenses are paid by the Plan Sponsor.

Payment of Benefits

Withdrawals may be made from a participant's account at retirement, death, disability, termination of employment, or financial hardship. The participant's vested account will be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in a single lump-sum payment. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. Withdrawals from salary deferral portions of the Plan may be made from the participant account based on financial hardship in accordance with rules promulgated by the Internal Revenue Service ("IRS") and the Plan document. Participants over age 59 ½ may elect to withdraw all or a portion of their account balances.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that effect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent loans are recorded as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at the value reported to the Plan by Fidelity Management Trust Company (the "Trustee") and Newport Trust Company, LLC, the former trustee. The value reported by the trustees represents fair value. See Note 3 for a discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to the participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid directly by the Company and are excluded from these financial statements. Administrative fees charged to the Plan as shown on the statements of changes in net assets available for benefits relate to fees charged to the participants for recordkeeping and information management or participant loan processing that are deducted from their asset balances. Investment related expenses are included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Valuation is based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using unobservable inputs to pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

In certain cases, inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact business at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. The NAV is based on a compilation of primarily readily observable market information. If current market prices are not readily available, the underlying securities are valued in good faith by the Trustee.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of October 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended October 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and Newport Trust Company, LLC, qualified institutions. Effective March 6, 2024, the Plan changed its qualified institution from Newport Trust Company, LLC to Fidelity Management Trust Company.

Fidelity Management Trust Company also certified the information included in the Schedule of Assets (Held at End of Year).

5. TAX STATUS OF THE PLAN

The Plan has obtained its latest determination letter on June 30, 2020 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan as amended is qualified and is tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to October 31, 2021.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity. Fidelity Management Trust Company is a trustee for the Plan and Fidelity Workplace Services, LLC is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan and its participants are directly charged for certain administrative expenses by a third party administrator. Notes receivable from participants also qualify as party-in-interest transactions.

Prior the change in trustees, Plan investments included mutual funds managed by iCapital, a related party to Newport Trust Company, LLC. Fees paid for investment management, custody and recordkeeping services are included as a reduction of the investment return earned by each investment.

Fees paid by the Plan to related parties amounted to \$156,691 in 2024.
