INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
D&H Contracting, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of D&H Contracting, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D&H Contracting, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTE 1 – PLAN DESCRIPTION

The following description of the D&H Contracting, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

D&H Contracting, Inc. (the Company) established the Plan, a defined contribution plan, effective August 1, 2021. The Plan is designed to comply with the Internal Revenue Code of 1986 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Administrator is responsible for oversight of the Plan. The Plan Sponsor, as the investment fiduciary, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

An employee is eligible to participate in the Plan upon completion of six months of service and upon reaching age 18.

Contributions

Elective deferrals are limited by the Plan according to IRC sections 401(k), 402(g), 404 and 415 to a set amount each year. For 2024 that amount is \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows quarterly entry dates on January 1st, April 1st, July 1st and October 1st of each year.

The Company's safe harbor matching formula is 100 percent of the first 3 percent and 50 percent of the next 2 percent of base compensation that a participant contributes to the Plan, with a maximum match of 4 percent. The Company may also make non-elective contributions, an amount to be determined from year to year. Participants are eligible to receive an allocation if he or she has completed 1,000 hours of service during the applicable Plan year and is employed by the Company on the last day of the year.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions, Company safe harbor matching contributions, and non-elective contributions, plus actual earnings thereon.

Loans to Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, with interest rates determined quarterly at 1% above the prime rate, as defined by the Plan. Loans generally must be repaid within five years. Principal and interest are repaid ratably through payroll deductions.

Payment of Benefits

On termination of service due to reasons other than death, a participant may receive the value of the vested interest in their account as a lump sum distribution. For termination of service due to death, a participant's account must be fully distributed by December 31st of the calendar year following the fifth anniversary of the participant's death, unless the participant's beneficiary chooses to receive distributions in accordance with other provisions of the Plan. Required minimum distributions are made to certain participants in the absence of other distribution elections.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$66 and \$62, respectively. These accounts may be applied to offset plan expenses, reduce future employer matching contributions, or reduce future employer non-elective contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review and Subsequent Events

Subsequent events were evaluated through August 13, 2025, which is the date the financial statements were available to be issued.

Subsequent to the Plan year end, the Company was informed that the fidelity bond purchased did not meet the qualifications for proper fidelity bond coverage. On July 30, 2025, the Company increased coverage to \$220,000 to correct the oversight.

NOTE 3 – FAIR VALUE MEASUREMENT

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were

not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the money market fund is based on the daily closing price as reported by the fund. The money market fund is registered with the Securities and Exchange Commission and deemed to be actively traded.

NOTE 4 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

All Plan investments are shares of mutual funds or money market funds managed by Centennial Bank. Centennial Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. American Trust provides administrative and recordkeeping services to the Plan. Fees paid by the Plan for the services amounted to \$12,984 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will be fully vested in their entire balance under the Plan.

NOTE 6 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed CCH Incorporated, the Pre-Approved plan provider, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Pre-Approved Plan has been amended since receiving the determination letter to comply with the requirements of the Consolidated Appropriations Act, 2021, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
