To the Management Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Apache Mills, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of Plan

The following description of Apache Mills, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a safe-harbor, defined contribution plan that allows employees of Apache Mills, Inc. (the "Company") to make tax-deferred contributions through voluntary payroll withholdings in order to accumulate benefits to be paid upon retirement. Employees age 21 and older are eligible to enter the plan after 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company directors are responsible for oversight of the Plan.

Contributions:

Employees who elect to enroll in the Plan may elect to have up to 100% of their pre-tax gross pay contributed to their account each pay period. Roth contributions are also accepted. These deductions may not exceed the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides a safe harbor matching contribution of 100% of deferrals up to 3% of compensation plus 50% of deferrals over 3% that do not exceed 5% of compensation. Additional discretionary profit sharing amounts may be contributed. There were no discretionary profit sharing contributions made for 2024.

Note 1. Description of Plan (continued)

Participant accounts:

Each participant's account is credited with the participant's contribution, Company matching contributions and the participant's allocation of the Company's contributions and is reduced for loans, withdrawals, and benefit distributions. All of the Plan's investment options are fully participant directed. Upon enrollment in the Plan, a participant may direct company and employee contributions into any of the Plan's investment options. Participant accounts are further credited or charged with their pro rata share of earnings or losses of the total investments in each investment account and their share of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Employees participating in the Plan are eligible to receive a benefit upon their normal retirement date, early retirement date, or disability retirement date equal to the amount in their individual accounts. Participant's voluntary contributions and the Company safe harbor contributions are always 100% vested as well as the earnings on those accounts. Vesting in the Company's discretionary non-safe harbor matching contribution accounts and profit sharing contribution accounts are based on years of service with the Company. A participant is fully vested after six years of service or the reaching of the normal retirement age.

Forfeited accounts:

Upon termination of employment, participants forfeit their nonvested balances. Overfunded employer safe harbor matching contributions determined via true-up calculations are also transferred from participant accounts to the forfeiture account. These forfeited balances are used to reduce future company contributions or pay plan expenses. Unallocated forfeiture balances as of December 31, 2024 and 2023 totaled \$29,109 and \$94,801, respectively. \$73,465 of forfeitures were used in 2024.

Note 1. Description of Plan (continued)

Notes receivable from participants:

Notes receivable from participants are valued at cost, which approximates fair value. Participants are eligible to borrow from their vested account balance in accordance with the Plan's provisions. The maximum amount of any note receivable is the lesser of a) \$50,000, or b) 50% of the participant's vested balance. Note receivable terms range from one to five years or up to fifteen years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant or designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may also make a hardship withdrawal from all contribution types in the event of severe financial need. A participant may make a withdrawal from his or her accounts while still employed by the company upon reaching the age of 59 1/2.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Investment Committee determines the Plan's valuation policies. See Note 9 for discussion of fair value measurements.

Note 2. Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating expenses:

Substantially all of the administrative expenses of the Plan are paid directly by the company and are excluded from these financial statements. Certain fees, such as fees related to the administration of notes receivable from participants, managed account fees for investments, and fees for distribution of benefits, are paid by the Plan and charged directly to the participants' accounts.

Indirect fees paid from insurance company pooled separate accounts in which the plan invests are charged against the separate accounts and reflected in the fund's return or the separate account's return. Sub-transfer agency fees, 12b-1 distribution fees, management fees and separate account charges are some examples of indirect compensation received by various services providers.

Notes receivable from participants:

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits:

Benefits paid to participants are recorded upon distribution.

Use of estimates:

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Related Party Activity

All plan investments are investments managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, who are the custodians as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Empower Annuity Insurance Company of America and affiliates received direct compensation of \$28,819 during the year ended December 31, 2024.

Note 4. Information Prepared and Certified by Custodians

The following information was compiled from data certified by the custodians, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits - December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits - Year Ended December 31, 2024.
- C. Investment information included in Schedule of Assets Held at End of Year.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Note 7. Income Tax Status

The Company has adopted a non-standardized prototype plan document sponsored by Empower Trust Company, LLC. The prototype plan document has received an opinion letter dated November 14, 2022 from the IRS as to the prototype plan document's qualified status. Any employer adopting the prototype plan document will be considered to have a qualified plan under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS, and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Guaranteed Interest Accounts

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may transfer their account balance in the Fund to any other investment option offered under the Plan at any time with no restrictions or penalties, because the Fund is designed to be a Plan's only guaranteed/stable value/money market investment.

Note 8. Guaranteed Interest Accounts (continued)

In order to provide the participant with liquidity (100% for participant transfers), there cannot be any actively competing guaranteed/stable value/money market investments in the Plan. Bond funds of durations longer than three years are permitted. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan or
- (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Upon termination of the group annuity contract, the employer may (a) receive the payoff of the fund in a lump sum with a market value adjustment, (b) receive the payout of the fund in a lump sum at book value, or (c) maintain participant accounts in the Key Guaranteed Portfolio Fund.

Note 9. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Note 9. Fair Value Measurements (continued)

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
