Opinion

Note 1 - Description of Plan and Significant Accounting Policies

The following description of the Port Imperial Ferry Corp. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan first became effective June 1, 2001 as a defined contribution profit sharing plan covering eligible employees of Port Imperial Ferry Corp. (the "Employer" or "Plan Sponsor") who are members of the Transport Workers Union or the Seafarers International Union (the "Unions"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Management has evaluated subsequent events through the date of the auditor's report, the date the financial statements were available to be issued.

Purpose

The purpose of the Plan is to provide retirement benefits to eligible participants.

Participants

Employees of the Employer, with the exception of non-resident aliens, salaried employees, and leased employees, become participants after completing six months of service and attaining 21 years of age.

Participants' accounts

Individual accounts, maintained for each participant, are credited with participants' contributions and allocations of Plan earnings based upon the investment options selected by each participant. A participant may direct contributions to various investment options consisting primarily of registered investment companies (mutual funds).

The Trustees have selected the Vanguard Target Funds, target date retirement funds, as the Plan's Qualified Default Investment Alternative. All contributions received on behalf of participants who fail to provide investment election forms will be invested in the Vanguard Target Funds, based on the participant's date of birth. Additionally, participants may elect to allocate a portion of their existing accounts and/or future contributions to the Vanguard Target Funds.

Vesting

Participants are 100% vested in the contributions they make to the Plan including salary deferrals and rollover contributions, plus actual earnings thereon.

Participants are vested in matching and profit sharing contributions subject to a five year schedule as follows:

In addition, a participant will become 100% vested in profit sharing, bonus, and matching contributions if he/she (1) attains age 65 while employed by the Employer, (2) becomes permanently and totally disabled, or (3) dies.

Benefits

A participant, or the participant's beneficiary, is entitled to receive benefits, if the participant:

1. Dies
2. Becomes disabled
3. Terminates employment

Plan regulations mandate that the distribution of a participant's benefit commences when the participant attains age 73, or retires, whichever occurs later.

An active participant may apply for an "in-service" distribution of his/her entire account balance, as long as he/she is at least 59 1/2 years of age.

Benefits are recorded when paid.

Effective May 2024, distributions under the Plan may be made in one lump-sum, substantially equal installments, or partial withdrawals. Prior to May 2024, only lump-sum payments were allowed.

Hardship withdrawals

In the event of certain financial hardships, as defined in the Plan, a participant may apply for a distribution of up to 100% of elective deferrals from their profit sharing account.

Notes receivable from participants

A participant may generally borrow up to 50% of the amount in their individual account not to exceed \$50,000 of the non-forfeitable amount of their account balance. The loans are secured by the balance in the participants' accounts. Loans are limited to purposes defined in the Plan and bear interest at a rate of 1% above the prime rate at the time the loan is taken. In general, loans must be repaid over a period of five years. Loans relating to the purchase of a principal residence must be repaid in accordance with terms set by the Plan Sponsor.

Notes receivable from participants are measured at their unpaid principal balance. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023 no allowance for credit losses has been recorded. If a participant does not make loan repayments in accordance with the terms of the loan and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Forfeitures

Participants that terminate service prior to being fully vested in their profit sharing contributions will forfeit the amount in which they are not vested at the earlier of the date they receive a distribution of their vested account balance or the date they incur five consecutive one year breaks in service.

Plan termination

The Plan Sponsor expects and intends to continue the Plan indefinitely, but reserves the right to amend or terminate it as provided for by the applicable Trust Agreement and Plan provisions. If the Plan is terminated, the rights of all affected participants and beneficiaries, to the value of the amounts credited to participants' accounts, shall be non-forfeitable and the Plan assets will be allocated to pay all obligations of the Plan and to provide benefits to those eligible under the terms of the Plan and as otherwise required by law.

Basis of accounting

The financial statements are presented on the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investments are stated at fair value. See "Fair value measurements" footnote for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative costs

The Plan Sponsor has agreed to assist in the administration of the Plan and absorb certain administrative costs related to the Plan.

Note 2 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices, in active markets, for identical assets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include: quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 inputs are generally based on the best information available, which may include the reporting entity's own assumptions and data.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies: Valued at the closing price reported in the active market in which the securities are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Note 4 - Party-in-interest transactions

Certain Plan investments are held by the manager of the investment; therefore, transactions relating to those investments qualify as exempt party-in-interest transactions and are identified as such on the supplemental schedules of investments.

Note 5 - Employers' and participants' contributions

Participants may elect salary deferrals of up to the annual maximum established by the IRS during any plan year. Participants who are age 50 at the end of any calendar year may make "catch up" contributions, up to the annual maximum established by the IRS, during any plan year. The Plan also accepts rollover contributions or transfers to the Plan with the approval of the Plan sponsor. The Employers may make discretionary matching contributions.

Therefore, no provision for income taxes has been included in the Plan's financial statements.
