Opinion

We have audited the accompanying financial statements of the Community Financial Services, Inc. Employee Stock Ownership Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Investments

As discussed in Note 3, the financial statements include investments representing approximately 99 and 98 percent of total assets as of December 31, 2024, and 2023, respectively, whose fair value has been estimated by an independent appraisal, in the absence of readily ascertainable fair values, with the assistance of management and approved by the Trustee. Because of the inherent uncertainty of the valuation, the estimated value may differ significantly from the value that would have been used had a market for the investment existed, and the difference could be material.

INDEPENDENT AUDITOR'S REPORT (CONTINUED)



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and; therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1 – Plan Description

The following brief description of the Community Financial Services, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Community Financial Services, Inc. (Company) established the Plan effective as of January 1, 1985. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the Company. Current trustees of the Plan consist of current and former Board members, executive officers of the Company, and independent third-party trustees.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The Company, as the lender, has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. the accounts of employees with rights in allocated common stock (allocated), and
2. common stock not yet allocated to employees (unallocated).

Eligibility

Employees of the Company are generally eligible to become participants of the Plan after one year of service, provided they worked at least 1,000 hours during such Plan year, and are age 21 or older. Once becoming eligible, participants can enter the Plan on January 1 of the year preceding meeting eligibility requirements. Participants who have not completed 1,000 hours of service during such Plan year, or are not actively employed on the last day of the Plan year, are generally ineligible for an allocation of Company contributions for such year, except for participants who retire in such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its note payable. Additional contributions may be made at the Company's discretion. Employee contributions are not permitted.

Payment of Benefits

Distributions on account of death, disability, retirement, or termination of service generally can be made in the form of a lump-sum, direct rollover, or installments over five years after the Plan year valuation following the event.

Payment of Benefits (Continued)

If the participant's account balance does not exceed \$100,000, a lump-sum distribution may be commenced in the year they terminate but will be made by April 1 in the year following the year of the termination event or attainment of age 73. Participants that become deceased subsequent to December 1 will receive a lump-sum distribution as soon as administratively feasible after the valuation is received for the year of the participant's death.

If the participant's account balance exceeds \$100,000, distributions will be made in annual installment payments over a five-year period in amounts at least equal to the lesser of \$40,000 or the remainder of the participant's account balance commencing by April 1 in the year following the year of the termination event or attainment of age 73, unless the participant terminates due to death. If the participant's account balance exceeds \$1,330,000, the installment period will be extended to six years. Participants that terminate due to death prior to December 1 will receive a lump-sum distribution in the Plan year in which they terminate. Participants that become deceased subsequent to December 1 will receive a lump-sum distribution as soon as administratively feasible after the valuation is received for the year of the participant's death. Participants receiving installment payouts prior to January 1, 2017, have the election to receive the remainder of their vested balance as a lump-sum distribution in the year their vested balance falls below \$100,000. Participants receiving installment payouts subsequent to January 1, 2017, will be paid the remainder of their vested balance as a lump-sum distribution in the year their vested balance falls below \$100,000.

Distributions are made in the form of cash or employer stock at the participant's discretion.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Trustees of the Plan or by the Company. The Trustees of the Plan have historically paid the operating expenses for the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. The Trustees are not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustees are required; however, to vote any unallocated shares on behalf of the collective best interest of the Plan participants and beneficiaries.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustees from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

Allocations are based on the participant's eligible compensation, relative to total eligible compensation of the Plan. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance, relative to the total beginning of year account balances of the Plan.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting begins at 20 percent after two years of service with participants becoming fully vested after five years of service.

Put Option

Under federal income tax regulations, the employer common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Upon distribution of stock to a participant, the former employee is given two 60-day periods to put the stock to the Company at its then fair market value. The first 60-day period begins upon distribution. The second 60-day period begins after the end of the next Plan year, once the participant has been notified of the current value of his or her shares.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants as of December 31, 2024 and 2023 totaled approximately \$11,000 and \$36,000, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated), and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Interest income is recorded on the accrual basis. Purchases and sales of the Company's common stock are recorded on a trade-date basis. Net appreciation in fair value of the Plan's investments includes the Plan's gains and losses on the Plan's investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Community Financial Services, Inc. common stock: The Company common stock held by the Plan is reported at fair value based upon an independent appraisal.

Interest-bearing cash and cash equivalents: Accounts primarily consist of savings accounts and a short-term certificate of deposit that are valued on the basis of readily determinable market prices.

Following is a description of the valuation methodologies used for Level 3 assets measured at fair value.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP Trustees, reviews in detail, discusses, and approves.

The Company common stock held by the Plan is reported at fair value based upon an independent appraisal. This appraisal was based upon 25 percent of the earnings value method and 75 percent the price to book value method for the year ended December 31, 2024, and upon the price to book value method for the year ended December 31, 2023. The appraiser deemed the 25 percent of the earnings value method and 75 percent of the price to book value method a more appropriate method than the 100 percent weight of the price to book value method, resulting in a change in method for the year ended December 31, 2024.

Note 5 – Note Payable

In June 2011, the Plan entered into a \$6,989,753 stock purchase agreement with the Company. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. For financial reporting purposes, the Plan does not release any shares until the debt service is actually paid. The debt service payment for the year ended December 31, 2024 resulted in 4,495 shares being released and allocated.

The note agreement provides for the loan to be repaid in future annual installments (including principal and interest at 0.01 percent) through December 2044. The value of the note payable as of December 31, 2024 and 2023 was \$4,662,165 and \$4,895,030, respectively. Note payable maturities are as follows:

Note 6 – Administration of Plan Assets

The Plan's assets, which consist primarily of Company common stock and interest-bearing cash and cash equivalents, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, who invest cash received, interest and dividend income, and make distributions to participants. The Trustees also administer the payment of principal and interest on the loan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. As described in Note 1, the Plan made direct payments to the third-party administrator, accountant, and Trustees totaling \$78,829.

Note 7 – Company Dividends

The Company declared a dividend in the amount of \$1.00 per share of common stock to be paid to the holders of record as of December 3, 2024 totaling \$223,087, which was paid on December 18, 2024.

Note 8 – Related Party Transactions and Party-in-Interest Transactions

The Plan invests in Company common stock and has a note payable with the Company. These are related party and party-in-interest transactions. As described in Note 1, the Plan and the Company pay all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Note 9 – Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Company, as the administrator, shall direct the Trustees to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 10 – Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated April 13, 2015 stating that the Plan is qualified under the IRC and; therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC.

Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 11 – Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 12 – Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.
