### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

### Note 1 - Plan Description

The following description of Eisenhower Center 401(k) Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

Moriah, Inc. d/b/a Eisenhower Center (the "Company") established the Plan effective February 1, 1994. The Plan is a defined contribution plan covering all full-time employees who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may make annual contributions to the Plan on a pretax basis and after-tax basis up to the maximum percentage of compensation and dollar amount permissible under Internal Revenue Code (IRC) Section 401(k). A participant may increase or decrease the amount of pretax contribution rates on a semiannual basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Company may make discretionary profit-sharing contributions to the Plan. No discretionary contributions were made during the plan year.

All contributions are invested in one or more investments, as directed by the plan participants.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances. Notes receivable are collateralized by the participant's account balance and bear interest at a rate commensurate with prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Vesting**

Participants are immediately vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company at 20 percent each year and are fully vested after five years.

#### **Benefit Payments**

On termination of service due to death, disability, retirement, attainment of age 59½, or termination of employment, as defined in the plan agreement, a participant or his or her beneficiary may elect to receive a lump sum equal to the value of the participant's account, substantially equal installments of the value of the participant's account, or a direct transfer to another qualified retirement plan or individual retirement account (IRA).

#### **Forfeitures**

Forfeitures may be used to pay expenses of the Plan, or are allocated to eligible participants. Forfeitures may be allocated to all participants eligible to share in the allocations of profit-sharing contributions or forfeitures in the same proportion that each participant's compensation for the plan year bears to the compensation of all participants for such year.

**Note 1 - Plan Description (Continued)**

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank or its affiliates. Charles Schwab Trust Bank is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

The Company paid certain expenses to administer the Plan, which qualify as party-in-interest transactions. Investment management fees and other fees, such as loan and withdrawal fees, are charged to participants' accounts.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment instruments. Investment instruments, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 10, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. Significant Level 3 inputs include the cash surrender value of specific policies.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

***Common Collective Trust Funds***

The common collective trust funds are valued at net asset value (NAV) per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets.

***Life Insurance Policies***

Life insurance policies are valued at fair value based on the cash surrender value of the policies.

***Cash***

The fair value of this investment is based on its outstanding balances.
