Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1. Description of the Plan**

The following description of Community Bancshares of Mississippi, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

***General***

Community Bancshares of Mississippi, Inc. (Company) established the Plan effective as of January 1, 1983. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan is administered by a Retirement Committee (Committee) appointed by the Company's Board of Directors. First Horizon Bank is the Plan's trustee.

***Participation***

Employees of the Company and its participating subsidiaries are able to participate in the Plan on January 1 in the year following their date of employment.

***Vesting***

Participants vest in the Company's contributions and earnings thereon at a rate of 20% for each year of service greater than two years and become fully vested upon completing six years of service. Participants terminating due to normal retirement, death, or disability will be 100% vested.

***Payment of Benefits***

Distributions from the Plan are made when the participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), terminates employment with the Company or its participating subsidiaries, or the participant may receive a portion of his or her vested portion at any time upon election. Distributions may be made in shares of the Company's stock or in cash, as the Committee so elects. If the trustee elects to make a distribution in cash, a participant has a right to demand that applicable benefits be distributed in the form of the Company's stock.

Net assets available for benefits include amounts allocated to the accounts of terminated participants. These accounts had a total balance of approximately \$34,666,000 and \$21,378,000 at December 31, 2024 and 2023, respectively.

***Voting Rights***

The trustee of the Plan will vote all employer stock held by it as instructed by the plan administrator. However, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to any corporate matter that involves the voting of such shares for the approval or disapproval of any corporate merger or consolidation, liquidation, dissolution, sale of substantially all assets of a trade or business, or other similar transactions.

***Plan Termination***

The Company reserves the right to terminate the Plan at any time, subject to the Plan's provisions. Upon such termination of the Plan, each participant becomes 100% vested, and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan's terms and the IRC.

***Participant Accounts***

Employer contributions and forfeitures are allocated to each participant's account based on the ratio of a participant's annual earnings to total compensation for all participants for the year. Plan earnings are allocated annually to each participant's account as prescribed by the Plan Document.

***Put Option***

Under federal income tax regulations and per the Plan's provisions, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

***Forfeitures***

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants during the year ended December 31, 2024 totaled approximately \$181,000.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The common stock of the Company is valued at estimated fair value. Fair value is determined by an annual independent appraisal. Money market mutual funds are stated at fair value based on quoted market prices, and certificates of deposit are stated at amortized cost, which is deemed by management to approximate fair value.

Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Dividends***

At the discretion of the Committee, dividends may be distributed in cash to plan participants or maintained in the Plan to be invested in company stock or other applicable investments, as provided by the Plan.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

***Plan Tax Status***

The Plan has received a determination letter from the Internal Revenue Service dated May 1, 2017, stating that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 3. Administration of Plan Assets**

The Plan's assets, which consist principally of 859,096 shares of Community Bancshares of Mississippi, Inc. common stock, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest and dividend income, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receive compensation from the Plan.

**Note 4. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, First Horizon Bank, a qualified institution, has certified the following

investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024 and the accompanying schedule of reportable transactions for the year ended December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

## **Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in common stock of the Company and, from time to time, certificates of deposits of the wholly-owned bank subsidiary of the Company.

The Company provides certain administrative services at no cost to the Plan.

## **Note 6. Employer Contributions**

Contributions to the Plan are made each year as determined by the Board of Directors. However, if a plan loan is outstanding, the contribution shall never be less than the amount required to enable the Plan to meet its annual obligation under the loan. No loans were outstanding as of December 31, 2024 or 2023.

## **Note 7. Disclosure About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that the entity can access at the measurement date
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy and include a money market mutual fund. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy and include certificates of deposit. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy and include company common stock.

The valuation process involves plan management's selection of an independent appraiser under contract with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP trustee, reviews in detail, discusses, and approves. The results of this process are documented in minutes of the plan fiduciary.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Uncertainty of Fair Value Measurements***

The following is a description of the uncertainty of the fair value measurement at the reporting date from the use of significant unobservable inputs, if those inputs reasonably could not have been different at the reporting date, the interrelationships between those inputs and other unobservable inputs used in recurring fair value measurement, and how those inputs might magnify or mitigate the effect of changes in the unobservable inputs on the fair value measurement.

***Company Common Stock***

The significant unobservable inputs used in the fair value measurement of the company common stock are the long-term revenue growth rate, discount rate, discount for lack of marketability and future dividend rates. Significant changes in these inputs could result in a significant change to the fair value estimate.

**Note 8. Risks and Uncertainties**

The Plan primarily invests in company common stock, which is exposed to various risks, such as market and credit risk. Due to the level of risk associated with such investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through August 1, 2025, which is the date the financial statements were available to be issued.
