NOTE A – DESCRIPTION OF PLAN

The following description of the Lamberts Cafe, Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of Lamberts Cafe, Inc. (Sikeston, MO), Lambert's Cafe II, Inc. (Ozark, MO) and Lambert's Cafe III, Inc. (Foley, AL) ("Company") who have met the Plan's age (21 or older) and service (one year of service (including 1,000 hours of service)) eligibility requirements. Effective January 1, 2024, long-term part-time employees who are credited with at least 500 hours of service for three consecutive years may also be eligible to participate (see Note J). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established September 1, 1997. It was most recently restated effective January 1, 2022 and amended effective January 1, 2024 (see Note J).

2. Contributions

Each year, participants may contribute up to 75 percent of pretax or after-tax (Roth) (effective January 1, 2024 Plan amendment) annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement Plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The employer may make non-elective contributions at the discretion of management. There were no discretionary contributions to the Plan for 2024. Contributions are subject to certain IRS limitations.

3. Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary non-elective contribution, and Plan earnings. Participant accounts are charged with certain administrative expenses not paid by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in the value of employer contributions, if any, and actual earnings thereon at the rate of 20% per year beginning on their two year service anniversary date.

5. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loan interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

6. Payment of Benefits

In the case of normal retirement, retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their vested plan benefits in accordance with the provisions of the Plan in a lump-sum distribution or in an alternative manner mutually agreed upon by the participant and the Plan administrator. In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested plan benefits in a lump-sum distribution or in an alternative manner mutually agreed upon by the beneficiary and the Plan administrator.

7. Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,357 and \$9,632, respectively. Forfeitures of Company profit sharing contributions are permitted to pay administrative expenses of the Plan. Forfeitures which are not used to pay administrative expenses may be used to reduce employer contributions or reallocated to participants' accounts, as elected by the Company.

8. Administration

Lamberts Cafe, Inc., Lambert's Cafe II, Inc. and Lambert's Cafe III, Inc. are the Plan administrators. Lincoln National Life Insurance Company (Lincoln) is the Plan's contract administrator and holds the Plan's investments.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

3. Investment Valuation and Income Recognition (continued)

Dividends on pooled separate accounts are included in net appreciation in fair value of investments. Interest on the guaranteed accounts is credited daily at an interest rate that will not be less than the guaranteed account minimum interest rate, as per the contracts specifications. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Contributions

Contributions from Plan participants and any contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the year ended December 31, 2024.

7. Payment of Benefits

Benefits are recorded when paid.

8. Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and for payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Certain administrative and investment advisory fees are also included in administrative expenses. Other investment related expenses are included in net appreciation of fair value of investments.

9. Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value of units held by the Plan at year end. The unit value of each separate account is based on the market value of the underlying assets owned by the account minus the liabilities, divided by the outstanding units of the separate account. This value is referred to as the net asset value. The net asset value is used as a practical expedient to estimate fair value. Investments that are measured at net asset value per unit are not classified in the fair value hierarchy. The fair value of the pooled separate accounts was \$3,516,611 and \$3,384,023 at December 31, 2024 and 2023, respectively.

NOTE D – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan entered into two fully benefit-responsive guaranteed investment contracts with Lincoln, the Lincoln Guaranteed Account and the Managed Principal Protected Portfolio. Lincoln maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE D – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (CONTINUED)

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of the investment contracts at December 31, 2024 and 2023 was \$333,856 and \$310,604, respectively. The crediting interest rate is agreed upon with the issuer, and it may not be less than the guaranteed minimum interest rate for the contract. The credited rate as of December 31, 2024 and 2023 was 3.6% and 2.1%, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Under the terms of the contracts, participant-initiated transactions for the purposes of receiving benefits allowed under the plan, including terminations, are completed at contract value without conditions, limits, or restrictions. A surrender charge or market value adjustment may apply if an in-service participant-initiated withdrawal occurs prior to normal retirement, cumulative withdrawals and transfers exceed a specified amount held in the account, or if the termination is associated with a full or partial plan termination, the consolidation, sale, merger, spinoff, or reorganization of the plan sponsor. Plan management has determined that the likelihood of any of these events occurring is not probable.

NOTE E – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Company has accepted the certification of Lincoln as to the accuracy and completeness of the investment information included in the accompanying financial statements and supplemental schedule; and instructed the Plan's independent accountants not to perform any auditing procedures with respect to such information. Accordingly, the following information was certified by Lincoln as of December 31, 2024 and 2023 and for the year ended December 31, 2024 and was not subject to any auditing procedures, except for comparing such information with the related information contained in the accompanying financial statements and supplemental schedule:

- Investments at fair value and contract value and notes receivable from participants as of December 31, 2024 and 2023, which are included in the Statement of Net Assets Available for Benefits.
- Interest and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, which are included in the Statement of Changes in Net Assets Available for Benefits.
- Party-in-interest transactions for the year ended December 31, 2024, which are described in Note F.
- All information regarding assets held by the Plan at December 31, 2024, included in the Schedule of Assets (Held at End of Year).

NOTE F – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan held units of various investment contracts held in pooled separate accounts and guaranteed accounts managed by Lincoln, the Plan's custodian. At December 31, 2024 and 2023, these investments had a total aggregate value of \$3,850,467 and \$3,694,627, respectively. Also, as described in Note B8, Lincoln provides certain administrative services to the Plan pursuant to a service agreement between the Company and Lincoln, for which the Plan is charged a fee. These transactions are allowable party-in-interest transactions under Section 408(b)(8) of the ERISA regulations.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the provisions of the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE H – TAX STATUS

The Plan, which is a CCH Incorporated, DBA ftwilliam.com non-standardized pre-approved plan document, has not been submitted to the Internal Revenue Service for an individual determination; however, the non-standardized pre-approved plan document was approved by the IRS on June 30, 2020 as satisfying the basic requirements of ERISA. Although the Plan has been amended since receiving the IRS letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE J— PLAN AMENDMENT AND RECENT LEGISLATION

The Plan was amended effective January 1, 2024 to add Roth contributions as a deferral option for participants.

In compliance with the SECURE Act of 2019, the Plan was amended to allow certain long-term part-time employees who are credited with at least 500 services hours three consecutive years to participate in the Plan effective January 1, 2024.

The SECURE 2.0 Act of 2022 (Act) was signed into law in December 2022 to increase retirement savings and improve retirement rules, among other provisions. Formal Plan amendments required by the Act are generally not required to be made until the end of the first plan year beginning on or after January 1, 2025.
