Notes to Financial Statements

Note 1: Description of Plan

The following description of the Pine State Trading Co. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Pine State Trading Co. (the "Company") and its majority owned subsidiary who are at least 20 years of age and have completed at least three (3) months of service as defined by the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investments and monitors investment performance.

Contributions

Each year, participants may contribute up to the maximum amount of their eligible compensation that will not cause the Plan to violate the Actual Deferral Percentage (ADP) test for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may contribute elective deferral amounts on a pre-tax basis or Roth after-tax basis. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants who are automatically enrolled with a deferral rate greater than zero will have that deferral increased annually by 1% as a pre-tax deferral contribution until a deferral rate of 6% is reached.

Company match contributions are discretionary. During 2024 and 2023, the Company matched 25% of the first 6% of eligible compensation that a participant contributed to the Plan. The Company match contributions to the Plan for the years ended December 31, 2024 and 2023, were \$374,280 and \$341,257, respectively. The Company's safe harbor nonelective contribution is equal to 3% of each participant's eligible compensation. The Company safe harbor contribution for the years ended December 31, 2024 and 2023, was \$904,079 and \$856,820, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Employee deferrals and Company match contributions are funded on a payroll basis; Company safe harbor contributions are funded on a semi-annual basis.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company safe harbor and discretionary match contributions, if applicable, and allocations of plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their eligible vested account balance. Loan terms generally cannot exceed 5 years, unless the loan is for the purchase of a principal residence, in which case the plan administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear a fixed rate of interest commensurate with local prevailing rates at the inception of the loan. Principal and interest are paid ratably through payroll deductions. Interest rates on notes outstanding at December 31, 2024 and 2023, ranged from 3.25% to 8.50%.

Payment of Benefits

Upon termination of service, a participant may receive a lump sum amount equal to the value of his or her vested account, installment payments, or partial withdrawals. If the balance is less than \$5,000 (\$7,000 effective January 1, 2024), the plan administrator may automatically distribute the balance as a lump-sum distribution. The Plan allows for in-service distributions upon attaining age 59 1/2. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to withdrawal charges are netted with benefits paid to participants. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and lowest priority to unobservable inputs ("Level 3"). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Units are valued daily at the NAV of the net assets and outstanding units of the underlying collective investment funds held within the trust. The NAV is used as the practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The redemption notice period is 90 days. There are no unfunded commitments.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan has a FBRIC with the Standard Insurance Company (Standard), the Stable Asset Fund II. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The Stable Asset Fund II is a general account product which provides a guarantee of principal and guaranteed quarterly interest rate. The methodology for calculating the interest rate is based on the Standard Stable Asset Fund (the SAF) interest rate which is determined and declared quarterly. The interest is credited daily to deposits to the SAF at the daily equivalent of the SAF interest rate. The SAF interest rate will not be less than the Minimum Guaranteed Interest Rate of 1.00% per annum.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs) (Continued)

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Fidelity Management Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to equity wash provisions for the Guaranteed Portfolio Fund.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, was \$292,986 and \$290,314, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee, as of and for the years ended December 31, 2024 and 2023.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fidelity Workplace Services LLC is the recordkeeper of the Plan. Total recordkeeping fees paid for the years ended December 31, 2024 and 2023 are included in administrative expenses in the statements of changes in net assets available for benefits.

Global Retirement Partners, LLC are defined as investment advisors to the Plan and are paid by the Plan for these services. Total investment advisory fees paid during the years ended December 31, 2024 and 2023 are included in investment fees in the statements of changes in net assets available for benefits.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan Document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Subsequent Events

Management has made an evaluation of subsequent events through August 13, 2025, which is the date the financial statements were available to be issued.
