### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of SJE-Rhombus 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SJE-Rhombus 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



**NOTE 1 DESCRIPTION OF PLAN**

The following description of the SJE-Rhombus (the Company) 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan provisions.

**General**

The Plan is a defined contribution plan established effective August 1, 2003. The Plan was last amended and restated effective March 11, 2022. Employees are eligible for participation upon attaining age 18 and enter the Plan immediately. The Plan excludes employees covered by a collective bargaining agreement, nonresident aliens with no U.S. source income, and leased employees. The Plan is subject to ERISA, as amended.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are thereby permitted to elect to have a percentage (up to the maximum amount allowed by law) of their annual compensation contributed as pre-tax 401(k) contributions to the Plan. The Plan also contains an automatic enrollment feature whereby participants are automatically enrolled at 6% (unless otherwise elected). The Plan allows participants to make Roth contributions to the Plan. The Plan also allows participants age 50 and over to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit IRAs. As part of the S.J. Electro Systems, Inc. Employee Stock Ownership Plan and Trust termination on June 17, 2021, participants were allowed to roll balances into the Plan.

Each year, the Company may make a discretionary matching contribution to the Plan. The Company made matching contributions equal to 50% of the first 6% of the participant's contributions deferred during the Plan years ended October 31, 2024 and 2023. Contributions are subject to certain limitations.

**Participant's Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and investment earnings or losses. Allocations are based on earnings or account balances, as defined in the Plan. Income is allocated daily based on the number of shares in the participant's account. Participants direct the investment of contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Employee contributions are immediately 100% vested. Company discretionary matching contributions, plus actual earnings thereon, vest at a rate of 20% per year starting with the second year of credited service. A year of credited service is each year in which an employee completes 1,000 hours of service. A participant is 100% vested after the completion of six years of credited service. Vesting service includes prior service with any affiliated companies. Notwithstanding the above, participants will become 100% vested in their account upon attaining normal retirement age 65, upon death, or becoming totally disabled.

**Forfeited Accounts**

Forfeited nonvested accounts are used to pay administrative expenses or used to reduce future Company matching contributions. At October 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,869 and \$1,693, respectively. There were \$33,096 and \$24,456 of forfeited nonvested amounts used to pay administrative expenses for 2024 and 2023, respectively. There were \$118,940 and \$97,956 of forfeited nonvested amounts used to reduce the Company matching contributions for 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note transactions are treated as a transfer to (from) the investment fund from (to) the participant note. Note terms range from one year up to five years (or up to 25 years for the purchase of a principal residence). The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service, death, disability, retirement (age 65), or early retirement (age 55 and six years of service), the participant may receive the value of the vested interest in their account in the form of a lump-sum distribution or in installments. If a participant terminates employment and the participant's account balance is not greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance is greater than \$1,000 but less than \$5,000, the benefit payment will be rolled over into an Individual Retirement Account (unless otherwise elected). The Plan also allows for in-service (age 59 ½) distributions and financial hardship withdrawals, subject to Plan provisions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced, and a benefit payment will be recorded at the time the participant incurs a distributable event.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants, benefits paid to participants and investment related expenses are charged directly to the participant's account and are included in administrative expenses.

**Subsequent Events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the notes receivable from participants and all the investment information reflected on the accompanying statements of net assets available for benefits as of October 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the schedule of assets (held at end of year) as of October 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at October 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan administrator will facilitate the distribution of account balances under the provisions of the Plan and Trust Agreement until all assets have been distributed. Participants will become 100% vested in their respective accounts upon termination of the Plan.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The investments are managed by Principal Trust Company, the trustee. Therefore, all transactions qualify as party-in-interest.

**NOTE 9 NONEXEMPT TRANSACTIONS**

During 2024, Plan management failed to remit loan repayments for certain participants within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC under this Plan. Plan management has made the necessary correction of this late remittance with applicable earnings in 2025.

**NOTE 10 PLAN MERGER**

Effective January 1, 2025, the Plan was formally resolved to merge the Revere Control Systems, Inc. 401(k) Profit Sharing Plan into the SJE-Rhombus 401(k) Plan. Accordingly, assets in the amount of approximately \$19 million were deposited into the Plan on March 3, 2025.
