NOTE 1 - Description of the Plan

The following description of the Job Options, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established December 16, 2004 to provide health and other benefits to eligible participants. The sponsoring employer, Job Options, Inc., has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, death, prescription drug coverage, supplemental accident, health reimbursement arrangement (HRA) and dismissal wage/unemployment benefits for eligible participants and their dependents. The Plan provides some of these benefits on a self-funded basis.

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan Sponsor or Plan Administrator to the other at least 60 days, but not more than 90 days, prior to the anniversary date of effective coverage under this Plan.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

Eligibility rules under the Plan require all employees hired as active employees to receive coverage the first of the month following one month of continuous employment on a fringe contract depending on their work site. Benefits terminate on the last day of the month in which a participant's employment terminates.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and equivalents

Cash equivalents include money market accounts used in general operations.

Concentration of credit risk for cash:

For business purposes, the Plan maintains cash balances at Partners Bank of California, which exceed the \$250,000 insurance provided by the Federal Deposit Insurance Corporation. The amount in excess of the \$250,000 insurance limit as of December 31, 2024 was \$250,866. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end with incurred and received dates of December 31, and prior.

Benefit Claims Incurred, But Not Reported

The obligation for benefit claims incurred, but not reported is an estimate for self-funded benefits incurred on or prior to December 31, but reported to and paid by the Plan after December 31. The estimate was calculated using available claims experience data and projected future claims.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through August 8, 2025, the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements

NOTE 3 - Dismissal Wage/Unemployment Benefit (DUB)

The Plan provides dismissal wage/unemployment benefits (DUB) to eligible participants upon termination of employment. A participant's account balance is determined by employer contributions and interest income less forfeitures. Included in the accompanying statement of net assets are amounts available to provide dismissal wage/unemployment benefits as of December 31, 2024 and 2023, totaling \$137,044 and \$201,552, respectively. Starting in 2016, the employer ceased dismissal wage/unemployment benefit contributions.

NOTE 4 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$197,466 and \$256,399 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 5 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 or 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - Health Care Reimbursement arrangement (HRA) Benefits

The Plan provides health care reimbursement arrangement (HRA) benefits to eligible participants. A participant's account balance is funded by employer contributions and allows participants to be reimbursed for eligible out of pocket health benefits incurred by participants. Included in the accompanying statement of net assets are amounts available to provide HRA benefits as of December 31, 2024 and 2023, totaling \$292,678 and \$292,528, respectively.
