Opinion

We have audited the accompanying financial statements of Structure Tone, Inc. Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, the statements of accumulated plan benefits as of October 31, 2023 and 2022, the related statements of changes in accumulated plan benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Structure Tone, Inc. Pension Plan as of October 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, and its accumulated plan benefits as of October 31, 2023 and 2022, and the changes in its accumulated plan benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Note 1 - Description of the Plan

The following description of the Structure Tone, Inc. Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement (the "Agreement") for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit pension plan which includes eligible employees of Structure Tone Group, LLC and its affiliates over the age of 20½ with at least six months of service and not covered under collective-bargaining agreements between employee representatives and the employer. The Plan complies with the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan and related trust were established on November 1, 1980 and amended and restated on November 1, 2021. The Plan has been frozen since November 1, 2009, ceasing all future benefit accruals for all Plan participants. However, Plan participants continue to earn vesting service for employment with Structure Tone Group, LLC and its affiliates on and after November 1, 2009 in accordance with the Plan's vesting schedule. Effective January 1, 2018, Wells Fargo, NA was appointed the custodian and the trustee of the Plan.

Effective December 30, 2020, the sponsor of the Plan is STO Building Group, Inc. (the "Sponsor" or the "Company"), succeeding Structure Tone, LLC.

Further, effective February 22, 2022, the custodian of the Plan, Wells Fargo, NA, was acquired by Principal Financial.

Effective November 1, 2022, the Plan entered into the group annuity contract with Principal Life Insurance Company.

Contributions

The Plan is entirely funded by the Company. The amount of funding required is based on actuarial calculations. Participants are neither required nor permitted to make contributions to the Plan.

Pension Benefits, Vesting, Death Benefits and Disability

Each participant shall be entitled to receive a monthly pension in the form of a straight life annuity commencing at the later of age 65 or the 5th anniversary of Plan participation. Participants with credited service prior to November 1, 1990 may elect to receive their pension benefit that was accrued prior to November 1, 1990 in a lump-sum payment. The amount of pension benefit received is calculated using certain formulas based on compensation at the time the Plan was frozen on November 1, 2009, and years of service. Effective August 8, 2024 in accordance with Plan provisions, the involuntary cashout limit for terminated participants increased from \$5,000 to \$7,000.

Pension Benefits, Vesting, Death Benefits and Disability (cont'd.)

Early retirement benefits are available to a participant who has attained age 55 and has completed ten years of service, even if age 55 is attained after termination of employment. The amount of pension benefit is reduced to account for the longer payment period. Vesting is based on years of service. After seven years, each participant is fully vested. If the participant dies or becomes permanently disabled before the normal retirement date, the participant will become fully vested and the beneficiary has the option to receive the entire benefit as a lump-sum or in monthly payments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid debt instruments purchased with an initial maturity of three months or less to be cash equivalents.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on an employee's age and years vested.

Actuarial Present Value of Accumulated Plan Benefits (cont'd.)

Benefits under the Plan are based on employees' compensation over a period of five years of credited service. The accumulated plan benefits for active employees are based on their average compensation over the highest five plan years during the preceding ten years. Benefits payable under all circumstances - retirement, death, disability, and termination of employment - are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated plan benefits. The actuarial present value of accumulated plan benefits is determined by an actuary from Mercer Human Resource Consulting and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Actuarial Present Value of Accumulated Plan Benefits (cont'd.)

There is a factor to reflect anticipated administrative expenses associated with providing benefits. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses relate to investment management services and actuarial services. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. All Plan expenses paid by the Company are not reimbursable by the Plan.

Note 3 - Funding Policy

The Plan is financed by Company contributions in accordance with the Plan agreement and by the excess of income from investments over the operating expenses of the Plan.

The Plan is subject to ERISA minimum funding requirements. For the years ended October 31, 2024 and 2023, the Plan has met these requirements.

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note 4 - Termination of Plan

In the event of termination of the Plan, the assets then remaining shall be first used to pay administrative expenses. The remaining assets shall be used to pay retirement benefits.

Benefits under the Plan are insured by the Pension Benefit Guaranty Corporation ("PBGC") if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement pensions, early retirement pensions and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under covered plans, and the amount of benefit protection is subject to certain limitations.

The PBGC guarantees vested benefits at the level in effect on the date of Plan termination. However, if a Plan has been in effect less than five years before it terminates, or if benefits have been increased within the five years before Plan termination, the whole amount of the Plan's vested benefits or the benefit increase may not be guaranteed. In addition, there is a ceiling on the amount of monthly pension that the PBGC guarantees, which is adjusted periodically.

Note 5 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at October 31, 2024 and 2023.

Pooled Separate Accounts: Valued at their "accumulation unit value" ("AUV"). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value ("NAV") of shares of the underlying fund, the fund's dividends and the contract's separate account charges. Transactions occur daily in and out of the accounts. The fund's net asset values are available from Principal Life. The contract's daily asset charge (separate account charge) is communicated to Plan management in the contract, and applicable notice of change is provided.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8 - Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated December 21, 2015 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter; therefore, the Plan administrator and the Plan's tax counsel believe that the Plan was qualified and the related trust was tax-exempt at the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at October 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to fiscal 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, probability of payment and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 10 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after October 31, 2024 through August 12, 2025, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.

Form of benefit and basis

100% of active participants with a pre-1990 benefit are assumed to receive their pre-1990 benefits as a single lump sum payable immediately for retirement benefits.

The remaining active participants and all inactive participants are assumed to receive a stream of payments at retirement on the plan's normal form.

We are relying on the assumption set by the prior actuary until we gain sufficient experience to adjust this assumption as needed.

The single sum benefit is based on 1971 Group Annuity mortality table for females and 5.00% interest.

Methods prescribed by law

Liability measure

Funding target is the present value of the benefits accrued on the valuation date. Included in Funding Target is the value of any missed required minimum distributions (defined in IRC §401(a)(9) and Treasury Regulation §1.401(a)(9)) and retroactive back payments for terminated vested participant past their NRD date, equal to back payments with interest at 7.00%.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

Lump sum payments

Lump sum payments are valued using the plan's funding target interest rates as required, per IRS guidance. These rates are currently higher than the actual rates used to determine lump sum distributions. Therefore, plan liabilities do not currently recognize this additional cost and this may result in the plan not accumulating adequate assets. You may wish to consider additional contributions.

Methods selected by plan sponsor

Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

Yield curve rates

Full yield curve. Use the rates through the month of October.

PBGC premium basis

Variable rate premiums are calculated using census, market value of assets and interest rates in effect on the current valuation date. Interest rates are the 24-month average rates used for annual cost but without the interest rate corridor defined in IRC §430(h)(2)(C)(iv). You elected this Alternative interest method and this method must be used for five years before a change can be made.

Methods elected by actuary

Retirees

Assets and liabilities for current and future retirees are included.

Vested benefits

A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant's vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

The optional form conversion basis for payments other than lump sums is the greater of 1971 Group Annuity Table for Females with 7% interest or the applicable mortality table as set forth in Code Section 417 with 5% interest.

Lump sum provisions

Small amount force out (SAFO) – allowed up to \$7,000.

Lump sums in excess of SAFO - are allowed at termination of employment and retirement.

Conversion – If there are no accruals prior to 11/01/1990, then we will use the greater of 1971 Group Annuity Table for Females with 7% interest or the applicable interest rate and mortality table as set forth in Code Section 417 (or with 5% interest if resulting in a larger benefit).

Only for accruals prior to 11/01/1990, we will use the greater of 1971 Group Annuity Table for Females with 5% interest or the applicable interest rate and mortality table as set forth in Code Section 417 (or with 5% interest if resulting in a larger benefit).

The applicable interest rate uses the fourth calendar month preceding the first day of the stability period which is the plan year.

Participation service

A plan year in which an employee has earned at least 1,000 hours worked.

Significant Event

The enrolled actuary has not been made aware that any significant events have occurred during the year.

There have been no changes in principal eligibility or benefit provisions since the last valuation.

Certain non-prescribed assumptions have been changed since last year. These assumptions were changed to better reflect the anticipated experience of your plan. See the attachment, Part V – Statement of Actuarial Assumptions/Methods, for the rationale for each assumption.

The inflation assumption has increased from 2.25% to 2.40%.

The assumed asset return for the current year has decreased from 4.41% to 4.25%. This rate is used in the calculation of the actuarial value of plan assets.
