### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Community Physicians Group 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the ten months ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Physicians Group 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 31, 2024 (in liquidation) and December 31, 2023 (ongoing) and for the ten months ended October 31, 2024 (in liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Community Physicians Group 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Emphasis of Matter – Termination Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Board of Directors of Community Physicians Group, the plan's sponsor, voted on March 4, 2024, to terminate the Plan. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Community Physicians Group 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Summary of Significant Plan Provisions

The following description of the Community Physicians Group 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan's provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Integrated Community Clinics, P.A. (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by a committee. The Board of Directors have appointed the trustee of the Plan within the organization. Empower Trust Company, LLC (the Custodian) holds the Plan assets and maintains the records of the participant data. WealthPath Investment Advisors, as sub-advisor to Pension Financial Group, LLC, serves as the Plan's investment advisor.

Effective March 4, 2024, the Board of Directors approved to terminate the Plan due to the asset sale of the Company.

- b. **Eligibility** – Employees, who were not a nonresident alien, leased under a collective bargaining agreement or scheduled to work less than 1,000 hours, were eligible to participate in the Plan upon attaining 18 years of age and completing 90 days of service. Plan entry dates were the first day of the quarter following the date the eligibility requirements were met.
- c. **Contributions** – Participants contributed through pre-tax or Roth deferrals, as well as rollover contributions. Participants were allowed automatic deferral arrangement at 3% with an automatic increase of 1% up to a maximum of 6% in compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Plan required the Employer to make safe harbor contributions in an amount equal to 3% of participant's eligible compensation. The Plan made the election on January 1, 2023, to deposit the safe harbor contributions into the Plan each pay period.

The Plan also required the Employer to make a fixed matching contribution to the Plan in an amount equal to 50% of a participant's contributions, not to exceed 4% of the participant's eligible compensation, each payroll period.

Additional amounts could be contributed by the Company under the Plan's non-elective contribution provisions at the discretion of the Company's Board of Directors. During the ten months ended October 31, 2024, no non-elective contributions were made.

Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain limitations set forth by the Internal Revenue Service (“IRS”).

- d. **Participant accounts** – Each participant’s account was credited with the participant’s contributions, safe harbor contributions, fixed matching contributions, and allocation of non-elective contributions and Plan earnings. Participant accounts were reduced with applicable withdrawals and an allocation of any administrative expenses. Allocations were based on participant contributions, compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants were fully vested in their own contributions and safe-harbor contributions, plus actual earnings thereon. Employer fixed matching contributions and nonelective contributions were fully vested upon death, disability or upon reaching normal retirement age of 65.

If participants terminated employment for any other reason, they were entitled to the portion of non-elective contributions made by the Employer according to the following schedule:

If participants terminated employment for any other reason, they were entitled to the portion of matching contributions made by the Employer according to the following schedule:

- f. **Notes receivable from participants** – Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000. Note terms could not exceed five years unless the note was for the purchase of a primary residence. The note was secured by the participant’s vested account balance and charged interest at a rate of prime plus 1%. Participants were limited to one outstanding note at any given time. Principal and interest were paid ratably through payroll deductions.

- g. **Payment of benefits** – Upon retirement, termination of employment or disability, a participant or his or her beneficiary in the event of death, could elect to receive a payment of benefits in a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, a participant could receive an in-service withdrawal from any portion of their account upon the age 59 ½. If the participant's account balance was equal to or less than \$5,000, the balance would be automatically distributed. Any distribution greater than \$1,000 that was made to a participant without the participant's consent would be rolled over to an individual retirement plan designated by the Plan administrator.

The Plan allowed hardship withdrawals, subject to account balances limits and applicable laws.

- h. **Forfeitures** – The portion of a participant's account to which they were not entitled, as a result of being less than fully vested shall be forfeited by the participant. Forfeitures could be used to pay administrative expenses, reduce employer matching and non-elective contributions. During the Plan ten months ended October 31, 2024, forfeitures of \$14,393 were used to reduce administrative fees. The Plan had unallocated forfeitures of \$0 and \$10,708 as of October 31, 2024 and December 31, 2023, respectively.
- i. **Termination of the Plan** – The Company terminated the Plan effective March 4, 2024 and contributions were stopped after the first pay period in April of 2024. No further contributions will be made to the Plan and all amounts credit to the active participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Effective, March 4, 2024, management terminated the Plan and at that time determined liquidation was imminent and began using liquidation basis of accounting.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

- c. **Investment valuation and income recognition** - Investments are reported at fair value. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and the Custodian. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

- d. **Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Allowance for credit losses of \$0 and \$22,136 have been recorded as of October 31, 2024 and December 31, 2023, respectively. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – The Plan allows certain administrative expense to be paid from Plan assets.

**3. Investments Certified by the Plan's Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the Custodian of the Plan as complete and accurate, and was not subject to any audit procedures, except for comparing the information with the related information included in the financial statements:

- a. Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of October 31, 2024 and December 31, 2023.
- b. Net appreciation in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits for the ten months ended October 31, 2024.

- c. Interest and dividends from investments and interest on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the ten months ended October 31, 2024.
- d. All the investment information included in the footnotes.

**4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets, unrestricted assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There has been no changes in the methodologies used at October 31, 2024 and December 31, 2023. During the ten months ended October 31, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

Collective investment trusts are stated at fair value as determined by the issuer and is based on the fair market value of the underlying investments, which is valued at net asset value (NAV) of units of the collective investment trusts and collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it determined to be probable that the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The Putnam Stable Value Fund (the Stable Value Fund) does have an equity wash rule that requires participants to transfer the Stable Value Fund to a non-competing fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Related Party and Party-in-Interest Transactions**

Certain administrative expenses, totaling \$22,400, were paid by the Company on behalf of the Plan for the ten months ended October 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

The Plan invests in collective investment trusts that are managed by Pensionmark Financial Group, LLC and WealthPath Investment Advisors. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments. The Plan also made direct payments to service providers and included in administrative expenses.

7. **Tax Status**

The Company adopted a Non-standardized Profit Sharing Plan with CODA (the Prototype Plan) sponsored by the Custodian. The Internal Revenue Service has informed the Prototype Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Prototype Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the favorable opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
