# The HTA Employees 401(k) Profit Sharing Plan

## Notes to Financial Statements December 31, 2024

### **1. Description of the Plan**

The following description of The HTA Employees 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan’s provisions.

#### General

The HTA Employees 401(k) Profit Sharing Plan is a defined-contribution plan. The Plan sponsor is Hoyle, Tanner & Associates, Inc. The Plan covers employees of Hoyle, Tanner and Associates, Inc. who meet certain age requirements discussed below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Eligibility

To be a plan participant, employees must have attained age 21 with no service requirement including leased employees, with the exception of persons who are covered under a collective bargaining agreement and nonresident aliens.

#### Contributions

Under the Plan, participants may elect to make pre-tax contributions ("deferrals") to their employee accounts up to the maximum percentage allowable subject to Sections 415(c), 402(g) and 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employer may make matching contributions and a profit-sharing contribution on a discretionary basis to employees meeting certain eligibility requirements. The discretionary employer matching contribution for each eligible participant was 50% of the participant’s elective deferrals that do not exceed 5% of the participant’s payroll period compensation. The discretionary match will be allocated to the participants accounts each payroll period. For the years ended December 31, 2024 and 2023, the employer did not make a profit-sharing contribution. The Plan allows for after-tax Roth contributions by employees.

Additionally, the Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to not participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation, as defined in the plan agreement.

#### Rollovers

With the approval of the plan administrator, the Plan may receive any amounts received by an employee as a distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

#### Participant Accounts

Each participant’s account is credited with the participant’s salary deferrals and allocations of (a) the employer’s matching contribution, if applicable, (b) employer profit-sharing contribution, if applicable and (c) plan earnings or losses and charged with administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## The HTA Employees 401(k) Profit Sharing Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### Investment Elections

Each participant shall direct the investment of their individual account among a selection of mutual funds and a common collective trust. Contributions may be allocated among one or more of the funds in increments of 1%, and each participant has the ability to change his or her investment allocations at any time.

##### Vesting

Participants in the Plan are immediately 100% vested in the current value of their pretax deferrals, actual earnings, discretionary employer matching and profit sharing contributions.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. Note terms range from one to five years. However, if the note is used for the purchase of a principal residence, the repayment period may exceed five years. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through bi-weekly payroll deductions.

##### Payment of Benefits

The Plan provides for participants to withdraw funds at any time after age 59 1/2. The Plan also provides for withdrawals in the event of death, disability, hardship and termination. On termination of service, a participant may elect to (1) receive a lump-sum amount equal to the value of his or her account; (2) receive installment payments; (3) roll over to a qualified plan or to an individual retirement account (IRA). However, participants with account balances greater than \$1,000 but less than \$5,000 who do not affirmatively elect to receive or rollover their distribution will have their account balance automatically rolled over into an IRA. The Plan's normal retirement age is 65.

##### Administrative Expenses

The Company pays certain costs to maintain the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles

requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in mutual funds are stated at fair market value based on the last quoted price as of the Plan year end. Investments in collective trusts are presented at net asset value, (NAV) as a practical expedient. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. In the statement of changes in net assets available for plan benefits, the Plan presents the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

##### Valuation Techniques

There have been no changes in the valuation techniques used during the current period.

##### Mutual Funds

Mutual funds are valued at the quoted market prices. These securities are categorized in Level 1 as they are actively traded, and no valuation adjustments have been applied.

##### Collective Trusts

Investment in the Great Gray Trust Retirement and Institutional Services Company Collective Investment Trust III for MetLife Group Annuity Contract No. 25554 (formerly Wilmington Trust) is valued based upon net asset value of shares held by the Plan at year end, as determined by the account manager, based upon quoted market prices of the underlying investments. The net asset value is used as a practical expedient.

The Great Gray Collective Trust was established to invest in MetLife Group Annuity Contract. The Contract is administered by MetLife and simulates the performance of a guaranteed investment contract through the guarantee of a specific interest rate and a portfolio of financial instruments that are owned by MetLife. This investment is designed to deliver safety and stability by preserving principal and accumulating earnings.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment

is recorded. Interest rate on outstanding loans at December 31, 2024 and 2023 were 4.25% to 9.50% with various maturities through March 2051.

##### Payment of Benefits

Benefit payments to participants are recorded when paid.

##### Subsequent Events

Events occurring after the statements of net assets available for benefits date are evaluated by the Plan to determine whether such events should be recognized or disclosed in the financial statements. The plan administrator has evaluated subsequent events through August 11, 2025 the date the financial statements were available to be issued.

#### **3. Information Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank, the trustee, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedules. The plan administrator has obtained a certification from Charles Schwab Trust Bank, as of December 31, 2024 and 2023, and for the year ended to December 31, 2024, stating that the information provided to the plan administrator by the trustee is complete and accurate. Such certified Plan information includes investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, investment transactions and note receivable transactions.

#### **4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds-valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust-valued at net asset value (NAV) as a practical expedient.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy. Participant-directed redemptions can occur daily and have no restrictions, and no unfunded commitments, however, the Plan is required to provide a 60-day redemption notice to liquidate its entire share in the fund.

**5. Related Party Transactions and Party-in-interest Transactions.**

Hoyle Tanner & Associates, Inc. provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services are contributing participants in the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Certain fees incurred by the Plan are included in net appreciation/depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments for investment advisory, record-keeping, trustee, participant distribution and loan fees of \$12,698 for the year ended December 31, 2024. However, under the provisions of ERISA these transactions meet the criteria for exemption, are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

Charles Schwab Trust Bank currently serves as the Trustee of the Plan. USI Consulting Group serves as the record-keeper and the Company serves as the plan administrator ("plan administrator").

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the employer has the right to terminate the Plan subject to the provisions of ERISA. The employer also has the right under the Plan to discontinue its contributions at any time.

#### **7. Tax Status**

The underlying pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
