Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Springfield Restaurant Group 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Springfield Restaurant Group 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the Springfield Restaurant Group 401(k) Profit Sharing Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the plan provisions.

- 1.) **General** - The Plan is a defined contribution plan covering substantially all employees of SRG, LLC ("SRG"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The employer and plan administrator, SRG, absorbs most of the administrative costs of the Plan. The plan administrator is responsible for oversight of the Plan, including determination of the appropriateness of the Plan's investing offerings and monitoring investment performance.

- 2.) **Participation Requirements** – An employee shall become a participant on the entry date coinciding with or next following the completion of one year of service, and the attainment of age 21.
- 3.) **Contributions** – Participants may elect to contribute, through the 401(k) feature, a percentage of their base salary or a fixed dollar amount each period, not to exceed the maximum amount permitted by the Internal Revenue Code. Participants may elect to have their contributions invested in various investment options administered by the Plan's custodian. The Company matches the participant's contribution in an amount equal to 10 percent of the participant's contribution, which is not in excess of 6 percent of the participant's eligible compensation. Contributions are subject to certain limitations.
- 4.) **Participant Accounts** – In accordance with the terms of the Plan, the account of each participant is maintained on a fair value basis. Participants' accounts consist of the contribution made on their behalf by SRG, their employee elective deferral contributions, their employee rollover contributions, and their share of investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 5.) **Investment of Contributions** – Participants shall direct the investment of all elective deferral, matching, and employee rollover contributions made on their behalf. The Plan offers various investment options under the custodial/trust agreement dated January 1, 2002. Participants may allocate their contributions in any proportion they choose among these options.

If the participant does not choose to direct the investment of his/her account, the account shall be invested ratably in the investment options available under the trust or group contract. Currently, all investments are considered to be participant directed.

- 6.) **Forfeitures** – Forfeiture of nonvested account balances will be used to offset the current-year employer contributions for that period in which they become available. The Plan had forfeitures of \$797 and \$1,023 used to offset employer contributions funded in the years ended December 31, 2024 and 2023, respectively.

- 7.) **Vesting** – Participants are immediately vested in their elective contribution accounts and qualified non-elective contribution accounts. They are entitled to their entire account balance if their participation ceases for any reason whatsoever.

If a participant's employment is terminated for reason of death, normal retirement (age 65), or retirement due to disability, the participant shall be entitled to the full account. If employment is terminated for any reason other than death, retirement, or disability, the participant shall be entitled to the vested portion of the employer-matching contribution account in accordance with the following schedule:

Less than one	- %
One but less than two	- %
Two but less than three	20 %
Three but less than four	40 %
Four but less than five	60 %
Five but less than six	80 %

- 8.) **Payment of Benefits** – If the vested account of the participant has never exceeded \$1,000, the entire vested account shall be payable in a single lump sum as of the earlier of the participant's retirement date, the date the participant dies, or the date the participant ceases to be an employee of SRG for any other reason.

If the vested account of the participant exceeds \$1,000 and the participant has not made a qualified election in writing with respect to the optional forms of benefit distributions described in the paragraph below within the 90-day period ending on the date benefit payments would commence, a participant's vested account balance will be paid in the form of a qualified joint and survivor annuity on the date payments are to commence.

If a participant elects to take their retirement benefit in a form other than a qualified joint and survivor annuity, the participant may choose one of the following optional forms of distribution of benefits:

- a) Lump-sum cash payment
- b) Straight life annuity

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- 1.) **Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.
- 2.) **Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

- 3.) **Payment of Benefits** - Benefits are recorded when paid.
- 4.) **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.
- Purchases and sales of securities are recorded on a trade-date basis. Interest Income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- 5.) **Plan Expenses** – Certain administrative functions are performed by employees of SRG. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by SRG.
- 6.) **Subsequent Events** – The Plan has been evaluated through August 1, 2025, which is the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FSB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical assets in inactive markets
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE C – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Variable Annuities – Valued using pricing models maximizing the use of observable inputs for similar securities.

Guaranteed Investment Contract – Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial reporting purposes only. In determining the reasonableness of the methodology, the investment committee evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate). The guaranteed investment contract is not actively traded.

NOTE D – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive investment contract with Empower Retirement. Empower Retirement maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract issuer is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Retirement, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Fair value of the investment contract approximates contract value at December 31, 2024 and 2023.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate and the net actual earnings rate for the contract was 2.80% and 1.35% at December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE E – INFORMATION CERTIFIED BY TRUSTEE

The investment information included in the accompanying financial statements and supplemental schedule was obtained from the data that has been prepared and certified to as complete and accurate by Empower Retirement for the years ended December 31, 2024 and 2023.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE G – INCOME TAX STATUS

SRG has no determination letter from the Internal Revenue Service indicating that the Plan is qualified and the trust established under the Plan is tax-exempt. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - PLAN TERMINATION

SRG expects to continue the Plan indefinitely, but is not contractually bound to do so. In order to protect both employees and SRG against any unforeseen contingencies, SRG reserves the right to amend the Plan, or to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants' accounts are to be paid in the time and manner set forth in the Plan's agreements.

NOTE I – PARTY-IN-INTEREST TRANSACTIONS

SRG absorbs some costs incurred in relation to the administration of the Plan. Such costs include legal, recordkeeping, and accounting fees. These costs amounted to \$13,920 and \$14,323 for the years ended December 31, 2024 and 2023, respectively.
