Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tree Top, Inc. Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tree Top, Inc. Salary Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Tree Top, Inc. Salary Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Tree Top, Inc. Salary Savings Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Tree Top, Inc. Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all salaried and administrative employees of Tree Top, Inc., and its affiliates (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator.

Eligibility requirements – To become an eligible participant, the employee must have completed 90 days of service, as defined by the Plan document, as a salaried employee of the Company.

Contributions

Participant – The Plan provides for contributions to be made by electing employees (herein referred to as participants) under a salary-reduction agreement up to the maximum deferral limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan has an automatic enrollment feature. All newly eligible participants are automatically entered into the Plan and have a default contribution amount of 3% of eligible wages. The participant's default investment fund is the T. Rowe Price Target Date Retirement Fund, as determined by the participant's age. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 10%.

Employer – Each payroll period the Company makes a matching contribution to each eligible participant equal to 100% of the first 4.5% of compensation that the participant defers.

Participants are eligible to receive a discretionary retirement contribution from the Company as long as they are employed by the Company on the last day of the Plan year or terminated within the Plan year due to death, disability, or retirement at or after the Participant attains age 55. In addition, the Retirement Committee adopted an amendment to the Plan that the Company may make a discretionary retirement contribution at a variable percentage of eligible wages to certain former participants of the Tree Top, Inc. Pension Plan (a defined benefit pension plan). There were no discretionary retirement contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to regulatory limitations.

Tree Top, Inc. Salary Savings Plan Notes to Financial Statements

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers registered investment companies and collective trusts as investment options. A participant may also be permitted, at the discretion of the Plan administrator, to invest any portion of his/her account balance in specific assets, specific funds, or other investments permitted under the Plan and the directed investment procedure; these investments are referred to herein as self-directed securities. Self-directed securities do not share in earnings realized on the above-mentioned registered investment companies and collective trusts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their salary deferrals plus actual earnings thereon. The Company's discretionary matching contributions plus actual earnings thereon are 100% vested upon entry into the Plan and nonforfeitable at all times. The portion of a participant's account that is derived from discretionary retirement contributions shall be 100% vested after the participant completes three years of service with the Company.

Notes receivable from participants – Participants may borrow from their accounts upon approval by the Plan administrator. The amount of the loan is limited to one-half of the total value of the participant's vested account balance, up to \$50,000, with a minimum of \$500. A participant may have up to two loans outstanding at any time. Loans are issued by the Plan and secured by the balance of the participant's account. All loans must be repaid within a period of five years unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time. In addition, the Committee adopted an amendment to the Plan that requires the participant to wait a minimum of 30 days after borrowing before requesting another loan from the Plan. The fixed interest rate charged is 100 basis points above the prime lending rate of T. Rowe Price Trust Company in effect on Monday of the week in which the loan is requested. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through September 2032.

Payment of benefits – Upon normal retirement, retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their vested account balances, in accordance with the provisions of the Plan, in the form of single lump sum, partial payments, or in installment payments. In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested account balance in a lump sum distribution, or the beneficiary may elect an alternative form of payment allowed by Plan provisions. If a terminated participant's vested account does not exceed \$1,000, distribution shall be made in a lump sum as soon as practicable following termination of employment and after the amount can be determined in accordance with the Plan provisions.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and can be used to reduce future Company contributions or pay the Plan's expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,451 and \$11,773, respectively. For the year ended December 31, 2024, Company matching contributions were reduced by \$11,871, and expenses were reduced by \$0 from forfeited nonvested accounts. For the year ended December 31, 2023, Company matching contributions were reduced by \$14,000, and expenses were reduced by \$4,072 from forfeited nonvested accounts.

Tree Top, Inc. Salary Savings Plan Notes to Financial Statements

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, T. Rowe Price Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – The Company pays the legal and accounting fees of the Plan, which are excluded from these financial statements. Certain administrative expenses related to operating and maintaining the Plan are paid by the Company. Other administration expenses and certain investment and transaction fees are paid by participants in the Plan.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

Tree Top, Inc. Salary Savings Plan Notes to Financial Statements

The Plan has evaluated subsequent events through August 5, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any relevant input that is significant to the fair value measurement. Valuation techniques maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trust – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The Plan invests in the following significant collective trust fund: the T. Rowe Price Stable Value Fund. The collective trust funds included in Plan assets do not have unfunded commitments or restrictions on the ability of a participant to redeem the fund as of the measurement date.

Self-directed brokerage accounts – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Note 4 – Certified Investment Information

- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Notes to Financial Statements

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated July 21, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Party-in-Interest

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by affiliates of T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee of the Plan; therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan for services to affiliates of T. Rowe Price Trust Company were \$26,922 and \$31,183 for the years ended December 31, 2024 and 2023, respectively.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 9 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor during 2023. The Company has determined the amount of related lost earnings and has remitted these amounts to participants' accounts during 2024.
