Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Akeela, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

NOTE A – DESCRIPTION OF PLAN

The following description of the Akeela, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan originated July 1, 2008, and is a defined contribution plan covering substantially all employees of Akeela, Inc., (the Sponsor). All employees, who attain the age of 21 years are eligible to participate in the Plan without regard to service except: employees who are union members and are not covered by a collective bargaining agreement that provides for coverage under the Plan; and individuals that are classified by the Employer as an independent contractor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Contributions to the Plan are based on taxable compensation and are made as follows:

Salary Deferrals – Active participants may elect to make tax deferred contributions to the Plan, not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Eligible participants age fifty and over may defer an additional \$7,500 and \$7,500 of catch-up contributions for the years ended December 31, 2024 and 2023, respectively. This limit may be reduced for participants covered by more than one retirement plan. The participant may elect to make pre-tax 401(k) contributions and/or Roth 401(k) contributions to the Plan.

Qualified Non-elective Contributions: Active participants are eligible for matching employer contributions and Safe Harbor Non-Elective contributions after the completion of one year of eligible service, 500 hours of service, and having reached the age of 21. Employer contributions are paid to eligible participants beginning on the first day of the month that coincides with or immediately follows the date the eligibility requirements are met.

The Employer match of the salary deferrals will not exceed 2% of the participant's eligible wages. All employees who are eligible participants receive the 3% Safe Harbor Non-Elective contribution.

Participant Accounts. The Plan is a Section 404(c) plan wherein the participant exercises control over the assets in his/her account. The participant is responsible for the investment decisions relating to those assets. Each participant's account is credited with the participant's contribution, employer matching or non-elective contributions (if any), and investment earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting. Participants are immediately 100% vested in salary deferrals including Roth 401(k) deferrals and catch-up contributions, rollover contributions, Safe Harbor contributions, and matching contributions.

Notes to Financial Statements, Continued

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate between 5.25% and 9.0% which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions. The loan term shall be no greater than five years, except in the case of a loan used to acquire any dwelling unit which within a reasonable period of time is to be used as a principle residence of the participant. Loans are measured at their unpaid principal balance plus accrued but unpaid interest.

Payments of Benefits. Upon attaining the age of 59 ½, death, disability or termination of employment, a participant, or his or her beneficiary, may elect to receive a lump-sum amount equal to the participant's vested account balance. Required distributions begin no later than the 1st of April following the later of the end of the year in which you reach age 72 or retire.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest is recorded as earned on the accrual basis. The difference in market value from one period to the next is included in net appreciation (depreciation) in fair value of investments in the accompanying Statement of Changes in Net Assets Available for Plan Benefits. The net appreciation (depreciation) in fair value of investments also includes realized gains and losses on investments sold during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Benefit Payments. Benefits paid to participants and beneficiaries are recorded upon distribution.

Administrative Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Use of Estimates. The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

NOTE C – INVESTMENTS CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY (U.S.A.)

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the following information was certified by John Hancock Life Insurance Company (U.S.A.) to be complete and accurate:

- (a) Investments, at fair value and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits;
- (b) Interest and dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits; and
- (c) All information included in the Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as shown in the supplemental schedule.

NOTE D – PLAN TERMINATION

While it is the intention of the Sponsor to continue the Plan indefinitely, the Sponsor may terminate the Plan in its entirety at any time subject to the provisions of ERISA. Plan termination would have no effect on employee vesting because employees are always 100 percent vested in employer contributions.

NOTE E – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board issued authoritative guidance establishing a framework for measuring fair value. That framework provides a fair value hierarchy based on the inputs used to measure fair value and expanding disclosures about the use of fair value measurements. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurements requires judgment and may affect the valuation of the assets and liabilities being measured and their level within the fair value hierarchy.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at December 31, 2024 and 2023.

Pooled separate accounts: According to the Plan custodian, the pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. John Hancock Life Insurance Company (U.S.A.) owns the underlying investments in separate accounts. While the underlying asset values are quoted prices, the NAV (net asset value) of a separate account is not publically quoted.

NOTE F – INVESTMENT OPTIONS

The Plan has entered into an investment contract with John Hancock Life Insurance Company, USA. John Hancock Life Insurance Company, USA maintains certain of the Plan's assets as follows:

Pooled Separate Accounts - these accounts hold assets allocated to each separate account. The value of each separate account is determined at the close of each business day based on fair value. These accounts are separate accounts (not part of John Hancock Life Insurance Company, USA's general account (i.e. segregated)); income, gains, or losses from the assets in each account are credited to or charged against that account without regard to other income, gains or losses of John Hancock Life Insurance Company, USA or any other separate account.

NOTE G – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in various instruments offered by the John Hancock Life Insurance Company. These transactions qualify as party-in-interest transactions. Any transactions involving these investments are on the open market at fair value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE H – TAX STATUS

The Plan has not received an opinion from the Internal Revenue Service regarding the Plan's qualifications. However, the Plan has been submitted for review as a Volume Submitter Plan. The form of the Plan was determined to be acceptable by the Internal Revenue Service under Section 401 of the Internal Revenue Code by a letter dated July 7, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's policy is to report interest and penalties associated with uncertain tax positions, if any, as administrative expenses. With few exceptions, the Plan is no longer subject to examination by federal tax authorities for years before 2021.

NOTE I – RISKS AND UNCERTAINTIES

The Plan has placed its investments with John Hancock Life Insurance Company. Investment securities are exposed to various risks such as interest rate, market, and credit risks. This institution has professionally managed money market funds and investment funds whose investments consist of numerous and diverse pooled separate accounts. As part of the Plan's investment strategy, the trustees perform periodic evaluations of the relative credit standing and investment performance of financial institutions.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 7, 2025, the date which the financial statements were available for issue. No events were identified that would require adjustment or disclosure according to generally accepted accounting principles.
