Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Adolfson & Peterson, Inc. Salary Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Adolfson & Peterson, Inc. Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Adolfson & Peterson, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Retirement Plan Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Participation: All employees, except interns and employees covered by a collective bargaining agreement, are eligible to participate in the Plan immediately following attainment of age 18. Part-time, temporary, and seasonal employees are eligible to participate in the Plan upon completing 1,000 hours of service during the plan year. The Plan includes an automatic enrollment provision whereby all eligible employees are automatically enrolled in the Plan after 30 service days unless they affirmatively elect to not participate in the Plan or elect to participate in the Plan sooner than 30 service days. The effective date of participation is the first date on which the eligibility requirements are satisfied.

Contributions: Participants can make voluntary pretax and Roth contributions up to 100% of their eligible compensation, as defined by the Plan, up to the maximum permitted by law. In the absence of a deferral election, participants are automatically enrolled in the Plan at a deferral percentage of 6% of pay for the initial enrollment, increasing 1% annually, up to a maximum of 10%, unless changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from qualifying benefit plans of previous employers. In addition to participants' contributions, the Employer may elect to make a discretionary matching contribution. The Employer authorized a matching contribution equal to 50% of the participant's salary deferral up to 6% of the participant's compensation resulting in a 3% maximum match for the year ended December 31, 2024. The Employer may also make a discretionary profit sharing contribution. To qualify for the discretionary profit sharing contribution, the participant must have 1,000 hours of service during the plan year as well as be employed on the last day of the plan year. The Employer did not make a discretionary profit sharing contribution for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Employer matching contributions, if any, and an allocation of: (a) the Employer's discretionary profit sharing contribution, if any, and (b) investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on earnings, account balances or specified transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and earnings thereon. Employer matching and profit sharing contributions and earnings thereon, are also vested immediately.

Benefit payments: Upon a participant's death, permanent disability, retirement or other termination of employment, a participant, or the participant's beneficiary, whose vested account balance exceeds \$5,000 may elect to receive a distribution equal to the value of his or her vested account balance in the form of a lump-sum distribution or in installments over varying periods. Participants with hardships and those reaching the age of 59½ may also receive benefit payments. If, at the time a participant is terminated, their account balance is less than \$1,000, it will be automatically distributed to the participant in a lump sum. If a terminated participant has a balance between \$1,000 and \$5,000, and the participant has not elected otherwise, it will be transferred into a qualified individual retirement account for the participant.

Note 1. Description of the Plan (Continued)

Forfeitures: As of December 31, 2024 and 2023, the Plan had forfeited nonvested accounts of approximately \$14,000 and \$12,000, respectively. Forfeited nonvested accounts are retained in the Plan and used to pay Plan expenses or partially fund Employer contributions. For the year ended December 31, 2024, approximately \$14,000 of forfeited nonvested accounts were used to fund Employer matching contributions.

Investment options: Participants are allowed to invest in a variety of investment options, as more fully described in the Plan's literature. The funds vary in type of investments, rates of return, and investment risk. Participants may elect to have all or part of their balances and future contributions transferred from one investment option to another or in any combination. Participants may change their investment options daily.

Note 2. Significant Accounting and Plan Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note 4 for a discussion of fair value measurements. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee, and custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefit payments: Benefit payments to participants are recorded when paid.

Administrative expenses: The Employer pays certain, but not all, administrative costs of the Plan. The expenses paid directly by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties: The Plan provides for investments in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: Plan management, in preparing the financial statements and notes thereto, has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy, that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Shares of registered investment companies (mutual funds) are valued at the quoted market price of shares held by the Plan at year-end.

Pooled separate account: The pooled separate account is valued at the net asset value (NAV) of units held by the Plan at year-end, which is based on quoted prices for similar assets traded in active markets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The method described above may produce fair values that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan has a traditional group annuity contract with Empower Annuity Insurance Company that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a fixed-annuity general account product and meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without penalty. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%.

The Plan held \$4,690,876 and \$4,608,509 of traditional investment contracts, at contract value, as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5. Fully Benefit-Responsive Investment Contract (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including a complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

The group annuity contract does not have a scheduled maturity date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

The Plan adopted a preapproved plan document that has received an opinion letter from the IRS dated November 14, 2022, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related Party and Party-in-Interest Transactions

Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodian and trustee, respectively, hold the Plan's assets and execute transactions, and the Plan holds a group annuity contract that is a general account product of Empower Annuity Insurance Company of America. Therefore, these transactions qualify as party-in-interest transactions.

Note 9. Nonexempt Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$179 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor corrected this failure in 2024. The correction was made from the Plan Sponsor's assets and not from assets of the Plan.
