Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PFL Tech, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF THE PLAN

The following description of PFL Tech, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan is a voluntary defined contribution plan qualifying under Section 401(k) of the *Internal Revenue Code of 1986* (IRC). It covers all employees of PFL Tech, Inc. (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan is a single-employer plan. The Plan was originally established at January 1, 2006, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Contributions Participants may elect to contribute to the Plan, in the form of pre-tax or after-tax (Roth) deferrals up to the lesser of 90% of their eligible compensation or the maximum amount allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of the first 4% of the eligible participant's compensation deferred to the Plan.

Automatic Enrollment Employees eligible to participate in the Plan are automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment is 4% of eligible compensation on a pre-tax basis, to be invested in a specific pre-selected investment offering. Unless otherwise elected by the participant, pretax deferrals for automatically enrolled participants increase by 1% each December 20th, up to a maximum of 10%. This annual increase does not apply within the first six months following a participant's automatic enrollment.

Participant Accounts Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of Plan earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately fully vested in all contributions and earnings thereon.

Notes Receivable From Participants Loans are not permitted by the Plan.

Payment of Benefits Upon termination of service, due to death, disability, or retirement, participants may elect to receive a lump-sum amount equal to the vested value of their account. If the participant does not initiate a withdrawal and the value of his or her vested account is less than \$1,000, the vested account balance is distributed to the participant, regardless of consent. If the participant's vested account balance is between \$1,000 and \$5,000, the participant must withdraw the vested account balance from the Plan or the Company will roll it to an individual retirement account. Participants with vested account balances greater than \$5,000 may delay distributions until required by law to receive required minimum distributions. Participants may make withdrawals from their account representing participant deferrals prior to termination of employment for hardships, subject to a \$500 minimum amount and limitations imposed by the IRC. Participants are entitled to receive a distribution of all vested account balances upon attainment of age 59½.

Forfeitures Forfeitures result from excess aggregate contributions. Forfeitures are held in a separate suspense account and can be used to reduce Company safe harbor matching contributions and Plan expenses. Forfeitures in the amount of \$1,147 and \$28 were used to reduce Company safe harbor matching contributions for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, there were unallocated forfeitures of \$-0- and \$1, respectively.

Plan Termination Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, partially terminated, or if there is a complete discontinuance of contributions by the Company, all amounts credited to the accounts of participants shall vest and become nonforfeitable.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: Valued at the NAV per unit as reported by the issuer of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits Benefits are recorded when paid.

Expenses Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Reclassifications Certain amounts in the December 31, 2023, financial statements have been reclassified for comparative purposes to conform to the presentation in the December 31, 2024, financial statements.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, the Trustee of the Plan's investment assets, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule. Fidelity Management Trust Company is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company is the administrator of the Plan. The Plan's administrator may designate other persons to carry out the day-to-day operations of the Plan. Plan investments are managed by Fidelity Management Trust Company, the Trustee of the Plan. The Plan paid administrative expenses to the Trustee amounting to \$58,309 and \$53,409 during the years ended December 31, 2024 and 2023, respectively. LPL Financial, LLC (LPL) is the plan investment advisor. The Plan paid administrative expenses to LPL amounting to \$27,189 and \$23,282 during the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other expenses related to the Plan's operations.

6. TAX STATUS

The Plan has adopted a pre-approved nonstandardized profit sharing plan established by Fidelity. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

Effective April 1, 2025, the Plan was amended to incorporate several withdrawal provisions in accordance with SECURE 2.0 Act: Domestic Abuse Withdrawal, Emergency Expense Withdrawal, Federally Declared Disaster Withdrawal, and Qualified Birth or Adoption Distribution.

On July 7, 2025, the Company was acquired by Vomela Holdings, LLC through a merger transaction. The Company became a wholly owned subsidiary and continues to operate as a separate legal entity. As of the date the financial statements were available to be issued, no changes to the Plan's operations, benefit structure, or service providers had been announced or implemented. Management is currently evaluating the potential impact of the merger on the Plan, including any changes to governance, funding arrangements, or participant communications. The Plan will continue to operate in accordance with its governing documents and applicable regulations under ERISA.
