Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bridgewater Bank 401(k) Safe Harbor Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, schedule H, line 4i-schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the Bridgewater Bank 401(k) Safe Harbor Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Bridgewater Bank (the "Company"). Eligible employees are employees who have attained the age of 21 or older. Upon satisfying the eligibility requirements, an employee is eligible to participate in the Plan on the first day of the quarter on or after the employee's hire date. Effective February 1, 2024, the Plan adopted an automatic enrollment feature. Newly eligible employees are automatically enrolled in the Plan at a pretax deferral rate of 4% of eligible compensation unless the employee affirmatively elects a different percentage or opts out of participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a percentage of pretax and roth after-tax annual compensation (as defined by the Plan), not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans as well as Individual Retirement Accounts.

The Company contributes a safe harbor matching contribution equal to 100 percent of participant salary deferrals up to 4% of compensation. The Company may also contribute a discretionary profit-sharing contribution to the Plan as determined annually by the Company's Board of Directors. For the year ended December 31, 2024, discretionary profit-sharing contributions were made in the amount of \$839,740.

Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers investments in various mutual funds and common collective trusts. Contributions are subject to certain limits.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's contributions, b) Plan earnings and c) Plan expenses. Allocations are based upon participant compensation, contributions and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary profit-sharing contribution portion of their accounts plus earnings thereon become 20% vested after two years of credited service. The vesting percentage increases an additional 20% each year thereafter, with 100% vesting after six years of credited service. Participants will vest 100% upon death, disability or retirement while employed by the Company.

(1) Description of the Plan (Continued)

Payment of Benefits

Upon termination of service, a participant will receive a lump-sum amount if the total of their vested account balance does not exceed \$1,000. If the vested account balance exceeds \$1,000, the assets will generally continue to be held in the Plan until the participants' normal or early retirement date. However, terminated participants may elect to receive their vested account balance at any time. Upon death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum payment or partial payments. The Plan also allows for certain hardship withdrawals of elective deferrals.

Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Administrative Expenses

Processing fees of the Plan are charged against the individual participant account balance that was responsible for the expense. Administrative expenses are paid by the Plan or may be paid by the Company at the Company's discretion.

Forfeited Accounts

Forfeitures are based on the non-vested portion of the Company's profit-sharing contribution upon employee termination. Forfeited amounts are used to reduce administrative expenses and Company contributions. There were no forfeitures used to reduce administrative expenses for the year ended December 31, 2024. The balance of unallocated forfeitures available to offset future administrative expenses and employer profit-sharing contributions amounted to \$66,476 and \$67,081 at December 31, 2024 and 2023, respectively. Subsequent to year-end, \$66,723 of forfeitures were applied to the payment of profit-sharing contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

(2) Summary of Significant Accounting Policies (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) Information Certified by the Qualified Institution

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA - required supplemental schedule, that was prepared by or derived from information provided by Ascensus, as agent for Ascensus Trust Company (Ascensus) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the qualified institution that the information provided to the Plan Administrator by the qualified institution related to the following assets is complete and accurate.

Ascensus also certified the completeness and accuracy of \$4,587,065 of net appreciation in fair value of investments and \$734,518 of interest and dividends related to the aforementioned investments for the year ended December 31, 2024.

(4) Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quotes prices for identical or similar assets or liabilities in inactive markets; inputs or other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023, and there have been no transfers between fair value levels.

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end, quoted in an active market.

Common Collective Trusts: The fair values of participation units held in common collective trusts are based on the NAV reported by the fund managers as of the financial statement dates and recent transaction prices. Under ordinary market conditions, redemptions of investments in collective trusts are permitted as of daily or monthly valuation dates, as applicable, and are executed at NAV as a practical expedient.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Tax Status

The Company has adopted the Plan based on a prototype plan document sponsored by Ascensus, Inc. Ascensus, Inc. has received an opinion letter from the Internal Revenue Service ("IRS") that states that the form of the prototype plan is acceptable under applicable sections of the Internal Revenue Code ("IRC"). The Company and the plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has confirmed that there are no uncertain positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Party-in-Interest Transactions

During the course of the year, the Plan may enter into certain party-in-interest transactions with the Company or its holding company, Bridgewater Bancshares, Inc. The Company may provide a discretionary contribution to the Plan's participants, which is based on the earnings of Bridgewater Bancshares, Inc. A discretionary profit-sharing contribution of \$839,740 was made for the year ended December 31, 2024.

Fees paid to Ascensus Trust Company, the trustee, and The Vanguard Group, the recordkeeper, qualify as party-in-interest transactions under ERISA. Fees paid directly by the Plan to The Vanguard Group, Inc. for recordkeeping and other administrative services totaled \$29,668 for the year ended December 31, 2024.

(7) Subsequent Events

Subsequent events have been evaluated through July 25, 2025, the date the financial statements were available to be issued.
