Independent Auditors' Report

To the Board of Trustees of
Dealers - Unions Insurance Fund
Cleveland, Ohio

Opinion

We have audited the financial statements of the Dealers - Unions Insurance Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Fund as of October 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Fund's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. The supplemental schedules of administrative expenses for the years ended October 31, 2024 and 2023 are presented for purposes of additional analysis and are not a required part of the financial statements. These supplemental schedules are the responsibility of the Fund's management and are derived from and relate directly to the underlying accounting and other records used to prepare the financial statements. The supplemental schedules have been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the supplemental schedules are fairly stated in all material respects in relation to the financial statements as a whole.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Fund Operations

Participants should refer to the plan document for a more complete description of the Dealers - Unions Insurance Fund's (the "Fund") provisions. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Fund, established October 27, 1955, is both a contributory and noncontributory health and welfare benefit plan primarily for employees and certain retirees of corporations which render services in connection with enfranchised automobile dealerships. These employers include the Fund, Local 1363 of the IAMAW and any employer who has a collective bargaining unit with Local 1363, Teamsters Local 964 and any another labor organization which agrees to contribute to the Fund. During the years ended October 31, 2024 and 2023, 25 and 22 employers, respectively, contributed to the Fund on behalf of their employees and certain retirees. The spouses and dependent children of active participants are also covered.

Retired participants under the age of 65 and participants receiving benefits under the Consolidated Omnibus Budget Reconciliation Act of 1985 contribute to the Fund based on various rates in effect, which can be obtained from the plan administrator. These participants are responsible for 100% of the premiums related to the coverage obtained.

The Fund is a fully insured Plan for medical, dental, vision, prescription drugs and life/accidental death and dismemberment benefits. Dental benefits are provided by Guardian. Medical Mutual of Ohio ("MMO") provides vision benefits, prescription drugs benefits, medical benefits, life insurance and accidental death and dismemberment insurance benefits. The disability benefits are self-insured. The services of accounting, printing, recordkeeping and the processing of disability claims have been outsourced to a third-party administrator.

The Fund provides for a Board of Trustees consisting of one employer representative and one employee representative. Each holds a 50% vote.

The Board of Trustees, as plan sponsor, has the right under the Plan to modify benefits provided to active and retired participants. The Plan may be terminated only by joint agreement between industry and union, subject to the provisions set forth in ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Fund are presented on the accrual basis of accounting which recognizes income in the period earned and expenses in the period they are incurred. Benefits are recorded when paid.

Fund management has evaluated subsequent events through August 13, 2025, which is the date the financial statements were available to be issued.

Non-Interest Bearing Cash – The Fund places its temporary cash with a national financial institution which may at times exceed federally insured amounts. The actual balance may exceed reported balances due to outstanding checks.

Note 2. Summary of Significant Accounting Policies (Continued)

Recognition of Contribution Revenue – Contribution revenue is recognized in the month for which coverage is being paid. Contributions received after the coverage months are recorded as receivables and contributions received prior to the month of coverage are recorded as deferred revenue. In 2024 and 2023, one employer accounted for 12% and 11%, respectively, of total employer contributions.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Disability Benefits – Plan obligations at October 31st for future disability payments to participants considered disabled are estimated by the administrator. The administrator has estimated this liability to be minimal at October 31, 2024 and 2023. Therefore, no liability has been recorded for disability benefits. Because these liabilities are estimates, it is at least reasonably possible that a change in these estimates will occur in the near term.

Note 3. Payments Upon Termination of the Fund

In the event of termination of the Fund, the Board of Trustees will distribute any surplus funds in the manner it deems will best effectuate the purpose of the Fund in accordance with ERISA.

Note 4. Income Tax Status

The trust established under the Fund obtained its latest determination letter on December 1, 1993, in which the Internal Revenue Service stated that the trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator believes that the trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Fund's financial statements.

The plan administrator has analyzed the tax positions taken by the Fund and has concluded that, as of October 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.
