1. Description of Plan

The following description of Gunderson Dettmer Stough Villeneuve Franklin & Hachigian, LLP Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees and partners, excluding leased employees, of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The "Plan Administrator" is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 50% of their pretax annual compensation, as defined by the Plan. Participants may choose to make contributions to the Plan on an after-tax basis, by designating their salary deferrals as Roth deferrals. Participants may elect to convert all or any of their non-Roth vested account balance from any contribution source to a Roth Conversion account upon the attainment of age 35 for employer contributions or matching contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan or may choose their own investments through self-directed brokerage accounts ("SDA").

Upon becoming eligible, new participants to the Plan are automatically enrolled to contribute 3% of compensation to the Plan. The contribution percentage automatically increases by 1% every year until it reaches the maximum of 10%. The automatic deferral and increases apply unless the participant makes an affirmative election to opt out of the feature.

Profit sharing amounts may be contributed at the option of the Plan Sponsor if the participant is still employed on the last day of the Plan year. Eligible participants will receive a profit-sharing contribution as follows:

- a) If the participant is classified as a non-attorney (staff) employee, the participant will receive a profit-sharing contribution equal to a percentage of pay that is determined each year. Participation begins on the next January 1st or July 1st on or following the date on which the participant completes two years of eligibility service, as defined under the Plan. For Plan year 2024 and 2023, the profit-sharing contribution percentage is 8%.
- b) If the participant is classified as a partner, the participating partner will receive a profit-sharing contribution determined each year. Participation begins on the first day of the month coinciding with or next following the date on which the participant becomes a partner. For Plan year 2024 and 2023, the profit-sharing amount for partners is \$46,000 and \$43,500, respectively.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Vesting

Participants are vested immediately in their contributions and the Partnership's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts to the lesser of \$50,000 or 50% of their account balance. However, the amount of any new loan shall not exceed \$50,000, reduced by the highest outstanding loan balance of the participant during the preceding twelve months. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as defined by Matrix Trust Company. If the loan is for the purchase of a participant's principal residence and the term is greater than 5 years, the interest rate is set at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or a portion of their vested account balance. The vested account balances of terminated participants are automatically distributed if the vested account balance does not exceed \$1,000 and the distribution is not timely initiated by the participant. The vested account balance of terminated participants is automatically rolled over to an individual retirement account established for the participant if the vested account balance is between \$1,000 and \$5,000 and the distribution is not timely initiated by the participant. In-service distributions of employee deferral contributions are permitted after attaining age 59 ½ and from employer contributions after attaining age 62. In-service hardship distributions are permitted if certain criteria are met. A partial distribution will not be allowed in an amount less than \$5,000, nor may a participant take more than two partial distributions in a calendar year.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 - Fair Value Measurements for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, one investment represented a concentration of greater than 10% of the Plan's net assets available for benefits.

Reporting on Individually Directed Accounts

The Plan allows participants to choose their own investments through SDA's. The Plan Sponsor applies the provisions of ASC 962, *Plan Accounting - Defined Contribution Pension Plan*, which allows presentation of participant-directed investments as one line item in the statements of net assets available for benefits.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Investments in non-publicly traded companies are valued using pricing models maximizing the use of observable inputs for similar securities, including basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Common/Collective Trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments with respect to the Plan's investments in these funds. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Based on information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024 and 2023. Accordingly, the trustees of the Plan's assets has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, as well as the supplemental schedule of assets (held at end of year) as of December 31, 2024.
- Net appreciation in fair value of investments, interest, dividends, and other income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Matrix Trust Company, the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in interest transactions.

OneAmerica Retirement Services LLC is the Plan's recordkeeper and provides certain administrative services to the Plan pursuant to a Defined Contribution Plan Service Agreement ("DCPSA") between the Company and OneAmerica Retirement Services LLC. OneAmerica Retirement Services LLC receives revenue from mutual fund service providers for services OneAmerica Retirement Services LLC provides to the funds.

This revenue is used to offset certain amounts owed to OneAmerica Retirement Services LLC for its administrative services to the Plan. If the revenue received by OneAmerica Retirement Services LLC from such mutual fund service providers exceeds the amount owed under the DCPSA, OneAmerica Retirement Services LLC remits the excess to the Plan's trust on a periodic basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to OneAmerica Retirement Services LLC for administrative expenses not covered by revenue sharing. Refer to Schedule C, Service Provider Information, of the Form 5500 for the fees incurred in the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts.

7. Tax Status

The Company has adopted a prototype plan, which received an opinion letter from the IRS dated August 19, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

The Plan evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
