Opinion

1. Description of the Fund

The following description of the Livermore Class Action Settlement Administration and Education Fund, Inc. Retiree Health Reimbursement Arrangement (the "Plan") provides only general information. Participants should refer to the Summary Plan Description and Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established, effective as of January 1, 2021, as a result of the settlement of Requa/Moen v. Regents of Univ. of Cal., Alameda Superior, Court Case No. RG 10530492, pursuant to the Stipulation of Class Action Settlement and Release dated on or about December 11, 2019 (the "Settlement Agreement") between the Regents of the University of California and certain retirees of the University of California who worked at the Lawrence Livermore National Laboratory ("Class Members"). The Alameda Superior Court granted final approval and entered judgment on April 10, 2020. The Plan provides reimbursement to participants for the purchase of health insurance or any other eligible medical expenses. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Administration of the Plan

The Plan is administered by the Livermore Class Action Settlement Administration and Education Fund, Inc. (the "Company"). The Company has contracted with Extend Health, LLC, an affiliate of Willis Towers Watson, to provide recordkeeping and administrative services with respect to the Plan.

Benefits

The Plan provides reimbursement to participants for eligible medical expenses that are not otherwise reimbursed by any other plan or program.

Funding

The Plan is funded in accordance with the Settlement Agreement and generally through the Livermore Retirees Health Insurance Trust (the "VEBA"), a voluntary employees' beneficiary association under Section 501(c)(9) of the Internal Revenue Code of 1986, as amended. Argent Trust Company is the trustee of the VEBA. During 2021, the Plan was partially funded by the VEBA and partially with settlement proceeds paid directly from the settlement administrator. The Settlement Agreement anticipates that the VEBA will fund the Plan until the earlier of December 31, 2040, or until 1,000 or fewer Class Members are living.

Forfeitures

A deceased participant's account balance will be forfeited immediately upon the participant's date of death if the participant did not have eligible beneficiaries. Medical claims incurred prior to death will be paid if claims are submitted within 180 days of the participant's death.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions which affect the reported amounts of assets, liabilities and postretirement benefit obligations and the disclosure of contingencies, if any, as of the date of the statements of net assets available for benefits and changes therein during the reporting period. Actual results could differ from those estimates.

Recognition of Benefits

Benefits are recognized when paid.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through August 11, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.

3. Priorities Upon Termination

Although the Board of Trustees has not expressed any intention to do so, the Plan may be terminated at any time. Upon termination of the Plan and liquidation of the Trust, all assets remaining after paying all accrued debts and liabilities shall be distributed by any means approved under ERISA, and the regulations issued thereunder, and used exclusively for the benefit of Plan participants.

4. Tax Status

The Plan is intended to qualify as a self-insured medical reimbursement plan for purposes of Sections 105 and 106 of the Internal Revenue Code Code, as well as a health reimbursement arrangement as defined in Internal Revenue Service ("IRS") Notice 2002-45. This Plan is also intended to be exempt from the Affordable Care Act as a separate "retiree-only" plan pursuant to ERISA Section 732(a) and Code Section 9831(a)(2).

Accounting principles generally accepted in the United States of America require management of the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Board has evaluated the tax positions taken by the trust and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing and regulatory jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.
