## Notes to Financial Statements

At December 31, 2024 and 2023 and For the Year Ended December 31, 2024

### (1) Description of Plan

The following description of the USG Management Services of Florida Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. The Plan agreement should be referred to for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all employees of USG Management Services of Florida Inc. ("USG") and its participating affiliates (the "Company") who have met certain eligibility requirements. Employees become eligible to enroll in the Plan if they are at least twenty years of age and upon completion of three consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act ("ERISA") of 1974, as amended. The Plan trustee is Great-West Life and Annuity Insurance Company and Subsidiaries (DBA Empower Retirement) (the "Trustee"). The Plan assets are held by Empower Retirement. Retirement Solutions Specialists ("RSS") is the Plan's record keeper.

**Plan Sponsor.** USG serves as the Plan sponsor.

**Contributions.** Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to the limitations provided by the Internal Revenue Code ("IRC"). Employees can choose pre-tax contributions, after-tax Roth 401 (k) contributions, or a combination of the two. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct their investment of all contributions credited to their accounts into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company will make a qualified safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 1% of compensation plus 50% of salary deferrals between 1% and 6% of compensation. Compensation and deferrals are determined on an annual basis. Also, the Company may make a discretionary profit-sharing contribution at an amount determined annually.

**Participant Accounts.** Each active participant's account is credited with the participant's contributions and allocations of (a) Plan earnings and (b) employer contributions, (c) is charged with an allocation of administrative expenses not paid by the Company, and (d) withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### (1) Description of Plan, Continued

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of credited service. The following schedule describes the Plan's vesting provisions:

Upon death, total disability, normal retirement or termination of the Plan, employer contributions become 100% vested.

**Forfeited Accounts.** Forfeitures of participants' nonvested account balances will be utilized to reduce future contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,679 and \$27,225, respectively. During the year ended December 31, 2024, forfeited nonvested accounts totaling \$22,921 were used to reduce contributions and pay administrative expenses.

**Notes Receivable from Participants.** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 less the highest outstanding loan balance in the previous twelve months, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate which is comparable to those of most major lending institutions. Loan terms generally range from one to five years. A longer term may be allowed if the loan is for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits.** Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

(2) **Summary of Significant Accounting Policies**

The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

***Use of Estimates.*** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Subsequent Events.*** Subsequent events have been evaluated through August 4, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

***Investment Valuation and Income Recognition.*** Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants.*** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Contributions.*** Contributions from participants are accrued and credited to participants' accounts as of each pay period.

***Payment of Benefits.*** Benefits are recorded when paid.

***Administrative Expenses.*** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Party-In-Interest.*** Certain of the Plan's investments are offered by the trustee. These transactions qualify as party-in-interest.

### (4) Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Investment Contract with Insurance Company**

The Plan has entered into an investment contract with Great-West in which participants may invest in a fixed annuity. The fixed annuity option is a guaranteed fund with interest compounded annually at a corporate rate set by Great-West. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and asset charges. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and asset charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value unless withdrawals are due to plan or contract termination or preretirement distributions at age 59 1/2 or after. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**(5) Investment Contract with Insurance Company, Continued**

The methodology for calculating the interest crediting rate for the contract is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the contract for the year ended December 31, 2024 was 1.45%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Company does not believe that any events which would limit the Plan's ability to transact at contract value with participants or contract issuers are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(7) Tax Status**

The Plan uses a prototype plan document sponsored by RSS. RSS received a determination letter from the Internal Revenue Service ("IRS"), last updated June 30, 2020, which states that the prototype document satisfies the applicable requirements of the IRS. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**(7) Tax Status, Continued**

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Risks and Uncertainties**

The Plan has made available various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' balances and the amounts reported in the statements of net assets available for benefit and the statement of changes in net assets available for benefits. The Plan permits every participant to direct the investment of their account balances under the Plan.

**(9) Related Party Transactions**

Certain Plan investments include investment funds managed by the Trustee, as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions.
