Independent Auditor's Report

Opinion

We have audited the financial statements of the Francis O. Day Co., Inc. Group Health & Life Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements October 31, 2024 and 2023

Note 1 - Description of the Plan

The following description of the Francis O. Day Co., Inc. Group Health & Life Plan (the "Plan") is provided for general information. Participants should refer to the Plan agreement for complete information of the Plan's provisions.

General

The Plan provides medical benefits, dental benefits, vision benefits, and life coverage covering all eligible employees of Francis O. Day Co., Inc. ("F.O. Day" and the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective November 1, 2019, the Sponsor established the Francis O. Day Co., Inc. Health Benefit Trust (the "Trust") to facilitate the collection of Plan contributions, remittance to various Plan service providers, and payment of other Plan expenses.

Contributions

The Plan is contributory, funded by both participant and employer contributions. Employee contributions are based upon rates determined by the Plan Sponsor and the claims processor. Any and all remaining participant claims and administrative fees are paid by the Sponsor who has committed to make payments to the Plan as needed to pay any remaining benefits and expenses related to the Plan.

Stop loss coverage

The Sponsor has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Eligibility

The Plan provides medical benefits to regular full-time employees scheduled to work at least 30 hours per week and to their eligible dependents. Participation continues until the end of the month in which separation of employment occurs or in which employee status changes to an ineligible class.

Benefits

The medical benefits are provided by the Plan and self-insured by F.O. Day. The Plan is administered by CareFirst Administrators (the "Administrator").

Dental benefits, vision benefits and other benefits including group life insurance coverage and group accidental death and dismemberment coverage provided by the Plan and are fully insured through the purchase of coverage from a third-party insurer. The Plan retains no risk of loss associated with these benefits.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and of the Plan's benefit obligations, and changes in net assets available for benefits and of changes in the Plan's benefit obligations during the reporting periods and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded on the accrual basis.

Payments of benefits

Premiums under the fully insured option, paid by either the Sponsor or the Trust, are recorded as premiums paid in the accompanying statements of changes in net assets available for benefits.

Self-insured claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and actuary. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Sponsor on behalf of the Plan.

Claims incurred but not reported

Plan obligations at October 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Stop loss

Premiums for stop loss insurance are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaled \$203,498 and \$355,737 for the years ended October 31, 2024 and 2023, and are included in claims paid, net of reimbursements on the accompanying statements of changes in net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Interest-bearing cash: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of October 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4 - Income tax status

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Plan termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event

of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 6 - Transactions with party-in-interest and related parties

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.
